EXECUTIVE ORDER

REQUIRING THE ATTORNEY GENERAL TO INVESTIGATE AND PROSECUTE EMPLOYERS IN COLORADO WHO FAIL TO PAY TAXES AS REQUIRED BY LAW

WHEREAS, I have been informed about conduct of employers in Colorado who:

- a. knowingly mischaracterize their employees as independent contractors;
- intentionally misrepresent the amount of their payroll;
- falsify or alter written documents which purport to be documents used or created by public servants;
- d. willfully attempt to evade or defeat, or willfully fail to collect or truthfully account for or pay over tax administered by the Department of Revenue; and
- e. attempt to influence public servants by means of deceit;

WHEREAS, this conduct results in:

- the loss of revenues by the Department of Revenue through the underpayment by employers of taxes, including withholding and sales taxes; and
- b. the loss of revenues to the Colorado Unemployment Trust Fund, resulting from the underpayment by employers of unemployment insurance taxes in violation of the Colorado Employment Security Act and resulting in other Colorado employers having to unfairly bear more than their share of the cost of maintaining the fund; and
- the loss of revenues to the State Compensation Insurance Authority, resulting from the underpayments by employers of premiums;

WHEREAS, employees are also victimized because, when characterized as independent contractors, they do not receive typical employee benefits such as retirement and health insurance;

WHEREAS, law-abiding employers are also injured as a result of the unfair competition created by those employers whose business costs do not include the payment of these taxes;

WHEREAS, the Colorado Attorney General has an integral relationship with the Colorado departments of Revenue and Labor and Employment and the State Compensation Insurance Authority in the enforcement of various statutes of the State of Colorado; and

WHEREAS, the Colorado Attorney General is of the opinion that grounds exist to file criminal and/or civil actions against certain employers who have engaged in this conduct;

NOW, THEREFORE, under and pursuant to the authority vested in me by section 24-31-101(1)(a), C.R.S., I, Roy Romer, Governor of the State of Colorado, hereby require the Attorney General of the State of Colorado to investigate and prosecute any unlawful activity by employers in this state, or their officers and agents, related to the above-described conduct; and, for such purposes, I hereby invest the Attorney General with all necessary criminal and civil authority.
