#### EXECUTIVE ORDER

AMENDMENT TO THE EXECUTIVE ORDER ON THE DISTRIBUTION OF EXXON OIL OVERCHARGE FUNDS UNDER THE JUDGMENT AND ORDER OF THE UNITED STATES DISTRICT COURT FOR THE DISTRICT OF COLUMBIA OF JUNE 7, 1983

- WHEREAS, Colorado was allocated \$22,715,814 under the provisions of the Exxon case;
- WHEREAS, those funds were originally allocated by Executive Order D0092 86, dated September 4, 1986 and amended by Executive Orders D0126 86, dated December 23, 1986 and D0057 87, dated December 16, 1987 and D0014 89, dated March 31, 1989 and D0016 89, dated April 25, 1989 and D0148 89, dated October 5, 1989;

WHEREAS, there is a need to amend the terms of these Executive Orders;

NOW, THEREFORE, I, Roy Romer, Governor of the State of Colorado, pursuant to the Judgment and Order of the U.S. District Court for the District of Columbia, DO HEREBY ORDER THAT:

- 1. \$1,500,000 shall be allocated for rural and urban community recycling grants to be monitored by the Colorado Office of Energy Conservation;
- 2. \$225,000 shall be allocated to the Energy in Community Development Program for grants to five energy efficient model communities;
- 3. \$210,000 shall be allocated to the City and County of Denver for developing a preliminary implementation analysis for integrated solid waste management at the Denver International Airport;
- 4. \$128,421 shall be allocated to the Colorado Office of Energy Conservation for a renewable resource program;
- 5. \$200,000 shall be allocated to a Trip Reduction for Working Families program which will evaluate the energy savings associated with alternative work locations, including on-site or close-to-work daycare center;
- 6. \$200,000 shall be allocated to the State Soil Conservation Board to deliver an energy conservation program to the farm sector;

- 7. \$100,000 shall be allocated to an Energy and Water Conservation program to be performed in conjunction with the Colorado Department of Natural Resources;
- \$70,000 shall be allocated to continue the Energy Conservation in Purchasing program to be performed in conjunction with the Colorado Division of Purchasing;
- 9. \$83,500 shall be allocated to Neighborhood Housing Services, Inc. to implement a model pilot demonstration project for weatherization services to the "working poor", a segment of the population often-neglected in other assistance programs.
