EXECUTIVE ORDER

PROCLAMATION CALL FOR THE SECOND EXTRAORDINARY SESSION OF THE FIFTY-EIGHTH GENERAL ASSEMBLY

WHEREAS, Section 9 of Article IV of the Constitution of the State of Colorado provides that the Governor may, on extraordinary occasions convene the General Assembly, by proclamation, and Section 7 of Article V of the Constitution provides that the General Assembly shall meet at other times when convened in special session by the Governor; and

WHEREAS, in the opinion of the Governor, an extraordinary occasion has arisen because the decennial census of the United States has been completed and Section 44 of Article V of the Constitution of the State of Colorado requires the General Assembly to divide the state into congressional districts according to the new apportionment made by Congress; and

WHEREAS, certain other matters have arisen which require the immediate attention of the General Assembly;

NOW THEREFORE, I, Roy Romer, Governor of the State of Colorado, convene the Fifty-Eighth General Assembly with this proclamation and summon the members of the Fifty-Eighth General Assembly to meet in Special Session at the State Capitol, in the City and County of Denver on the tenth day of September, 1991, at 10:00 a.m. and designate the following subjects for your consideration and appropriate legislative action:

1. Concerning division of the State of Colorado into six districts for representation in the United States Congress, according to constitutional standards;

2. Concerning the reenactment of Section 16-11-103, C.R.S. as it existed prior to the approval of Senate Bill 88-78 and concerning its applicability to crimes committed on or after July 1, 1988; and concerning appeals by the prosecution from determinations that a death penalty statute is inoperative or inapplicable;
3. Concerning public schools, including standards, measures, assessments and accountability for educational outcomes in the public schools;
4. Concerning the financing of public schools, including changes in state or local revenues or taxes or the process or procedures for collecting such revenues or taxes, and changes in state or school district expenditures to fund the public schools;
5. Concerning certain technical corrections to Senate Bill 91-146 to clarify the age at which one attains majority in Colorado for the purpose of terminating conservatorships;
6. Concerning certain technical corrections to House Bill 91-1187 regarding docket fees in special proceedings;
7. Concerning a federal mandate that the Public Employees' Retirement Association pay interest on refunds of member contributions;
8. Concerning avoidance of federal preemption because of Public Law 98-440;
9. Concerning the financing and reform of the medicaid programs in Colorado, including changes in taxes or revenues to fund the expenditures in the medicaid programs.
10. Senate consideration for confirmation of gubernatorial appointments to boards and commissions.
