EXECUTIVE ORDER

TRANSFER OF FUNDS

FROM THE U.S. DEPARTMENT OF HEALTH AND HUMAN SERVICES
TO THE COLORADO DEPARTMENT OF LOCAL AFFAIRS

- WHEREAS, the Department of Health and Human Services is the recipient of funds under the Low-Income Home Energy Assistance Act of 1981 (P.L.97-35); hereafter referred to as the Low-Income Energy Assistance Program (LIEAP);
- WHEREAS, the Colorado Department of Social Services is the recipient of funds for the LIEAP Program;
- WHEREAS, the Low-Income Energy Assistance Act of 1981 allows up to fifteen (15) percent of the funds to be used for low-cost residential weatherization or other energy-related home repair for low-income households;
- WHEREAS, LIEAP received moneys from the Department of Health and Human Services Leveraging Incentive Program for using Petroleum Violation Escrow funds for low-cost residential weatherization and other energy-related home repairs in Federal Fiscal Year 1991;
- WHEREAS, it has been determined that the provisions of low-cost residential weatherization services will provide long-range benefits for Colorado's low-income population;
- WHEREAS, the Division of Housing in the Colorado Department of Local Affairs has experience in providing low-cost weatherization services to low-income populations;
- WHEREAS, the Division of Housing in the Colorado Department of Local Affairs is best able to use the weatherization funds to serve Colorado's low-income population;

NOW, THEREFORE, I, Roy Romer, Governor of the State of Colorado, pursuant to the authority vested in me under the Constitution and laws of the State of Colorado, DO HEREBY ORDER THAT:

- 1. The Colorado Department of Local Affairs is designated as the responsible agency to administer a low-cost weatherization program;
- 2. The Low-Cost Weatherization Program shall be administered in accordance with all federal laws and regulations;
- The Department of Local Affairs shall receive \$3,461,814 from the Colorado Department of Social Services, including \$226,731 for administrative costs and \$3,235,083 weatherization services. Of the total, \$3,405,552 shall come from the LIEAP Block Grant and \$56,262 from the Leveraging Incentive Program award.
- 4. Due to a significant level of delayed funding to the Department of Social Services, the Department of Local Affairs shall not expend more than \$1,000,000 of the above total prior to September 30, 1993. The remaining \$2,461,814 shall be available after September 30, 1993.
