## EXECUTIVE ORDER

### DESIGNATION OF SERVICE DELIVERY AREA UNDER THE JOB TRAINING PARTNERSHIP ACT

- WHEREAS, pursuant to the Job Training Partnership Act of 1982, Public Law 97-300 (JTPA), the Governor must publish a proposed designation of JTPA service delivery areas (SDAs) for the state; and
- WHEREAS, pursuant to Executive Order D0010 83, dated April 1, 1983, ten SDAs under the JTPA have been designated for the state; and
- WHEREAS, Pueblo, Custer, Fremont, Chaffee, Lake, Park and Teller counties as a consortium were so designated as a SDA, known as the Pueblo County SDA; and
- WHEREAS, Pueblo County has chosen to terminate its status as grant recipient and administrative entity for the Pueblo County SDA, and has chosen to dissolve that SDA; and
- WHEREAS, Pueblo, Custer, Fremont, Chaffee, Lake, Park and Teller counties as a consortium have petitioned the Governor for redesignation of their SDA; and
- WHEREAS, the Job Training Coordinating Council has been formally apprised of the recommendations for the redesignation of this SDA and agrees that a redesignation is appropriate; and
- WHEREAS, the Governor has received and reviewed comments submitted by local interested parties on the need and plans for SDA redesignation in the state; and
- WHEREAS, pursuant to Executive Order D0010 83, a single rural SDA has been designated, which is known as the "balance of state" or ORJT SDA.

NOW, THEREFORE, I, Roy Romer, Governor of the State of Colorado, under the authority vested in me by the

Constitution and the laws of the State of Colorado, DO  
HEREBY ORDER THAT:

1. The following units of local governments in Colorado, as a consortium, are redesignated as part of, and incorporated into, for purposes of the Job Training Partnership Act of 1982, Public Law 97-300, as amended, the single rural SDA established pursuant to Executive Order D0010 83, known as the "balance of state" or ORJT SDA:

Pueblo, Custer, Fremont, Chaffee, Lake, Park and Teller counties, as a consortium.

2. All designations shall be effective April 1, 1993.
