George Murad of Denver to represent volunteers and to serve as an Unaffiliated;

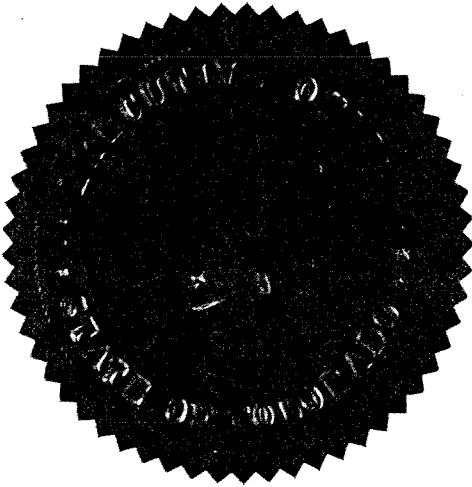
Kelly Brady of Greeley, to represent youth and to serve as a Republican;
