EXECUTIVE ORDER

Amending Executive Order B 2017-001 Regarding the Governor's Education Leadership Council

Pursuant to the authority vested in the Office of the Governor of the State of Colorado and, in particular, pursuant to Article IV, section 2 of the Colorado Constitution, I, John Hickenlooper, Governor of the State of Colorado, hereby issue this Executive Order amending Executive Order B 2017-001 regarding the Governor's Education Leadership Council.

I. Background, Need, and Purpose

The Governor's Education Leadership Council was created in 2011 to advance the educational goals of the State of Colorado. By Executive Order B 2017-001, I reconstituted the Education Leadership Council to renew its membership and goals. As mandated by Executive Order B 2017-001, the Education Leadership Council has convened to begin developing a strategic plan to improve Colorado's P-20 educational system. This Executive Order makes changes to the leadership and operational structure of the Education Leadership Council.

II. Declaration and Directives

I hereby amend Section II(A) of Executive Order B 2017-001 to read as follows:

The Education Leadership Council shall be housed in the Lieutenant Governor's office. The Lieutenant Governor's office will be responsible for scheduling the meetings, setting the agenda, and reporting to the Governor and other appropriate representative groups.

I hereby amend Section III(A) of Executive Order B 2017-001 to read as follows:

The Education Leadership Council consists of members appointed by the Governor for two and three-year staggered terms. The co-chairs shall be appointed by the Governor and serve until replaced by the Governor. Members of the Education Leadership Council shall include, but not be limited to:

I hereby amend Section III(A)(1) of Executive Order B 2017-001 to read as follows:

The Lieutenant Governor;

I hereby amend Section III(B) of Executive Order B 2017-001 to read as follows:

The Education Leadership Council may create subcommittees as needed to address specific issues and may, at the discretion of the Council, invite experts, consultants, and ex officio members to support the work of the subcommittees. The co-chairs of the Education Leadership Council will create an Executive Committee in order to facilitate the execution of the Council's duties. Chairs of subcommittees may serve as ex officio voting members of the Council at the discretion of the co-chairs.

The Education Leadership Council shall consult with the Lieutenant Governor's Office on all process matters relating to the work of the Council. Such matters include creating advisory groups, creating subcommittees, inviting experts, consultants, and ex officio members to support the work of the subcommittees, creating the Executive Committee, and any other process matters.

III. Duration

This Executive Order shall remain in effect until rescinded or modified by Executive Order. In all other respects, Executive Order B 2017-001 shall remain in full force and effect as originally promulgated.
