EXECUTIVE ORDER

Rescission of Prior Executive Orders

Pursuant to the authority vested in the Governor of the State of Colorado and, in particular, pursuant to Article IV, Section 2 of the Colorado Constitution, I, Jared Polis, Governor of the State of Colorado, hereby rescind the following 208 Executive Orders that are unnecessary, outdated, or obsolete.

I. Background and Purpose

While Colorado Governors use Executive Orders as an essential tool of governance in order to carry out their executive functions as mandated by the Colorado Constitution and State law, they can accumulate over time and become an operational burden to efficient government. Executive Orders can provide timely and necessary direction for and resources to pressing matters of statewide concern and advance the implementation of State objectives and policies, but can also lead to additional paperwork.

Over time, Executive Orders may become unnecessary, outdated, or obsolete due to changed circumstances, the completion of their intended purposes, or redundancy with current laws and regulations. The continued retention of outdated Executive Orders may lead to confusion, inefficiency, or administrative burdens. To make state government more efficient, the Office of the Governor and Executive Branch agencies reviewed past Executive Orders to determine relevance and alignment with the State's current needs and priorities. My administration has determined that certain Executive Orders can be rescinded because they are unnecessary, outdated, or obsolete.

II. Directive
