Energy Outreach Colorado

is the only nonprofit that raises funds to help all Coloradans afford energy for their homes. Since 1989, Energy Outreach has raised more than \$158 million to fund energy assistance for limited income families and seniors, and energy efficiency upgrades for affordable housing and nonprofit facilities. We are the state's leading advocate for affordable energy policies to support safe, healthy and affordable housing. Listed below are our accomplishments for the past fiscal year (October 2010 through September 2011).

Energy Assistance

- EOC distributed \$9.3 million for energy bill payment assistance.
- We partnered with 136 community assistance organizations and Colorado's Low-Income Energy Assistance Program (LEAP).
- A record 142,000 limited income households received help paying overdue energy bills, allowing them to remain warm and safe in their homes.



Energy Efficiency

- Our Nonprofit Energy Efficiency Program (NEEP) provided 41 nonprofit facilities with energy efficiency improvements totaling more than \$2.5 million. Funders were EOC, the Denver Office of Strategic Partnerships, Xcel Energy, the Governor's Energy Office, Atmos Energy and Noble Energy.
- In our second year administering the Governor's Energy Office multi-family weatherization program, EOC completed 12 projects with 1,027 units totaling \$5 million in funding.
- EOC secured an additional \$1.3 million from Xcel Energy, Atmos Energy and the Denver Office of Strategic Partnerships to weatherize 20 affordable housing properties.



Advocacy

- Energy Outreach represented limited income households in rate cases and rule making activities at the Colorado Public Utilities Commission.
- EOC advocated on behalf of affordable energy policies during the Colorado General Assembly.

Often these families and seniors have fewer options for energy efficient housing and rely on services from assistance organizations that are stretched to pay their own energy bills.

Energy Outreach Colorado addresses these critical needs by raising funds to:

- Provide 130 assistance organizations with energy assistance grants
- Manage energy efficiency programs for affordable, multi-family housing
- Install free weatherization measures in qualifying nonprofit facilities
- Advocate for affordable energy policies in Colorado and the nation
