




Personal Income Growth - National (in Billions)

Personal Income Growth - Rocky Mountain Region (In Millions)





Fuel Prices: Colorado vs. National Average





Year-to-Date Precipitation







Further, despite extensive efforts, 19 attractions who reported in the same quarter could not provide monthly or quarterly attendance rates. As such, the large difference in attendance may not be so vast.

Also in each year, 19 attractions were closed for some portion of the quarter.

Skier Visits

Colorado Ski Country USA (CSCUSA) reported that total skier visits at its 22 member resorts were down 7.7 percent during the first period of the 2008-09 ski season, defined as October 15, 2008 through December 31, 2008. However, the first skier visit period does not include four days of the 2009 New Year's week, when resorts experienced high, and in some cases record, volumes of guests.
