The Commission determines the boundaries of designated ground water basins (see map at the back of this book) by geographic description and considers well permit applications for persons desiring to appropriate designated ground water for beneficial use. The Commission is responsible for the development of policies and procedures for maximum economic development, as well as the protection of the vested rights of the designated ground water basins of the state.

Six of the members shall be resident agriculturists of designated ground water basins, with no more than two from the same ground water basin. One member shall be from Water Division 3. Two members shall be representatives of municipal or industrial water users of the state.

The Board works with the Department of Healthcare Policy and Financing and the Medical Services Board to develop the hospital provider fee model, monitor implementation of the bill, help with preparation of annual reports on this program, and ensure that the Medicaid and CHP+ eligibility expansions are implemented as intended.

The Board shall consist of 13 members as follows: five members who are employed by hospitals, including at least one person who represents a rural area, one person who represents a safety net hospital and one person who represents an urban area; one member who represents a statewide organization of hospitals; one member who represents a statewide organization of health insurance carriers or a health insurance carrier and who is not a representative of a hospital; one member who does not represent a hospital or a health insurance carrier; one member who is a consumer of health care and not in the health care industry; one member who represents business that provides health insurance for its employees; two employees of the Department of State. 



Colorado Congressional Districts
