INTRODUCTION

The Statewide Internet Portal Authority (SIPA) is pleased to provide this Annual Legislative Report. C.R.S. § 24-37.7-113.5 requires SIPA to submit an annual report to the Joint Technology Committee, the Joint Budget Committee, the members of the Business, Labor, and Technology Committee of the Senate, and the Business Affairs and Labor Committee of the House of Representatives that includes:

- (a) a complete and detailed operating and financial statement each fiscal year;
- (b) the total amount of charges or fees imposed by each state agency for accessing electronic information, products, and services through the statewide internet portal;
- (c) the total amount of receipts and revenue derived by SIPA from the transactions in (b); and
- (d) recommendations regarding additional legislation or other action that might be necessary to carry out the purposes of SIPA.

SIPA was created in 2004 by the Colorado General Assembly with a mandate to "develop **the officially recognized statewide internet portal** that provides one-stop access to electronic information, products, and services in order to give members of the public, state agencies, and local governments an alternative way to transact business with the state". C.R.S. § 24-37.7-105(1)(a).

SIPA is governed by a 15-member Board of Directors comprised of elected officials, state legislators, government stakeholders, and private residents.

SIPA serves as the oversight body of the **Colorado.gov portal**, which is the gateway to Colorado governments and is intended to be Colorado's single most comprehensive delivery channel for e-Government services. Online services allowing Coloradans to complete tasks such as starting a business, renewing a professional license, renewing driver's licenses, and vehicle registrations are available.

Governments can create and maintain a web presence on Colorado.gov at no cost to the government, accept electronic payments without needing to procure a PCI-compliant system of their own, deploy mobile applications, and much more – using solutions provided through SIPA.

SIPA works with eligible governmental entities to offer creative solutions that take advantage of new technologies and meet the fiscal challenges of today. SIPA continuously looks for innovative ways to provide new services while improving the current services it offers.

For the last several years, SIPA has focused on:

- Developing and implementing a technology portfolio that meets its customers' needs.
- Promoting SIPA and Colorado.gov as <u>the</u> official statewide internet portal that connects the public with Colorado governments.
- Being the first choice for Colorado government payment processing by developing processes, systems, and technologies that enhance its customers' experiences.
- Working with state and local government partners to develop a sustainable operating model.

While these critical operational initiatives will not be abandoned by the SIPA team, there are several new situational and legislative priorities that will be the focus of FY 2020 – 2021.

The SIPA team is currently focusing on:

- Responding to HB20-1039 regarding state rule making
- Managing the NIC Colorado Innovation Fund process and projects
- Responding to the ongoing OSA Audit for web application security
- Preparing for the Portal Integrator Re-procurement
- Managing the transition to a new Executive Director

STATUTORY MISSION

SIPA's statute, § 24-37.7-105, requires SIPA to, among other things, "develop the officially recognized **statewide** internet portal that provides one-stop access to electronic information, products, and services in order to give members of the public, state agencies, and local governments an **alternative** way to transact business with the state."

What is SIPA's mission?

The mission of the authority is to . . .

- Develop the officially recognized statewide internet portal that provides one-stop access to electronic information, products, and services in order to give members of the public, state agencies, and local governments an alternative way to transact business with the state.
- Explore ways and means of expanding the amount and kind of electronic information, products, and services provided, increasing the utility of the electronic information, products, and services provided and the form in which it is provided, and, where appropriate, implementing such expansion or increase.
- Explore technological means of improving access for members of the public, state agencies, and local governments to electronic information, products, and services, and, where appropriate, implement such technological improvements.
- Explore options for expanding the statewide internet portal and its services to members of the public, state agencies, and local governments by providing add-on services such as access to other information, products, services, and databases or by providing electronic mail and calendaring to subscribers.

STRATEGIC PURPOSE

SIPA is statutorily required to develop and annually update a strategic business plan for the implementation, maintenance, and enhancement of the statewide internet portal. C.R.S. § 24-37.7-105(1)(c).

In 2017, SIPA's Board and staff worked to generate a modern and aspirational Purpose Statement.

We improve the quality of life in Colorado by connecting the public to efficient services through technology, enabling governments to focus on their core missions.

BOARD OF DIRECTORS

SIPA is governed by a 15-member Board of Directors which includes the following members: the Secretary of State; one representative from the Office of the Governor and three Executive Directors of principal agencies of the State, all appointed by the Governor; three members from the private sector and one member of local government, all appointed by the Governor with consent of the Senate; two Senators; two Representatives; one member of the Judicial Department of the State appointed by the Chief Justice of the Colorado Supreme Court; and the State Chief Information Officer of the Governor's Office of Information Technology. The complete roster of current board members is provided in **Appendix 1**.



GOVERNMENTS SERVED


SIPA is a body corporate and political subdivision of the state that serves other governmental entities throughout Colorado. Eligible governmental entities are state agencies, county and municipal governments, public institutions of higher education, public school districts, and many other special purpose authorities.

As of October 9, 2020, SIPA had agreements in place with 734 governments or subdivisions, including all principal departments of state government, 55 counties, 176 municipalities, 85 water and/or sanitation districts, 37 fire protection districts, 12 public higher education institutions, and 26 school districts.



SIPA entered into agreements with 143 new eligible governments over the past year. While many of SIPA's initial customers were state agencies predominately located in the Greater Denver metropolitan region, SIPA now serves governments across Colorado.


One of SIPA's goals is to ensure that the experience is the same for all Coloradans interacting with their governments whether they dwell in a large front-range city or a small town on the Western slope.



BUSINESS MODEL

SIPA is self-funded through revenue earned from payment processing, the sale of licenses, and time and material consulting. No governments are required to acquire any services or products from SIPA. To remain a viable and functioning organization, SIPA must offer products and services that are secure, cost-effective, and useful to governments. Because SIPA is self-funded, the SIPA team and its vendor partners are highly motivated to ensure that industry-leading solutions are available at competitive prices. Governments will choose to acquire services and solutions through other mechanisms, unless SIPA offers the best products, customer service, and prices.


SIPA's total revenue has grown as more cloud-based services were added to SIPA's portfolio. SIPA earns a small margin on both professional services and software license revenue. In FY 2019-2020, total revenue increased largely due an increase in both professional service and software license procurements for Colorado state agencies. The state increased the number of Google, Salesforce, Five9, and MuleSoft licenses procured to operate critical resident facing applications. Similarly, the state invested in professional services, especially for the Governor's Office of e-Health Innovation, in response to the COVID-19 pandemic.



However, as shown on the next page, SIPA's operating revenue (total revenue minus the cost of goods sold) has not grown at the same rate as total revenue. This is because SIPA provides many services at **no additional cost** to governments. The bulk of SIPA's operating revenue is generated through its partnership with NIC Colorado (dba Colorado Interactive), which operates the Colorado.gov portal, and provides payment processing and other services to governments.

Modest efficiency fees are applied to a limited number of services, which cover the cost of building, maintaining, and expanding Colorado.gov services at no cost to the governments served. Revenues from all of NIC Colorado's services are pooled, and projects are initiated according to priorities for state and local government set collaboratively between SIPA and NIC Colorado. Approximately 90% of the services offered in partnership with NIC Colorado are not self-sustaining but instead are supported by a small handful of profitable services.

These transaction fees create a sustainable funding stream to support long-term growth. With this funding source in place, many digital government services are provided at no cost to Colorado governments. The ongoing funding is reinvested in building new services to connect residents to their governments statewide. This helps underfunded government entities obtain and maintain a digital presence and provide world class digital services to the residents and businesses of Colorado. Unlike traditional IT contracting, transaction-based funding has no ongoing maintenance costs or other requirements that limit government's ability to address its evolving needs.



SIPA's purposefully keeps its operating expenses below its operating revenue because of its selffunded business model. In 2018, SIPA engaged Wyant Data Systems to estimate the cost switching its Portal Integrator partner. After the completion of that study, SIPA's Board approved the creation of a separate Portal Integrator Transition Fund should a new vendor partner be selected in 2022 or 2023 after the expiration of the contract with NIC Colorado. SIPA's net income is currently being added to the Portal Integrator Transition Fund.

SERVICES


SIPA and its partners offer many services to the eligible governmental entities of Colorado and the members of the public that interact with these services. Every year SIPA adds more SaaS Licenses and professional service offerings to its portfolio. A complete list of vendor partners and services can be

found on SIPA's website at: <u>https://sipa.colorado.gov/services</u>. SIPA's most widely-used services are described in detail below.

Internet Portal Services – Conducted in Partnership with NIC Colorado (Colorado Interactive)

As required by SIPA's statute, § 24-37.7-104 (2), SIPA conducted a request for proposals in 2013 to identify a statewide portal integrator. In 2014, a five-year contract with NIC Colorado, expiring April 30, 2019, was signed. SIPA's Board unanimously approved a three-year contract extension (to April 30, 2022) that was executed January 29, 2019.

SIPA provides a variety of portal services in partnership with NIC Colorado including website hosting and development, payment processing, event registration, mobile event management, and custom application development. More than 383 state agencies and local governments take advantage of at least one NIC Colorado portal service. The homepage of the Colorado.gov portal provides access to <u>state agencies</u> even if they do not host their websites on Colorado.gov, as well as numerous <u>online</u> <u>services</u> provided by many government entities.



As mentioned above, SIPA's statute, § 24-37.7-105, requires SIPA to "develop the officially recognized statewide internet portal that provides one-stop access to electronic information, products, and services

in order to give members of the public, state agencies, and local governments an alternative way to transact business with the state." Thus, SIPA oversees the State of Colorado's Internet portal, **www.colorado.gov**, which serves as the most comprehensive delivery channel for e-Government services available in Colorado. The portal links to state and local government websites and connects members of the public to the e-Government services they are seeking. Between July 1, 2019 and June 30, 2020, the Colorado.gov homepage received approximately 3.3 million unique visitors looking for information related to government services.

Electronic Payment Processing - Integrated within Colorado.gov, SIPA's partnership with NIC Colorado provides a convenient and efficient way for members of the public to pay for government services they receive online or over-the-counter by credit card or e-check. The major benefits and protections provided to government entities that utilize NIC Colorado's payment processing services are outlined in the table below.

NIC Colorado is a PCI (Payment Card Industry) Data Security Standards (DSS) Merchant Level 1 vendor.¹ NIC Colorado manages more than 600 independent payment systems for more than 200 Colorado governments, including 59 of Colorado's 64 counties. While electronic payment processing is

often provided as a standalone offering, many governments elect to integrate SIPA's payment processing solution into their custom applications. NIC Colorado hosts hundreds of stand-alone payment portals, third-party payment integrations, and Event Registration applications which can take payments on behalf of Colorado governments (**APPENDIX 3: NIC COLORADO PORTAL SERVICES**).

If the state agencies and local governments using SIPA's services were to independently set up and manage these transactions, they would have carried annual costs of approximately \$10 million related to PCI compliance alone.² In FY 2019-2020 more than 7.6 million transactions for government payments of more than \$2.5 billion were completed using SIPA's payment engine.

SIPA's partner, NIC Colorado, serves as the merchant of record on all financial transactions, thus providing Colorado governments with an added layer of protection. All government transactions are processed through a PDPA (Public Deposit Protection Act) protected bank account. The purpose of PDPA is to ensure that public funds held on deposit in banks are protected if the bank holding the public deposits becomes insolvent. Unlike other payment processing vendors, SIPA's partnership with NIC Colorado allows SIPA to offer governments the protection of a PDPA account on payment transactions. Further, both SIPA and NIC Colorado carry large technology and cyber breach notification insurance policies, adding further protections to governments and Colorado residents using our services.

SIPA's contract with NIC Colorado was extended for three more years in 2019. As part of the contract negotiations, NIC Colorado agreed to provide several new benefits to Colorado governments. These benefits include naming all 300+ government entities receiving services from NIC Colorado as additional insureds on NIC Colorado General Liability insurance policy. In the event of a breach of personally identifiable information, all impacted Colorado residents will receive at least one year of credit monitoring.


Websites - Colorado.gov websites might be SIPA's single best-known portal service. Offered in partnership with NIC Colorado, SIPA provides website creation and hosting on Colorado.gov at no charge to eligible government entities and has more than 350 websites in production today (Appendix 2). These websites allow members of the public to gather valuable information regarding governmental services 24 hours a day, 7 days a week from their home, office, and mobile devices.

NIC Colorado refreshed and relaunched the Drupal 7 based <u>Colorado.gov</u> portal in May 2015. A Drupal 8 based <u>Colorado.gov</u> platform, has been developed. NIC Colorado is actively migrating government sites from the older Drupal 7 Platform to the refreshed Drupal 8 Platform. More information on the current platform can be found at: <u>cms.colorado.gov</u>.

Typically, there are about 75 million page-views of Colorado.gov sites each year, with dramatic increases in traffic in 2020 due to the COVID-19 Pandemic. Website hosting and development costs average \$5,000 to \$75,000 per site depending on complexity.³ The costs of website development, security updates, and hosting are absorbed by SIPA and its partner NIC Colorado. NIC Colorado also

ensures that the Colorado.gov portal and the websites hosted on it, are responsive (i.e., available on any device including mobile devices), accessible to people with disabilities, and maintain the highest security features. Using a conservative estimate of \$10,000 per website per year, SIPA has saved governments *approximately* \$3.5 *million for website hosting each year.*⁴



Since HB19-1087⁵ "CONCERNING ONLINE NOTICE OF PUBLIC MEETINGS OF A LOCAL GOVERNMENTAL ENTITY" was signed into law on April 26, 2019, SIPA has had a massive increase in requests for websites. C.R.S. § 24-6-402(2)(c)(II)(D), as enacted by HB19-1087, states that "local governments are encouraged to avail themselves of existing free resources for creating a website and receiving content management assistance from the Colorado Statewide Internet Portal Authority and statewide associations representing local governmental entities."

Currently, SIPA's small team is managing the paperwork and contracting for approximately 200 requests for websites and 100 requests for other services that SIPA and its partners provide each month. SIPA and NIC Colorado also helped the Governor's Office and the Colorado Department of Public Health and Environment (CDPHE) to rapidly develop and deploy new websites focused on the COVID-19 Pandemic. These sites include:

- <u>COVID19.colorado.gov</u> CDPHE website for Coronavirus information
- <u>stayathomeco.colorado.gov</u> Governor's website for stay at home information and resources.
- <u>COVID.colorado.gov</u> Governor's website for Coronavirus resources



Custom Applications - SIPA and NIC Colorado help governments develop and implement custom applications that provide improved services to the residents of Colorado. State and local governments have partnered with SIPA to develop numerous custom applications since SIPA was created. These applications include the Online Transparency Portal, Sex Offender Registry, MyBizColorado, Professional License Renewals, Online Vehicle Registration, Colorado Cold Case, and many more. Most of these applications were created with the SIPA self-funded model and were not funded by taxpayer dollars. SIPA and NIC Colorado are continuously updating the portfolio of services available to Colorado governments. More information about NIC Colorado's Portal Services can be found in **Appendix 3**.

Most of these applications used the SIPA-NIC Colorado self-funded model and <u>were not funded by</u> <u>taxpayer dollars</u>. Instead they were financed through a portal administration fee, whereby the direct beneficiary (user) of the service pays a small amount to support the service. NIC Colorado's custom application development capabilities also include the ability to rapidly deploy small form-based solutions, using their proprietary tool App Engine. Many new applications that range in scope from reserving a gazebo, providing resident feedback, applying for a municipal business license, or applying for a burn permit have been deployed in the last year. A complete listing can be found in **Appendix 4**.

Help Desk – NIC Colorado provides a local help desk to support users of the various applications and services it has developed and maintained for state agencies and local governments. In FY 2019 – 2020, NIC Colorado responded to 3,586 requests by online-chat, 14,961 by phone, and 57,380 by email. There was an uptick in customer support requests as the COVID-19 Pandemic was beginning to impact Colorado.



SIPA customers are very satisfied with the quality of support and services being received by NIC Colorado and SIPA's other vendor partners. (**Appendix 5: SIPA Customer Experience Scorecard**).

Event Registration and Mobile Event Management – NIC Colorado provides a free online event registration system, allowing entities the ease and flexibility to set up an event in a matter of minutes. It provides the ability to register any free or cost-based event and allow for tracking both attendance and revenue. Colorado governments have used this service over 200 times for a wide-range of events including registering participants for seminars, special events, and one-time events. NIC Colorado also provides a mobile application – MyEvents2Go – for event management. This mobile application allows real-time updates of conference agendas.

Digital Government Assistant – Gov2Go⁶ is a national application, which serves as a resident's personal assistant for state, federal, and local government alerts and services. It allows a resident to create a personalized profile (in a <u>web</u> or mobile (Android or IOS) application) focusing on the government services each person would like to be reminded about, and even have the assistant act on the resident's behalf, including one-click payments. Colorado specific services on Gov2Go include Flag Status Updates, Sex Offender Registry Alerts, and Motor Vehicle Registration Renewals.

Cloud Based Software as a Service (SaaS) Solutions

SIPA continues to have partnerships which allow Colorado governments to acquire and customize a variety of software solutions at competitive prices. These services are offered using an on-demand pricing model that allows governments to pay only for what they are using. SaaS (Software as a Service) solutions include: Salesforce, MuleSoft, G-Suite, Google Cloud Platform, DocuSign, Granicus, Qualtrics, AODocs, and Five9. Professional services to customize the cloud-based solutions are also contracted on behalf of eligible governments if desired. The State of Colorado, through the Governor's

Office of Information Technology, is SIPA's single largest consumer of SaaS solutions. However, approximately 84 local governments procure one or more of SIPA's SaaS offerings.


SIPA generally earns a small margin of revenue on SaaS license fees. SIPA's goal is to offer SaaS products below list price and still cover SIPA's costs of administration. SIPA also offers a variety of professional service offerings that support its mission. These range from designing custom applications for governments to engage with their constituents to providing cyber security assessments to protect resident data. SIPA earns a small margin on professional service contracts, to offset some of the costs associated with insurance, contract management, project management, and invoicing.

Micro-Grant Program

SIPA is about to start the eleventh year of its Micro-Grant Program. Each year, SIPA awards approximately 25 grants and up to \$150,000 to help governments put more resident-facing services and information online. Since the grant program inception in 2010, SIPA has awarded 259 grants totaling \$1,202,024 across the State of Colorado. The grant program is open to all Colorado government entities that are eligible to work with SIPA.

Grant winners have used their funds creatively to put more constituent facing services and information online. For example, Colorado governments have: digitized historic resources (maps, newspapers, art collections, video collections) and made them available online, modernized their websites, provided more broadband internet access, created low cost extensible (can be used by other governments) webportals based on Google Drive to allow residents to more easily self-serve their CORA (Colorado Open Records Act) requests, created a Colorado Parks and Wildlife mobile fishing application, and created resident-facing online portals for resident engagement.

In FY 2019-2020 SIPA received 95 requests for micro-grants and funded 35 of those, totaling \$147,000.⁷ Three additional grants were awarded in partnership with DOLA to expand broadband access statewide. Micro-grant awards for FY 2019-2020 are shown in the table below.

Innovation Fund

As part of the contract extension with NIC Colorado, provided NIC Colorado's revenue does not decrease from its CY 2018 amounts, NIC Colorado will invest \$500,000 per year for the next three years to equipment, hardware, goods, and services for projects directed by SIPA to innovate technology in the State of Colorado. This financial commitment is above and beyond the already extensive amount of no-cost services provided to Colorado governments that were described above in the Portal Services section.

SIPA's Board selected the following projects for Innovation Fund Investment in the first year of the program. Some projects received funding for the award amount, while other projects are being invested in with in-kind services by NIC Colorado.

For the second year of the Innovation Fund, SIPA's Board decided, at their October 1, 2020 Board Meeting, to only select projects where the full funding request could be committed. The Board selected the following projects for Innovation Fund investment:

• **CDHE My Colorado Journey Chatbot (\$68K)** - The funds will be used to implement a cuttingedge chatbot functionality to provide direct, instantaneous responses to user questions thereby extending scarce staff and agency resources and optimizing user engagement and learning for the My Colorado Journey website.

- **CDPHE Water Control Board (\$30K)** The funds will be used to store fish consumption, swim beach closure, harmful algae blooms, and other significant water impairments data for availability through an application program interface on our website and other applications, such as the MyColorado mobile application.
- **DOLA Demography Dashboards and Storymaps (\$7K)** The funds will be used to increase the data storage and software licenses for the State Demographer's Office to expand its online data visualizations and tools to analyze and describe the socio-economic impacts of the COVID-19 Pandemic across the state as well as develop tools, visualizations, and access to the Census 2020 counts to be released in 2021.
- DOLA Local Government Information System Modernization (\$45K) The funds will be used to hire a contractor to assist in constructing external user interfaces for the Division's soon-to-be modernized Local Government Information System and E-Filing Portal (LGIS) and will improve local government user experience and prevent the current system from ceasing function due to reliance on obsolete Oracle forms, Java programming, and web browsers.
- DOR UI/UX Study for DMV Platforms (\$150K) The funds will be used to retain a consultant to analyze, assess, and recommend a strategy through a development roadmap driven by utilizing User-Centered Design techniques to provide a framework of processes in which usability goals, user characteristics, environment, tasks and workflow of a product, service or process are given extensive attention at each stage of the design process. This will set a path for the DOR to manage the DMV Digital Transformation and manage usability and user experience across the DMV platforms (myDMV (Driver License/ID Services and Vehicle Services), colorado.gov/dmv, Driver Control, and Emissions.
- Judicial Online Dispute Resolution (\$200K) The funds will be used to purchase and integrate an online dispute resolution (ODR) platform to reduce court users' barriers to courts to be able to resolve civil disputes online, including e.g., small claims court, dissolution of marriage, parenting issues (pre and post-decree), and debt collection, without the need to physically go to a courthouse.
- OIT Security Bug Bounty Platform (\$50K) The funds will be used to cover payment to the security bug bounty platform and for the security researchers. The Colorado Digital Service team's time is covered through OIT's common policy. That covers much of the time to develop and publish resources such as a playbook to facilitate state agencies using bug bounties in the future. OIT has a contingent commitment to get help from the Beeck Center for Social Impact and Innovation at Georgetown University to help with writing and promoting the case study and playbook.

These new projects will start in Calendar Year 2021.

HB20-1039 Transparent State Web Portal Search Rules

HB 20-1039 Transparent State Web Portal Search Rules: Concerning a transparent state web portal that allows the public to easily search for information relating to state agency rules at no cost was signed into law on March 24, 2020. HB 20-1039 assigned SIPA's Executive Director to chair a task force to look at ways to enhance residents' online access to rules and the rule-making process

and to increase the transparency of the rule-making process, including potential improvements to existing online resources and the potential creation of new online resources.

SIPA's former Executive Director, Jack Arrowsmith, retired on May 31, 2020. SIPA's new Executive Director, Ajay Bagal, started on October 21, 2020. During these transitions, SIPA's Chief Technology Officer, Jerrod Roth, has been managing the task force responsibilities created in HB20-1039.

The objective of HB0-1039 is to deliver a report that addresses:

- a. Ways to enhance residents' online access to rules and the rule-making process and to increase the transparency of the rule-making process, including potential improvements to existing online resources and the potential creation of new online resources.
- b. Options for the design and implementation of an integrated state rule-making web portal.
- c. Common rule-making agency reporting formats, workflows, timelines, and protocols.
- d. An entity to manage the integrated state rule-making web portal.

The HB20-1039 Task Force first met on May 15, 2020. Of the agencies that were designated in the legislation to participate in the Task Force, seventeen of twenty organizations have actively participated. The Task Force agreed to the following schedule and timeline.

Agendas and Meeting Minutes from the Task Force meetings are available on the <u>SIPA HB20-1039</u> <u>website</u>. There has been exceptional engagement by the Task Force members. The final report to the general assembly's committees of reference with jurisdiction over business and state affairs is expected to be delivered on time. Since stakeholder engagement is very important to the HB20-1039 Task Force work and rule-making in general, SIPA will make the draft report available for public comment on the SIPA website. Those public comments will be captured in the final report.

FINANCIAL OPERATIONS

SIPA is self-funded and does not receive any appropriation from the Colorado General Assembly. SIPA is self-funded through its partnership with NIC Colorado, the sale of licenses, and time and material consulting. To remain a viable and functioning organization, SIPA must offer products and services that are in demand by governments.

Financial Risks

SIPA's primary financial risk is whether the amount of cash it has on hand is sufficient to cover vendor invoices between the time a government requests licenses or services to be ordered, and the time the government remits payment to SIPA. SIPA's Board approved a policy in 2019 that SIPA maintain a fund for business continuance of at least \$2 million for the purpose of meeting future obligations, capital expenditures, and operational expenses that cannot be met with operating funds. Several contracts that SIPA enters into for state agencies exceed the cash reserves, putting SIPA at risk if the agencies are slow to pay for the licenses or services that have been ordered.

The full financial impact of the COVID-19 Pandemic is not yet fully known. State agencies asked SIPA and its vendor partners to find ways to help trim 20% from FY 2020 - 2021 contract renewal costs. NIC Colorado's revenue from payment transactions decreased significantly with the economic downturn associated with the pandemic. If NIC Colorado's revenue decreases, the amount of funding SIPA receives as "Margin Share" will also proportionally decrease. Similarly, since SIPA's margins on license and professional service costs average 2.3%, there is little that SIPA can do to further reduce costs to governments and continue to operate, especially as requests for non-revenue generating services, such as website hosting, continue to increase. Some government entities may need to cancel licenses and services that they have come to rely on. This potential drop in revenue may impact SIPA's capacity to conduct self-funded "no cost" projects for governments.

An overview of SIPA's financial operation is presented below.

Description of Profit and Loss Line Items

<u>Income</u>

NIC Colorado Margin Share: This line item is used to account for the revenue received from the contract with NIC Colorado. SIPA receives a base monthly amount plus a percentage of net revenue. As described above, most of SIPA's Operating Revenue is derived from the NIC Colorado Margin Share.

Professional Services Revenue: This line item is used to account for revenue received from governments that require professional services to implement SaaS licenses, cyber security assessments, Google Cloud Platform development, technical account management services, custom integrations or applications, and maintenance of in-production applications. SIPA has added a few new partners that are doing extensive work for state agencies. CORHIO, QHN, CCMCN, and Prime Health were brought on as partners for the Governor's Office of e-Health Information. Slalom has been an active professional service partner doing work with many state agencies.

SaaS License Revenue: This line item is used to account for the revenue received from the purchase of software licenses by governments. Google, Five9, and Salesforce are the main license types offered by SIPA. This change is largely represented by the increased adoption of Salesforce licenses, and the addition of MuleSoft licensing by the Governor's Office of Information Technology and other state agencies.

Interest & Sponsorships: This line item is used to account for revenue from Interest from SIPA's ColoTrust account where the reserve fund balance is maintained. SIPA's vendor partners were eager to support SIPA's Annual User Conference this year and contributed financially to the event. The SIPA Annual User Conference was cancelled due to the COVID-19 Pandemic and all sponsorship dollars were returned.

Cost of Services

Professional Services Expense: This line item is used to account for expenses associated with professional services to implement SaaS licenses, cyber security assessments, Google Cloud Platform development, technical account management services, custom integrations or applications, and maintenance of in-production applications. These expenses are covered by the income line item Professional Services Revenue above.

SaaS Licenses: This line item is used for expenses associated with the purchase of software licenses to fulfill orders placed by government entities. These expenses are covered by the income line item SaaS License Revenue above.

SIPA-Funded Projects: This category supports projects that SIPA's Executive Director and Board of Directors have determined will benefit the most stakeholders. The ability to conduct such initiatives is a major advantage of the self-funded model. SIPA supported the migration of Colorado.gov websites from the current Drupal 7 to updated Drupal 8 platform and state technology projects that align with SIPA's mission.

Expenses

Personnel, Training, PERA liability: This line item is used to account for the various costs associated with SIPA's employees, including the required reporting from GASB 75 and GASB 68 expenses related to PERA.

Office Operations: This line item accounts for all office operation related expenses such as the lease, insurance, office equipment, and office supplies.

Functions: This line item includes all marketing materials, travel, memberships, lunch and learns, other events, participation at 20 government conferences, the annual micro-grant program, SIPA's Annual User Conference, and Board meeting related expenses. SIPA's Annual User Conference was cancelled due to the COVID-19 Pandemic this year, but many of the associated expenses were not refundable.

Professional fees: This line item accounts for the SIPA Board's legal counsel, SIPA's contract CFO, bookkeeping firm, annual independent audit, and other contractors who are retained for special projects, such as the recruiter retained to identify a new Executive Director for SIPA.

Use of Net Income from FY 2019 - 2020 for FY 2020 - 2021

Portal Integrator Transition Fund

SIPA's Board approved the creation of a new reserve fund called the Portal Integrator Transition Fund to support the predicted costs of switching to a new portal integrator in 2022 (or 2023 if the current contract is extended for another year). It was estimated by Wyant Data Systems that SIPA would incur substantial costs in transitioning to a new portal integrator. SIPA plans to move the profits it has retained that have been accrued over the last few years into a ColoTrust account for this purpose. On July 1, 2019, the Portal Integrator Transition fund was started with \$3 million. This amount is less than the amount proposed by Wyant Data Systems, but SIPA plans to retain future earnings to help support the costs of switching portal integrator vendors in the future. Net income from FY 2019 – 2020 will be added to the Portal Integrator Transition Fund.

FINANCIAL TRANSACTION DATA

C.R.S. § 24-37.7-113.5 requires SIPA to report the total amount of charges or fees imposed by each state agency for accessing electronic information, products, and services through the statewide internet portal and the total amount of receipts and revenue derived by SIPA from those transactions. These reporting requirements are for the preceding fiscal year, which for this reporting period is FY 2019 – 2020.

Fees charged by State Agencies

For most payment transactions, the fees are simple and posted to <u>SIPA's website</u>. Agencies can choose to absorb these fees or pass them down to the end user as a convenience fee for transacting online. The latter is the most common choice.

eCheck Transactions: Transaction Amount + \$1.00 Credit Card Transactions: Transaction Amount + ((Transaction Amount + \$0.75) x 2.25%) + \$0.75 For some specialized transactions, NIC Colorado and state agencies have agreed to exceptions to these standard fees. For example, motor vehicle-related transactions for less than \$10.00 are not charged to residents; instead, the credit card transaction fees are absorbed by NIC Colorado. Judicial fees are \$1.90 per statutory filing and \$0.50 per case history. Gambling intercept has a fee of \$10.00 per intercept. In some cases, NIC Colorado helps state agencies to deliver bulk records electronically to others. These fees range from \$0.003 to \$5 per type of record being looked up and delivered.

In FY 2019-2020, SIPA, through its partnership with NIC Colorado, processed more than 7.2 million transactions for state agencies, which collected more than \$2.1 billion for their information, products, and services. More than 77 million records were delivered on behalf of the Department of Revenue, generating an additional \$654,316 for that agency. Records requested by other state agencies and approved by the Department of Revenue are provided at no cost.

The table, **FY 2019-2020: Fees & Payments Collected by State Agencies (Online & Over the Counter)**, provides information related to the charges imposed by state agencies due to laws, rules, or regulations and includes the list of available state agency services, the number of transactions completed, and the amount of money collected for the state agency. Most of the transactions listed reflect a single payment for a single item.

Fees charged by Local Governments

In addition to processing payments for state agencies, SIPA, through its partnership with NIC Colorado, processed more than 408,487 transactions, collecting \$342 million, for Colorado local governments. Of this total, 140,775 transactions were for Colorado County Governments, which collected \$17,472,178. Special districts, such as water and sanitation districts, were accountable for 33,957 transactions and \$5,100,017. Municipalities were responsible for 233,755 transactions and \$319,379,767.

The transaction fees for local governments are the same as for state agencies, except as noted. Payment transactions processed for local governments are shown below.

Receipts & Revenues

NIC Colorado shares revenue, generated by offering portal services, with SIPA through a formula set by contract. For FY 2019 - 2020, SIPA was paid a flat fee (\$42,231.09 per month) and a percentage (7.5%) of the portal services revenue collected after expenses (credit card company fees, payment processing fees, and additional payments to agencies). Last year, SIPA received a total of \$2,212,391.67 from NIC Colorado. This number includes payment processing services for state agencies, municipalities, counties, special districts, school districts, and public institutions of higher education. It also includes a small amount of professional services offered on a time and materials basis.

The revenue (unaudited) SIPA received for FY 2019 - 2020 related to the transaction services provided to state agencies is approximately \$2,097,369.5 (i.e. 94.8% of the margin share received from NIC Colorado).

It is important to note that the citizens and residents of Colorado who use these services have many alternatives available and are generally not required to use them; however, they elect to use SIPA and NIC Colorado's Portal Services because of their convenience and ease of use.

RECOMMENDED LEGISLATION

As previously noted, C.R.S. § 24-37.7-113.5 requires that SIPA's annual report include any recommendations regarding additional legislation that might be necessary to carry out the purposes of SIPA. SIPA is requesting legislation to broaden the procurement method it may utilize to select a portal integrator partner.

Currently SIPA must use a request for proposals or RFP mechanism of procurement as specified in C.R.S. § 24-37.7-104. Powers of the statewide internet portal authority. (2) The authority shall not enter into a contract with a statewide portal integrator unless the statewide portal integrator was chosen by the authority pursuant to a request for proposals issued by the authority.

SIPA's Board Members have discussed the portal integrator reprocurement process in recent meetings and have suggested a change to legislation to allow for more flexibility in the procurement, allowing any competitive procurement process, including the Invitation to Negotiate (ITN). ITN has been adopted within state agencies and has garnered success.

Vendors who work with state agencies are becoming familiar with the ITN process. Therefore, SIPA is requesting a change in legislation that would simply change the RFP requirement in the SIPA statute to allow for "any competitive procurement method. This may provide more clarity for potential bidders and allow the recently adopted Invitation to Negotiate to be used as a procurement method for the portal integrator.

SIPA is asking that C.R.S. § 24-37.7-104. Powers of the statewide internet portal authority. Section (2) be amended to state:

The authority shall not enter into a contract with a statewide portal integrator unless the statewide portal integrator was chosen by the authority pursuant to a request for proposals <u>or other competitive</u> <u>procurement method such as an invitation to negotiate</u> issued by the authority.

Draft legislation for consideration is presented in Appendix 6.





APPENDIX 6: SIPA Draft Legislation

BILL DRAFT

CONCERNING THE AUTHORITY OF THE STATEWIDE INTERNET PORTAL AUTHORITY TO ENTER INTO A CONTRACT WITH A STATEWIDE PORTAL INTEGRATOR PURSUANT TO A COMPETITIVE PROCUREMENT PROCESS.

Bill Summary

The mission of the statewide internet portal authority (SIPA) is, in part, to develop the officially recognized statewide internet portal; to enter into a contract with a statewide internet portal integrator for the development, support, maintenance, and enhancement of the equipment and systems utilized for the statewide internet portal; and to provide appropriate administration and oversight of the statewide internet portal integrator. Pursuant to statute, SIPA shall not enter into a contract with a statewide portal integrator unless the statewide portal integrator was chosen by the authority pursuant to a request for proposals issued by the authority.

SIPA is a body corporate and a political subdivision of the state, is not a state agency, and is not subject to administrative direction by any department, commission, board, or agency of the state. SIPA is not bound by state procurement rules, which was intended to provide SIPA more flexibility, rather than limitations, in its procurements. The only statutory requirement related to SIPA's procurements is for the statewide portal integrator contract.

Prior to 2018, the most widely accepted and authorized competitive procurement process was the request for proposals. In October 2018, the Invitation to Negotiate (ITN) was added to the Code of Colorado Regulations as an additional procurement method for competitive procurements. The invitation to negotiate is intended to solicit responses from potential vendors to determine the best method for achieving a specific goal or solving a particular problem to identify one or more responsive vendors with which the state may negotiate to determine the response that is most advantageous. Given the complex nature of the statewide portal integrator contract, an ITN may be a more effective procurement method.

The bill retains the requirement for a competitive solicitation for the contract with the statewide portal integrator, but extends the type of competitive solicitation beyond the request for proposals and provides flexibility to explore other competitive solicitation types, including the invitation to negotiate.

Be it enacted by the General Assembly of the State of Colorado:

SECTION 1. In Colorado Revised Statutes, 24-37.7-104, amend (1) as follows:

24-37.7-104. Powers of the statewide internet portal authority. (2) The authority shall not enter into a contract with a statewide portal integrator unless the statewide portal integrator was chosen by the authority pursuant to a request for proposals OR OTHER COMPETITIVE PROCUREMENT METHOD SUCH AS AN INVITATION TO NEGOTIATE issued by the authority.

SECTION 2. Safety clause. The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.
