




BACKGROUND

Created in 1992 as the result of a citizens' initiative, the Great Outdoors Colorado (GOCO) Constitutional Amendment— Article XXVII of the Colorado Constitution—redirected a portion of Lottery proceeds to the GOCO Trust Fund for projects that preserve, protect and enhance Colorado's wildlife, park, river, trail and open space heritage. The Amendment also created the GOCO Board to oversee distribution of the funds. Contrary to what many people think, GOCO receives only a portion of Lottery proceeds. The Conservation Trust Fund and the Colorado Division of Parks and Outdoor Recreation are allocated 50% of the proceeds. Additionally, a cap is placed on the total amount of funding GOCO receives. In Fiscal Year 2008-2009, GOCO reached its cap of \$54.3 million. Therefore, \$5.5 million was contributed to the School Capital Construction Assistance Fund, created by voters in November 2000 with the passage of the Lottery's Powerball game.

The allocation of Lottery proceeds in Fiscal Year 2008-2009 was:

- 40%—or \$47.8 million— to the Conservation Trust Fund for distribution to local governments, and park and recreation districts on a per capita basis for parks, recreation and open space.
- 10%—or \$11.9 million— to the Division of Parks and Outdoor Recreation for state park and outdoor recreation projects.
- 50% to the GOCO Trust Fund capped at \$35 million annually adjusted for inflation-\$54.3 million in FY2009.
- \$5.5 million to the School Capital Construction Assistance Fund for facility improvements since GOCO reached its cap.

FUNDING CATEGORIES

The Colorado Constitution requires GOCO to allocate its proceeds to four areas in substantially equal portions over time:

- 1. "Investments in the wildlife resources of Colorado through the Colorado Division of Wildlife, including the protection and restoration of crucial wildlife habitats, appropriate programs for maintaining Colorado's diverse wildlife heritage, wildlife watching, and educational programs about wildlife and wildlife environment."
- 2. "Investments in the outdoor recreation resources of Colorado through the Colorado Division of Parks and Outdoor Recreation, including the State Parks system, trails, public information and environmental education resources, and water for recreational facilities."
- 3. "Competitive grants to the Colorado Divisions of Parks and Outdoor Recreation, and Wildlife, and to counties, municipalities, or other political subdivisions of the state, or non-profit land conservation organizations, to identify, acquire, and manage open space and natural areas of statewide significance."
- 4. "Competitive matching grants to local governments or other entities that are eligible for distributions from the Conservation Trust Fund, to acquire, develop or manage open lands and parks."

STRUCTURE OF THE BOARD

ACCOUNTABILITY

OVERVIEW OF GRANTS AWARDED FOR FY2009

Great Outdoors Colorado Board members are appointed by the Governor and subject to confirmation by the Colorado State Senate. The structure of the 17-member Board is designed to provide representation to all parts of the state based on population.

- Two members from each of Colorado's seven congressional districts serve.
- No two members from one congressional district can be from the same political party.
- One member of the Board must represent agricultural interests.
- Two members must live west of the Continental Divide.
- The Executive Director of the Colorado Department of Natural Resources and a representative from the Colorado Board of Parks and Outdoor Recreation, and from the Colorado Wildlife Commission are members.



The Great Outdoors Colorado Board strives to be responsive to the needs of communities, takes seriously the enormous responsibility the citizens have given it to allocate these public funds, and works hard to be an accountable organization.

The Board:

- has adopted bylaws.
- has adopted the State Code of Ethics.
- has adopted the Colorado Open Meetings Law.
- is subject to an annual audit by the State Auditor presented to the Legislative Audit Committee.
- must provide this annual report to the Governor, Colorado General Assembly and Colorado citizens.
- ensures the Joint Budget Committee and Capital Development Committee are notified of grants to the Division of Parks and Outdoor Recreation, and the Division of Wildlife.
- regularly conducts "stakeholder" meetings with citizens who represent organizations with involvement or expertise in each of GOCO's funding categories to set grant award criteria.
- has conducted four extensive public hearing processes in conjunction with formulating strategic plans.
- directs staff to conduct grant writing workshops throughout the state twice a year.
- holds one-half of all Board meetings outside the Denver metro area.

- commissioned four statewide surveys to identify citizen priorities for use of Lottery proceeds and to gain a better understanding of Coloradans' preferences for open space, parks, outdoor recreation and wildlife.
- commissioned three surveys of eligible grant recipients to assess the grant process and where additional technical assistance should be provided.

Payment In Lieu of Taxes (PILT)

GOCO does make Payments In Lieu of Taxes (PILT) on properties purchased by the Colorado Divisions of Wildlife and Parks. GOCO's share of the payment equals the portion of the project for which it paid. For example, if GOCO paid 50% for acquisition of a parcel, it would provide 50% of the PILT payment based on the agricultural value of the property.

What Great Outdoors Colorado Does Not Do

- The Board does not have the power to regulate. It only makes grants to willing recipients.
- The Board itself does not have the authority to acquire any interest in real property. The Board makes grants to eligible entities to acquire interest in real property.
- The Board does not have power of eminent domain.
 GOCO dollars cannot be used to acquire real property by condemnation.
- The Board cannot have an affect on Colorado water law. However, it can make grants to purchase water for recreational purposes or for aquatic habitat restoration or enhancement pursuant to Colorado water law.

In Fiscal Year 2008-2009, the GOCO Board awarded \$38.9 million for projects—projects that preserve land, provide new ballfields, skateparks and playgrounds, protect species, improve existing facilities at state parks and establish new state parks, and expand the state's trail system.

While the dollars GOCO awards are significant, demand continues to be greater. To maximize its resources, GOCO encourages grant recipients to form partnerships and to leverage GOCO dollars. Grant recipients have embraced these criteria, providing cash matching contributions and in-kind services far exceeding GOCO's requirements.

Project partners include local governments, state and federal agencies, land trusts, foundations, special districts, the business community, private landowners, non-profit organizations, school districts, community groups and volunteers.

OPEN SPACE GRANTS


LOCAL GOVERNMENT PARK, OUTDOOR RECREATION AND ENVIRONMENTAL EDUCATION FACILITY GRANTS

Colorado's dramatic population growth shows few signs of slowing any time soon: Projections place an additional 1 million residents in the state by 2020. While growth-and the development that comes with it—are vital to Colorado's economic health, so are its prime agricultural lands, unique wildlife habitats and breathtaking open spaces. Maintaining the state's beauty and natural resources is an enormous challenge in the face of rapid change, but GOCO is helping eligible entities (local governments, land trusts, the Colorado Division of Wildlife and Colorado State Parks) address this challenge through its Open Space Grant Program, which awards grants twice yearly.

In FY2009, GOCO awarded \$8 million in Open Space Grants for 26 projects that are helping to preserve 67,000 acres. Projects funded include:

- Lazy JC and Quarter Circle U Ranches in Saguache County sponsored by the Colorado Cattlemen's Agricultural Land Trust.
- Crescent Ranch in Montezuma and Dolores counties sponsored by the Montezuma Land Conservancy.
- Apishapa Ranch in Otero and Pueblo counties sponsored by The Nature Conservancy.
- Silver Plume Mountain Park In-Holding in Clear Creek County sponsored by the Town of Silver Plume.
- Harold G. Vickerman Ranch in Custer County sponsored by the San Isabel Land Protection Trust.

Regardless of their size or scope, central gathering places are vital to every community. One town may need its first playground, another may need restrooms in an existing sports facility, and another may need to create or expand a major water park. Whatever a community's outdoor recreation needs, GOCO funds can help. Cities, counties, and park and recreation districts are eligible for GOCO grants to acquire, expand and improve local parks, outdoor recreation amenities and environmental education facilities. Local Government Park and Outdoor Recreation Grants-and Mini-Grants for smaller projects in communities of 5,000 or less-are offered twice yearly.

In FY2009, GOCO awarded \$7.9 million in Local Government Park and Outdoor Recreation Grants for 61 projects in 30 counties. This includes 14 Mini-Grants for projects in smaller communities.

- Liberty Track and Field Improvements in Yuma County sponsored by Yuma County.
- Ophir Playground Addition in San Miguel County sponsored by the Town of Ophir.
- Stanley Park Playground and Restroom Enhancement in Larimer County sponsored by the Estes Valley Rec and Park District.
- Rocky Ford Babcock Park Project, Phase I in Otero County sponsored by the City of Rock Ford.
- Summit County Turf Project sponsored by Summit County.
- Park Enhancements in Green Mountain Falls in El Paso County sponsored by the Town of Green Mountain Falls.

TRAIL GRANTS

Hiking, biking, horseback riding, wildlife-watching, crosscountry skiing, snowshoeing. Since its inception in 1971, the Colorado State Trails Program has fostered the development of recreational trails for everyone. GOCO funding provides a substantial boost to the State Trails Program, which offers grants for trail planning and design, construction, maintenance, special projects and equipment. Trail Grants are offered once each year through the Colorado State Trails Program. In FY2009, GOCO provided \$563,321 for State Trails Grants to 3 local governments. Additionally, GOCO offered a special grant opportunity for larger trail projects in FY2009 providing \$3.5 million for 7 projects. Projects funded include:

- The Laramie Foothills Trails Development Project sponsored by Larimer County.
- The Swan Mountain Recreation Path/Sapphire Section sponsored by Summit County.
- The Harley to Carvon Section of the Animas River Greenway sponsored by the City of Durango.



PLANNING GRANTS


Preserving a community's character in the face of dramatic growth while also forecasting its future needs requires strategic planning. GOCO grants help communities throughout Colorado develop plans to protect and enhance open space, wildlife habitat and provide parks and trails elements that define and distinguish every city and town. GOCO Planning Grants lead to projects that have greater chances of long-term success. Local governments, land trusts, the Colorado Division of Wildlife and Colorado State Parks are all eligible for Planning Grants, which are offered twice yearly.

In FY2009, GOCO awarded \$328,927 in Planning Grants for 8 projects. Projects funded include:

- Pineries Open Space Park Master Plan in El Paso County sponsored by El Paso County.
- VanTuyl Ranch Master Plan in Gunnison County sponsored by the City of Gunnison.
- Howelson Hill Rodeo Facility Master Plan in Routt County sponsored by the City of Steamboat Springs.
- Parks, Recreation, Facilities and Trails Master Plan in San Miguel County sponsored by the Norwood Park and Recreation District.

WILDLIFE INVESTMENTS THROUGH THE COLORADO DIVISION OF WILDLIFE

In addition to managing the state's 960 wildlife species, the Division of Wildlife (DOW) oversees more than 230 wildlife areas for public recreation; conducts research to improve wildlife management activities; provides technical assistance to private and public landowners concerning wildlife and habitat management; and develops programs to protect and recover threatened and endangered species. The DOW is funded largely by hunting and fishing license fees, and spends most of its revenues on game species management—leaving limited resources for non-game species. GOCO/Lottery dollars help make up this shortfall by funding projects through the DOW for non-game species and habitat protection, while also providing opportunities for Coloradans to watch and learn about the state's wildlife.

In FY2009, GOCO invested \$8.6 million in projects through the DOW. Projects funded include:

- The placement of a conservation easement on the 1,025-acre Gilmore Ranch in Alamosa County—part of the Rio Grande Legacy project. The ranch provides valuable habitat for the Southwest Willow Flycatcher, the Western Yellow-billed cuckoo and the bald eagle, among other species.
- Conservation efforts that resulted in the bald eagle's removal from Colorado's list of threatened species.
- Initial development of a statewide lynx monitoring program; ten wild-born lynx kittens were documented for the first time in Colorado since 2006.
- Project WILD (Wildlife in Learning Design), which continues to reach thousands of Colorado students annually; specifically, 47 Wildlife Educator Workshops were held that reached 824 Colorado educators.

OUTDOOR RECREATION INVESTMENTS THROUGH THE DIVISION OF PARKS AND OUTDOOR RECREATION

More than 11 million visitors flock to Colorado's 42 state parks each year making the state park system an essential part of the state's economy and quality of life. GOCO/ Lottery funds continue to play a vital role in enabling State Parks to enhance existing facilities; buy land and provide facilities at new state parks; and acquire buffers to protect existing parks from encroaching development. State Parks also uses GOCO/Lottery funds to develop visitor centers, expand campgrounds and trails, and offer educational programming for Colorado youth.

In FY2009, GOCO invested \$9.9 million in projects through State Parks. Projects funded include:

- Enhancements to Elkhead Reservoir in Moffat County, including construction of a 16-unit campground, installation of park signage, and upgrades to the park's primary boat ramp.
- Colorado Youth Corps Association (CYCA) projects at state parks; a total of 210 crew members and 30 crew leaders worked on projects, which provided 17,496 hours of project labor for CYCA.
- Securing water leases from multiple sources to maintain adequate water levels for recreation at Cherry Creek State Park, one of the most popular sites in the State Parks system with more than 1 million visitors annually.

LEGACY GRANTS


What will you leave as your legacy? GOCO's Legacy Grant Program strives to ensure that Colorado's rich natural heritage is left for future generations. Legacy Grants are multi-year initiatives of regional or statewide importance to which GOCO has made multi-million dollar commitments. They are designed to preserve Colorado's land and water, enhance critical wildlife habitat, create new state and local parks, construct trails, and help provide environmental education. Legacy projects cross political and jurisdictional boundaries, and hinge upon strong partnerships between federal and state agencies, non-profit organizations, landowners and the private sector.

All entities eligible for GOCO funds can participate in the Legacy Grant Program, which is offered periodically as GOCO's financial position allows.

While Legacy Grants were not awarded in FY2009, work continued on projects previously funded:

- The final transaction in the Saguache Creek Corridor Legacy Project—the placement of a conservation easement on Quarter Circle U Ranch-occurred. All told, GOCO funds helped protect 6,446 acres in the corridor through the Legacy grant.
- The Town of Silverton completed improvements at Molas Lake Campground—part of the San Juan Skyway Legacy Project.
- The Trust for Public Land and the City of Littleton purchased Lee Gulch, part of the South Platte Greenway Legacy Project in Arapahoe County. The 5.4 acre parcel will provide public open space and trail connections to the Lee Gulch Trail and Mary Carter Greenway.
- Two conservation easements were finalized on properties that are part of the Rio Grande Legacy Project: The Gilmore Ranch in Alamosa County and the River Valley Ranch in Rio Grande County, protecting more than 1,600 acres.

FINANCIAL SUMMARY FOR FY 2008-2009

The following is a summary of financial information drawn from State Audit reports for 16 fiscal years of Great Outdoors Colorado's operation. More detailed financial information is included in the annual audit reports, which are available through GOCO.

Since Fiscal Year 1993-1994, Great Outdoors Colorado has authorized grants from Lottery proceeds for:

- local government park, outdoor recreation and environmental education facilities projects.
- outdoor recreation projects through the Colorado Division of Parks and Outdoor Recreation.
- wildlife projects through the Colorado Division of Wildlife.
- open space projects.
- planning and capacity building projects.
- trail projects.
- Legacy projects that integrate components of GOCO's four Constitutionally-mandated funding categories.

There are two financial steps to the GOCO grant process:

- 1) Grant Authorization The GOCO Board approves the use of funds for projects up to a specified amount.
- 2) Grant Expenditure Funds are distributed for projects as either reimbursements to sponsors for expenses incurred, or in the case of land acquisition payments, to a title company at the time of closing.

The Board furthered its mission during Fiscal Year 2008-2009 with \$59.6 million in grants expended.
