



### BACKGROUND

Created in 1992 as the result of a citizens' initiative. the Great Outdoors Colorado (GOCO) Constitutional Amendment-Article XXVII of the Colorado Constitution—redirected a portion of Lottery proceeds to the GOCO Trust Fund for projects that preserve, protect and enhance Colorado's wildlife, park, river, trail and open space heritage. The Amendment also created the GOCO Board to oversee distribution of the funds.

Contrary to what many people think, GOCO receives only a portion of Lottery proceeds. The Conservation Trust Fund and the Colorado Division of Parks and Wildlife (for state parks) are allocated 50% of the proceeds. Additionally, a cap is placed on the total amount of funding GOCO receives. In Fiscal Year 2010-2011, GOCO reached its cap of \$56 million; because of this, \$662,230 was contributed to the School Capital Construction Assistance Fund, created by voters in November 2000 with the passage of the Lottery's Powerball game.

### The allocation of Lottery proceeds in Fiscal Year 2010-2011 was:

- 40%—or \$45.3 million— to the Conservation Trust Fund for distribution to local governments, and park and recreation districts on a per capita basis for parks, recreation and open space.
- 10%—or \$11.3 million— to Colorado's state parks for park and outdoor recreation projects.
- 50% to the GOCO Trust Fund capped at \$35 million annually adjusted for inflation-\$56 million in FY2011.
- \$662,230 to the School Capital Construction Assistance Fund for facility improvements since GOCO reached its cap.

### **FUNDING CATEGORIES**

The Colorado Constitution requires GOCO to allocate its proceeds to four areas in substantially equal portions over time:

- 1. "Investments in the wildlife resources of Colorado through the Colorado Division of Wildlife, including the protection and restoration of crucial wildlife habitats, appropriate programs for maintaining Colorado's diverse wildlife heritage, wildlife watching, and educational programs about wildlife and wildlife environment."
- "Investments in the outdoor recreation resources of Colorado through the Colorado Division of Parks and Outdoor Recreation, including the State Parks system, trails, public information and environmental education resources, and water for recreational facilities."
- 3. "Competitive grants to the Colorado Divisions of Parks and Outdoor Recreation, and Wildlife, and to counties, municipalities, or other political subdivisions of the state, or non-profit land conservation organizations, to identify, acquire, and manage open space and natural areas of statewide significance."
- 4. "Competitive matching grants to local governments or other entities that are eligible for distributions from the Conservation Trust Fund, to acquire, develop or manage open lands and parks."



## STRUCTURE OF THE BOARD

Great Outdoors Colorado Board members are appointed by the Governor and subject to confirmation by the Colorado State Senate. The structure of the 17-member Board is designed to provide representation to all parts of the state based on population.

- Two members from each of Colorado's seven congressional districts serve.
- No two members from one congressional district can be from the same political party.
- One member of the Board must represent agricultural interests.
- Two members must live west of the Continental Divide.
- The Executive Director of the Colorado Department of Natural Resources and representatives from the Colorado Parks and Wildlife Board are members.



### **ACCOUNTABILITY**

The Great Outdoors Colorado Board strives to be responsive to the needs of communities, takes seriously the enormous responsibility the citizens have given it to allocate these public funds, and works hard to be an accountable organization.

### The Board:

- has adopted bylaws.
- has adopted the State Code of Ethics.
- has adopted the Colorado Open Meetings Law.
- is subject to an annual audit by the State Auditor presented to the Legislative Audit Committee.
- · must provide this annual report to the Governor, Colorado General Assembly and Colorado citizens.
- ensures the Joint Budget Committee and Capital Development Committee are notified of grants to the Division of Parks and Wildlife.
- regularly conducts "stakeholder" meetings with citizens who represent organizations with involvement or expertise in each of GOCO's funding categories to set grant award criteria.
- has conducted five extensive public hearing processes in conjunction with formulating strategic plans.
- directs staff to conduct grant writing workshops throughout the state twice a year.
- holds one-half of all Board meetings outside the Denver metro area.

- commissioned four statewide surveys to identify citizen priorities for use of Lottery proceeds and to gain a better understanding of Coloradans' preferences for open space, parks, outdoor recreation and wildlife.
- commissioned three surveys of eligible grant recipients to assess the grant process and where additional technical assistance should be provided.

### Payment In Lieu of Taxes (PILT)

GOCO does make Payments In Lieu of Taxes (PILT) on properties purchased by the Division of Parks and Wildlife. GOCO's share of the payment equals the portion of the project for which it paid. For example, if GOCO paid 50% for acquisition of a parcel, it would provide 50% of the PILT payment based on the agricultural value of the property.

### What Great Outdoors Colorado Does Not Do

- · The Board does not have the power to regulate. It only makes grants to willing recipients.
- The Board itself does not have the authority to acquire any interest in real property. The Board makes grants to eligible entities to acquire interest in real property.
- The Board does not have power of eminent domain. GOCO dollars cannot be used to acquire real property by condemnation.
- The Board cannot have an effect on Colorado water law. However, it can make grants to purchase water for recreational purposes or for aquatic habitat restoration or enhancement pursuant to Colorado water law.

### **OVERVIEW OF GRANTS AWARDED**

In Fiscal Year 2010-2011, the GOCO Board awarded \$52.9 million for 190 projects—projects that preserve land, provide new ballfields, skateparks and playgrounds, protect species, improve existing facilities at state parks and establish new state parks, and expand the state's trail system.

While the dollars GOCO awards are significant, demand continues to outpace available funds. To maximize its resources, GOCO encourages grant recipients to form partnerships and to leverage GOCO dollars. Grant recipients have embraced these criteria, providing cash matching contributions and in-kind services far exceeding GOCO's requirements.

Project partners include local governments, state and federal agencies, land trusts, foundations, special districts, the business community, private landowners, non-profit organizations, school districts, community groups and volunteers.



### **OPEN SPACE** GRANTS


Preserving Colorado's open spaces-land along river corridors, urban parcels, agricultural lands and wildlife habitat-directly benefits the state's economic health and development. Efforts to sustain the quality of life in Colorado amid rapid population growth and change are enormously challenging, however. GOCO continues to help eligible entities-local governments, land trusts, and the Colorado Division of Parks and Wildlife-address these challenges through its Open Space Grant Program, which awards grants twice each year.

In FY 2011, GOCO awarded \$17.1 million in Open Space Grants for 26 projects that are helping to preserve 20,688 acres. Projects funded include:

- · The Upper Trout Creek Valley Conservation Initiative in Routt County sponsored by Colorado Cattlemen's Agricultural Land Trust.
- Westminster Hills Open Space in Jefferson County sponsored by the City of Westminster.
- Shaw Ranch in Yuma County sponsored by The Nature Conservancy.
- Green Ranch in Alamosa County sponsored by Rio Grande Headwaters Land Trust.
- · Animas River Greenway Preservation Project in La Plata County sponsored by the City of Durango.

# LOCAL GOVERNMENT PARK, OUTDOOR RECREATION AND ENVIRONMENTAL EDUCATION FACILITY GRANTS

Regardless of size, every community needs places to gather and recreate. One community may need its first playground while another needs to expand a major water park. Whatever a community's outdoor recreation needs, GOCO funds can help. Cities, counties, and park and recreation districts are eligible for GOCO grants to acquire, expand, and improve local parks, outdoor recreation amenities, and environmental education facilities. Local Government Park and Outdoor Recreation Grantsand Mini Grants for smaller projects costing \$60,000 or less-are offered twice each year.



- Blue River Town Park in Summit County sponsored by the Town of Blue River.
- Huerfano Re-1 Community Sports Complex in Huerfano County sponsored by the Huerfano Park and Rec District.
- Chipeta Park Enhancement Project, Phase II in Boulder County sponsored by the Town of Nederland.
- Enhancement of Peach Bowl Park in Mesa County sponsored by the Town of Palisade.
- Homesteaders Park Playground, Turf Field and Disc Golf Course in Phillips County sponsored by Phillips County.
- Playground Improvements at the Clayton/Bertha Heid Campus in Adams County sponsored by Adams County.



### TRAIL GRANTS

Since 1971, the Colorado State Trails Program has fostered the development of recreational trails for everyone and almost all possible trail experiences, including hiking, biking, horseback riding, wildlifewatching or cross-country skiing. GOCO funding provides a substantial boost to the State Trails Program, which offers grants for trail planning and design, construction, maintenance, special projects and equipment. Trail Grants are offered once each year through the Colorado State Trails Program.



### In FY 2011, GOCO provided \$500,000 for State Trail Grants to 3 local governments:

- Lower Little Salt Wash Trail Construction in Mesa County sponsored by the City of Fruita.
- Avon to Eagle-Vail Trail, Phase I in Eagle County sponsored by the ECO Trails Program of Eagle County Government.
- Fountain-Clear Spring Connector Trail
   Acquisition sponsored by the City of Fountain in El Paso County.

GOCO also invested additional funds in the State Trails Program through its state park purpose, which helped provide grants to seven additional trails projects.

### **PLANNING GRANTS**

Planning Grants help develop strategic plans that create, protect and enhance open space, wildlife habitat, parks and trails—crucial elements of every community. Because Planning Grants result in sound plans, they typically lead to projects with greater long-term success. Local governments, land trusts, and the Colorado Division of Parks and Wildlife are all eligible for Planning Grants, which are offered twice each year.

### In FY 2011, GOCO awarded \$731,950 in Planning Grants for 17 projects. Projects funded include:

- Carbondale Gateway River Park Site Plan in Garfield County sponsored by the Town of Carbondale.
- Bear Creek Lake Park Environmental Education Center Master Plan in Jefferson County sponsored by the City of Lakewood.
- Trails, Recreation and Open Space Plan sponsored by Costilla County.

# CONSERVATION EXCELLENCE GRANTS

Designed to assist organizations in achieving high-caliber land conservation, Conservation Excellence Grants provide funding for conservation planning, staff training, open space assessment, expansion of services in underserved regions, education, and other activities that improve and expand an existing entity's capacity to do its best work in land conservation. Local governments and land trusts are eligible for Conservation Excellence Grants, which are offered twice each year.

### In FY 2011, GOCO awarded \$269,744 in Conservation Excellence Grants for 3 projects:

- GIS Analyses of Denver Metro Park Equity, Riparian Habitat Protection, and Trail
   Connectivity in Adams, Arapahoe, Boulder, Denver, Douglas, Jefferson and Weld counties sponsored by The Trust for Public Land.
- Conservation Priority Setting for Garfield County sponsored by The Trust for Public Land.
- Statewide Center of Excellence in Conservation sponsored by the Colorado Conservation Trust.



### WILDLIFE INVESTMENTS THROUGH THE COLORADO DIVISION OF PARKS AND WILDLIFE

GOCO funds invested through the Division of Parks and Wildlife are used for habitat and species protection, wildlife education, and programs like Watchable Wildlife. Parks and Wildlife manages the state's 960 wildlife species, oversees more than 230 wildlife areas used for public recreation, conducts research for wildlife management, and develops programs for threatened and endangered species. Because wildlife funding primarily comes from hunting and fishing license fees, Parks and Wildlife spends most of its revenue on game species management. This limits funding for non-game species management, habitat protection and educational programming. Fortunately, GOCO funds keep these critical efforts viable.



In FY 2011, GOCO invested \$18.6 million in wildlife projects through Colorado Parks and Wildlife. Projects funded include:

- · The Wildlife Habitat Protection Program, which matches GOCO funds with Wildlife Habitat Stamp monies to protect habitat and the species that rely on it. To date, this joint effort has protected more than 300,000 acres of habitat across Colorado.
- The Wetlands Program, which will help restore, enhance, and create roughly 1,000 acres of wetland and riparian habitat at 12 sites. These areas comprise less than 2% of Colorado's land, but provide benefits to more than 75% of the state's species.
- Wildlife education projects that introduce youth and families to outdoor recreation activities, which build awareness and understanding of wildlife and its management, thereby helping to create future land and wildlife stewards.


# OUTDOOR RECREATION INVESTMENTS THROUGH THE COLORADO DIVISION OF PARKS AND WILDLIFE

Colorado's 42 state parks offer quality outdoor recreation experiences for more than 11 million visitors each year. An invaluable resource close to home, Colorado's network of state parks also serves as a cornerstone of our state's economy and quality of life.

Due to budget constraints, the Division of Parks and Wildlife continues to rely heavily on GOCO funds to enhance existing state parks, provide facilities at new state parks, and offer educational programs for Colorado youth.

### In FY 2011, GOCO invested \$9.4 million in outdoor recreation through Colorado Parks and Wildlife. Projects funded include:

- Improvements at 4 parks to structures built over 30 years ago at a time when parks served much fewer visitors. Projects include road improvements and trail replacement at Chatfield and Cherry Creek State Parks, as well as dam renovations at the yet-to-be opened Staunton State Park.
- · Trails and river greenways funding, part of which will be matched with GOCO Local Government purpose funds for grants through the State Trails Program. Work will also continue on trails within state parks.
- Environmental education funding, which supports the Volunteer Program at state parks and work by the Colorado Youth Corps Association.



### STRATEGIC PLAN UPDATE

In April 2010, following extensive input from stakeholders statewide, the GOCO Board adopted a new Strategic Plan that outlines priorities and initiatives to guide its work over the next five to ten years. The Plan organizes GOCO's grant programs into three broad areas—Land, Water and Wildlife; Outdoor Recreation and Trails; and Youth, Families and the Outdoors—and sets specific goals within each area.

GOCO has incorporated Plan components into each of its competitive grant programs, which has resulted in projects that implement one or more of the Plan's objectives. Additionally, GOCO continues to advance the Plan's goals via Special Opportunity grants and initiatives, which it periodically offers to provide larger project grants beyond those offered in GOCO's regular grant cycles.

In Fiscal Year 2011, GOCO awarded a \$1 million grant to the Colorado Youth Corps Association that created 400 land stewardship jobs statewide for youth and young adults at no cost to taxpayers. Because of the GOCO/Lottery grant, youth corps crews are working to maintain and help develop trails, parks, open space and wildlife habitat projects throughout Colorado.

GOCO is offering a Special Opportunity grant cycle in Fiscal Year 2012 for projects centered on river corridors. The initiative builds upon previous work along river corridors that GOCO has funded including the South Platte River Corridor in Adams, Arapahoe and Denver counties; the Yampa River System; the Sand Creek Regional Greenway; and the Colorado Riverfront in Mesa County. The Board approved up to \$18 million for the River Corridors Initiative, which was developed to acquire river-based recreation properties and construct river-based parks, trails and environmental education facilities.

### FINANCIAL FY 2010-2011

The following is a summary of financial information drawn from State Audit reports for 18 fiscal years of Great Outdoors Colorado's operation. More detailed financial information is included in the annual audit reports, which are available through GOCO.

### Since Fiscal Year 1993-1994, Great Outdoors Colorado has authorized grants from Lottery proceeds for:

- · local government park, outdoor recreation and environmental education facilities projects.
- outdoor recreation projects through the Colorado Division of Parks and Wildlife.
- wildlife projects through the Colorado Division of Parks and Wildlife.
- open space projects.
- planning and capacity building projects.
- trail projects.
- Special Opportunity and Legacy projects that integrate components of GOCO's four Constitutionally-mandated funding categories.

### There are two financial steps to the GOCO grant process:

- Grant Authorization The GOCO Board approves the use of funds for projects up to a specified amount.
- Grant Expenditure Funds are distributed for projects as either reimbursements to sponsors for expenses incurred, or in the case of land acquisition payments, to a title company at the time of closing.

### The Board furthered its mission during Fiscal Year 2010-2011 with \$73.1 million in grants expended.

#### **Expenditures**

Great Outdoors Colorado expenditures include payments to grantees and covering administrative expenses. Administrative expenses include operating expenses and Board expenses. Through 18 fiscal years, administrative expenses have totaled approximately 3% of total revenues, substantially less than interest earned on cash balances.
