BACKGROUND

Created in 1992 as the result of a citizens' initiative, the Great Outdoors Colorado (GOCO) Constitutional Amendment—Article XXVII of the Colorado Constitution—redirected a portion of Lottery proceeds to the GOCO Trust Fund for projects that preserve, protect and enhance Colorado's wildlife, park, river, trail and open space heritage. The Amendment also created the GOCO Board to oversee distribution of the funds.

Contrary to what many people think, GOCO receives only a portion of Lottery proceeds. The Conservation Trust Fund and the Colorado Division of Parks and Wildlife (for state parks) are allocated 50% of the proceeds. Additionally, a cap is placed on the total amount of funding GOCO receives. In Fiscal Year 2011-2012, GOCO reached its cap of \$57 million; because of this, \$4.6 million was contributed to the School Capital Construction Assistance Fund, created by voters in November 2000 with the passage of the Lottery's Powerball game.


The allocation of Lottery proceeds in Fiscal Year 2011-2012 was:


- 40%—or \$49.3 million— to the Conservation Trust Fund for distribution to local governments, and park and recreation districts on a per capita basis for parks, recreation and open space.
- 10%—or \$12.3 million— to Colorado's state parks for park and outdoor recreation projects.
- 50% to the GOCO Trust Fund capped at \$35 million annually adjusted for inflation—\$57 million in FY2012.
- \$4.6 million to the School Capital Construction Assistance Fund for facility improvements since GOCO reached its cap.

FUNDING CATEGORIES

The Colorado Constitution requires GOCO to allocate its proceeds to four areas in substantially equal portions over time:

- "Investments in the wildlife resources of Colorado through the Colorado Division of Wildlife*, including the protection and restoration of crucial wildlife habitats, appropriate programs for maintaining Colorado's diverse wildlife heritage, wildlife watching, and educational programs about wildlife and wildlife environment."
- 2. "Investments in the outdoor recreation resources of Colorado through the Colorado Division of Parks and Outdoor Recreation*, including the State Parks system, trails, public information and environmental education resources, and water for recreational facilities."
- 3. "Competitive grants to the Colorado Divisions of Parks and Outdoor Recreation, and Wildlife*, and to counties, municipalities, or other political subdivisions of the state, or non-profit land conservation organizations, to identify, acquire, and manage open space and natural areas of statewide significance."
- 4. "Competitive matching grants to local governments or other entities that are eligible for distributions from the Conservation Trust Fund, to acquire, develop or manage open lands and parks."

STRUCTURE OF THE BOARD

Great Outdoors Colorado Board members are appointed by the Governor and subject to confirmation by the Colorado State Senate. The structure of the 17-member Board is designed to provide representation to all parts of the state based on population.

- Two members from each of Colorado's seven congressional districts serve.
- No two members from one congressional district can be from the same political party.
- One member of the Board must represent agricultural interests.
- Two members must live west of the Continental Divide.
- The Executive Director of the Colorado Department of Natural Resources and representatives from the Colorado Parks and Wildlife Commission are members.



ACCOUNTABILITY

The Great Outdoors Colorado Board strives to be responsive to the needs of communities, takes seriously the enormous responsibility the citizens have given it to allocate these public funds, and works hard to be an accountable organization.

The Board:

- has adopted bylaws.
- has adopted the State Code of Ethics.
- · has adopted the Colorado Open Meetings Law.
- is subject to an annual audit by the State Auditor presented to the Legislative Audit Committee.
- must provide this annual report to the Governor, Colorado General Assembly and Colorado citizens.
- ensures the Joint Budget Committee and Capital Development Committee are notified of grants to the Division of Parks and Wildlife.
- regularly conducts "stakeholder" meetings with citizens who represent organizations with involvement or expertise in each of GOCO's funding categories to set grant award criteria.
- has conducted five extensive public hearing processes in conjunction with formulating strategic plans.
- directs staff to conduct grant writing workshops throughout the state twice a year.
- holds one-half of all Board meetings outside the Denver metro area.

- commissioned numerous statewide surveys to identify citizen priorities for use of Lottery proceeds and to gain a better understanding of Coloradans' preferences for open space, parks, outdoor recreation and wildlife.
- commissioned numerous surveys of eligible grant recipients to assess the grant process and where additional technical assistance should be provided.

Payment In Lieu of Taxes (PILT)

GOCO does make Payments In Lieu of Taxes (PILT) on properties purchased by the Division of Parks and Wildlife. GOCO's share of the payment equals the portion of the project for which it paid. For example, if GOCO paid 50% for acquisition of a parcel, it would provide 50% of the PILT payment based on the agricultural value of the property.

What Great Outdoors Colorado Does Not Do

- The Board does not have the power to regulate. It only makes grants to willing recipients.
- The Board itself does not have the authority to acquire any interest in real property. The Board makes grants to eligible entities to acquire interest in real property.
- The Board does not have power of eminent domain. GOCO dollars cannot be used to acquire real property by condemnation.
- The Board cannot affect Colorado water law. However, it can make grants to purchase water for recreational purposes or for aquatic habitat restoration or enhancement pursuant to Colorado water law.

OVERVIEW OF GRANTS AWARDED FOR FY2012

In Fiscal Year 2011-2012, the GOCO Board awarded \$63.2 million for 156 projects—projects that preserve land, provide new ballfields, skateparks and playgrounds, protect species, improve existing facilities at state parks, and expand the state's trail system.

While the dollars GOCO awards are significant, demand continues to outpace available funds. To maximize its resources, GOCO encourages grant recipients to form partnerships and leverage GOCO dollars. Grant recipients have embraced these criteria, providing cash matching contributions and in-kind services far exceeding GOCO's requirements.

Project partners include local governments, state and federal agencies, land trusts, foundations, special districts, the business community, private landowners, non-profit organizations, school districts, community groups and volunteers.



RIVER CORRIDOR INITIATIVE

In FY 2012, at the urging of stakeholders, local governments and numerous land trusts statewide, the GOCO Board offered a special grant opportunity the River Corridor Initiative—to increase outdoor recreational opportunities near Colorado's waterways by investing in projects that preserve publiclyaccessible open space and develop trails close to rivers and creeks.


Response to the River Corridor Initiative was overwhelming and competition for funding was fierce. In June 2012, the GOCO Board announced \$29.5 million in lottery grants to fund eight River Corridor projects across the state that will result in the protection of more than 3,000 acres of publicly-accessible open space and critical trail development—and increase opportunities to experience Colorado's rivers first-hand.

Five of the funded projects are located along Colorado's Front Range:

- **Poudre River Trail Corridor Improvement Project** sponsored by Larimer County, the City of Fort Collins, the City of Greeley, the Town of Timnath and the Town of Windsor.
- Denver South Platte River Implementation Project sponsored by the City and County of Denver, the Greenway Foundation and The Trust for Public Land.
- Peaks to Plains Trail: Clear Creek Canyon Phase sponsored by Jefferson County and Clear Creek County.
- **Triple Creek Greenway Corridor Project** sponsored by the City of Aurora and The Trust for Public Land.
- Fountain Creek Watershed Trails and Recreation Projects sponsored by numerous partners including the City of Pueblo, the City of Colorado Springs, El Paso County and the City of Fountain.

Three other projects are located along the Colorado and Yampa Rivers:

- Colorado River Conservation and Recreation Project sponsored by Eagle County and The Conservation Fund.
- Colorado Riverfront Trail Project: Fruita Connection, Phase III sponsored by numerous partners including Mesa County, the City of Fruita, the Town of Palisade and the Riverfront Foundation.
- Yampa River Legacy Project sponsored by the Yampa Valley Land Trust and the City of Steamboat Springs.





Preserving Colorado's open spaces-land along river corridors, urban parcels, agricultural lands and wildlife habitat-directly benefits the state's economic health and development.Efforts to sustain the quality of life in Colorado amid rapid population growth and change are enormously challenging, however. GOCO continues to help eligible entities-local governments, land trusts, and the Colorado Division of Parks and Wildlife-address these challenges through its Open Space Grant Program, which awards grants twice each year.

In FY 2012, GOCO awarded \$8.1 million in Open Space Grants for 18 projects that are helping to preserve more than 24,086 acres. Projects funded include:

- Markus Ranch in Teller County sponsored by the Palmer Land Trust.
- Los Caminos Farm sponsored by Colorado Open Lands.
- Three Sisters in Mesa County sponsored by the Mesa Land Trust.
- Marrs Farm in Arapahoe County sponsored by The Trust for Public Land.
- East Weber Canyon Ranch in Montezuma County sponsored by the Montezuma Land Conservancy.



LOCAL GOVERNMENT PARK, OUTDOOR RECREATION AND ENVIRONMENTAL EDUCATION FACILITY GRANTS

Every community needs places to gather and recreate. While one community may need a playground, another may seek to expand a water park. Whatever a community's outdoor recreation needs, GOCO funds can help. Cities, counties, and park and recreation districts are eligible for GOCO grants to acquire, expand, and improve local parks, outdoor recreation amenities, and environmental education facilities. Local Government Park and Outdoor Recreation Grants—and Mini Grants for smaller projects costing \$60,000 or less—are offered twice each year.

In FY 2012, GOCO awarded \$4.9 million in Local Government Park and Outdoor Recreation Grants for 30 projects, including 9 Mini Grants for smaller projects costing \$60,000 or less. Projects funded include:

- Minton Park Expansion, Phase I in Clear Creek County sponsored by the Town of Empire.
- McClave Park Improvements sponsored by Bent County.
- Gunnison Skate Park in Gunnison County sponsored by the City of Gunnison.
- Community Partnership Garden in Garfield County sponsored by the Town of Carbondale.
- Westwood Neighborhood Park sponsored by the City and County of Denver.



TRAIL GRANTS

Since 1971, the Colorado State Trails Program has fostered the development of recreational trails for everyone and almost all possible trail experiences, including hiking, biking, horseback riding, wildlifewatching or cross-country skiing. GOCO funding provides a substantial boost to the State Trails Program, which offers grants for trail planning and design, construction, maintenance, special projects and equipment. Trail Grants are offered once each year through the Colorado State Trails Program.

In FY 2012, GOCO provided \$500,000 for State Trail Grants to 4 local governments:

- Fruita Connection Phase II of the Colorado Riverfront Trail sponsored by Mesa County.
- Darby Lateral Trail Underpass sponsored by the City of Aurora.
- Denver Mountain Parks Trail Stewardship Initiative in Jefferson County sponsored by Denver Parks and Recreation.
- Pagosa Springs Town to Lakes Trail Segment sponsored by the Town of Pagosa Springs.

GOCO also invested additional funds in the State Trails Program through its state parks purpose, which helped provide grants to 27 other trails projects.

PLANNING GRANTS

Planning Grants help develop strategic plans that create, protect and enhance open space, wildlife habitat, parks and trails-crucial elements of every community. Because Planning Grants result in sound plans, they typically lead to projects with greater longterm success. Local governments, land trusts, and the Colorado Division of Parks and Wildlife are all eligible for Planning Grants, which are offered twice each year.

In FY 2012, GOCO awarded \$510,500 in Planning Grants for 9 projects. Projects funded include:

- Alamosa Community Trails and Cross-country Course Master Plan sponsored by the City of Alamosa.
- South Platte River Corridor Master Plan: Platteville to Milliken sponsored by the Town of Milliken.
- El Paso County Parks, Trails and Open Space Master Plan Update sponsored by El Paso County.

CONSERVATION EXCELLENCE GRANTS

Designed to assist organizations in achieving highcaliber land conservation, Conservation Excellence Grants provide funding for conservation planning, staff training, open space assessment, expansion of services in underserved regions, education, and other activities that improve and expand an existing entity's capacity to do its best work in land conservation. Local governments and land trusts are eligible for Conservation Excellence Grants, which are offered twice each year.

In FY 2012, GOCO awarded \$216,760 in Conservation Excellence Grants for 4 projects. Projects funded include:

- Caring for Colorado's Outdoors Project sponsored by Douglas County.
- Regional Land Conservation, Stewardship and Recreation Study sponsored by Larimer County.





WILDLIFE INVESTMENTS THROUGH THE COLORADO DIVISION OF PARKS AND WILDLIFE

GOCO funds invested through the Division of Parks and Wildlife are used for habitat and species protection, wildlife education, and programs like Watchable Wildlife. Colorado Parks and Wildlife manages the state's 960 wildlife species, oversees more than 300 wildlife areas used for public recreation, conducts research for wildlife management, and develops programs for threatened and endangered species. Because wildlife funding primarily comes from hunting and fishing license fees, Colorado Parks and Wildlife spends most of its revenue on game species management. This limits funding for non-game species management, habitat protection, and educational programming. Fortunately, GOCO funds keep these critical efforts viable.



In FY 2012, GOCO invested \$16.9 million in wildlife projects through Colorado Parks and Wildlife. Projects funded include:

- Numerous transactions that resulted in the protection of more than 16,000 acres of wildlife habitat via the Wildlife Habitat Protection Program, which matches GOCO funds with Wildlife Habitat Stamp monies to protect habitat and the species that rely on it.
- Successful reproduction of the Arkansas darter and bluehead sucker at the Native Aquatic Species Restoration Facility.
- Rewriting the Colorado Environmental Education Plan in collaboration with the Colorado Department of Education.
- The restoration or enhancement of 1,486 acres of wetlands and riparian areas.
- Recovery efforts for threatened and endangered species including the Canada lynx, black-footed ferret, piping plover and least turn, peregrine falcon, Mexican spotted owl, and greenback cutthroat trout.
- Protection efforts for native species including greater sage-grouse, Gunnison sage-grouse, lesser prairiechicken, white-tailed ptarmigan, and the boreal toad.

OUTDOOR RECREATION INVESTMENTS THROUGH THE COLORADO DIVISION OF PARKS AND WILDLIFE

Colorado's 42 state parks attract more than 12 million visitors per year, offering exceptional settings for healthy, fun-filled outdoor recreation that promotes stewardship of our natural resources. Colorado's network of state parks also serves as a cornerstone of our state's economy and quality of life.

Due to budget constraints, Colorado Parks and Wildlife relies on GOCO funds to help operate and staff state parks, offer educational programming for youth, and enhance and manage recreational amenities throughout the state parks system.

In FY 2012, GOCO invested \$6.5 million in outdoor recreation through Colorado Parks and Wildlife. Projects funded include:

• Environmental education, including the Volunteer Program and seasonal employees who lead interpretive programs and hikes at state parks, as well as work at state parks by the Colorado Youth Corps Association.

- Planning, construction and maintenance of trails and river greenways through the State Trails Program, matched in part with GOCO Local Government purpose funds. Parks purpose funds also help build trails within state parks.
- Improvements at Cherry Creek State Park, including construction of a camper services building, road repairs, and camp site enhancements.
- A program that helps manage water resources at state parks to enhance water-based recreational opportunities via acquisitions and leases of water rights, and interagency partnerships for joint water acquisitions that supplement or augment water levels.





FINANCIAL SUMMARY FOR FY 2011-2012

The following is a summary of financial information drawn from State Audit reports for 19 fiscal years of Great Outdoors Colorado's operation. More detailed financial information is included in the annual audit reports, which are available through GOCO.

Since Fiscal Year 1993-1994, Great Outdoors Colorado has authorized grants from Lottery proceeds for:

- local government park, outdoor recreation and environmental education facilities projects.
- outdoor recreation projects through the Colorado Division of Parks and Wildlife.
- wildlife projects through the Colorado Division of Parks and Wildlife.
- open space projects.
- planning and capacity building projects.
- trail projects.
- projects that integrate components of GOCO's four Constitutionally-mandated funding categories.

There are two financial steps to the GOCO grant process:

- 1) Grant Authorization The GOCO Board approves the use of funds for projects up to a specified amount.
- 2)Grant Expenditure Funds are distributed for projects as either reimbursements to sponsors for expenses incurred, or in the case of land acquisition payments, to a title company at the time of closing.

The Board furthered its mission during Fiscal Year 2011-2012 with \$57.6 million in grants expended.
