2006 KidsCount in Colorado!

Introduction

Today, there are more than 1.1 million children in Colorado – and that number and their needs are growing. The Colorado Children's Campaign's mission is to create hope and opportunity for not just one of those children, or 100 children or 1,000 children – but one million Colorado children at a time.

This 13th edition of KidsCount in Colorado! details child well-being on a county-by-county level, including new county-level indicators on student achievement. In addition, the continued expansion of the U.S. Census Bureau's American Community Survey provides an opportunity to take a closer look at recent demographic trends regarding children in immigrant families in Colorado.



Recent Trends in Child Well-Being

The quality of life for most Colorado children has seen real progress over the past decade. Fewer children are dying before reaching their teen years, full-day Kindergarten enrollment is on the rise, and fewer teens are having babies.

Promising Trends


- ★ Child deaths (ages 1-14) dropped to a low of 16.9 per 100,000 (lowest since 1990).
- Full-day Kindergarten enrollment rose to 24 percent, but still lags behind the national average of nearly 60 percent full-day Kindergarten participation.
- Firths to teens remain much below the peak of the early 1990s, although they have increased slightly to 24.8 per 1,000 in 2004 compared to 24.3 per 1,000 in 2003.

These are accomplishments worth celebrating. Yet we recognize that challenges remain and our work to improve the well-being of all children in Colorado is far from done.


INTRODUCTION / RECENT TRENDS IN CHILD WELL-BEING

Troubling Trends

- Low birth weights continue to be an issue in Colorado (9.0 percent in 2004).
- Teen deaths due to injuries rose sharply from 52.4 deaths per 100,000 teens in 2003 to 60.7 deaths per 100,000 teens in 2004.
 - All three components (accidents, homicides and suicides) of this death rate rose between 2003 and 2004.
 - The vast majority (80%) of teen deaths due to injuries are due to injuries sustained in motor vehicles (107 of the 133 deaths).




- Child poverty rose in 2004 to 14.2 percent, up from 9.2 percent in 2000.
- Furthermore, nearly one in six young children (under age 5) lives in poverty.



Births to women with no high school diploma continue to rise slightly from 22.4 percent in 2003 to 22.8 percent in 2004. This is a considerable increase from a decade ago when 17.6 percent of births were to women with no high school diploma in 1994.

Colorado's Changing Population

In 2004, the number of births to Colorado residents declined for the first time since 1993. With 68,475 births, this was a decrease of more than 800 births from 2003.





The Colorado demographer's office expects Colorado's population to grow by 100,000 people each year until 2030, culminating in a state population of 7.4 million 25 years from now. The current Colorado population is 4.6 million. Between 2000 and 2005, most of our population growth was a natural increase (births minus deaths). Growth after 2005, however, will mainly be from migration into the state. Roughly 60 percent of the forecasted increase is due to migration to Colorado, by immigrants from other countries and movers from other states.

COLORADO'S CHANGING POPULATION

Three Major Demographic Trends

Three major trends are playing into Colorado's demographics. All three are detailed briefly below, and the main issue affecting children is explored in more detail.

Aging of the population

Between 2000 and 2020, Colorado's population ages 55 to 64 will more than double in size as the "Baby Boomers" born from 1946 to 1964 are approaching retirement age.


The population of working-age adults who pay the majority of taxes and provide most services will not increase at the same rate because the baby boom was followed by the "birth dearth," and, in recent years, fertility rates have been declining.

- Colorado's birth rate in 2004 was 14.7 per 1,000 compared to 27.2 per 1,000 in 1952.
- The individuals born at Colorado's "birth peak" are turning 54 this year and nearing retirement.
- The combined effect will be a sharp increase in the old-age dependency ratio, the ratio of the working-age population to the elderly population. Currently, there are 3.3 workers for each Social Security beneficiary nationally. By 2031, there will be only 2.1 workers for each beneficiary nationally and the Colorado trend is expected to be similar.

Migration of people within the United States

- The migration of people in the U.S. was a major contributor to Colorado's growth in the 1990s.
- As of 2004, 47 percent of Colorado's population was born in another state, compared to 29 percent nationally.


Immigration of foreign-born population

- In 2004, the foreign-born population represented 10 percent of Colorado's total population. At the national level, the foreign-born population represented 12 percent of the total population.
- 🕺 In contrast, 72 percent of children under age 18 living in Colorado in 2004 were born in Colorado, and only 4 percent were foreign-born.
- The number of immigrants coming to the United States each year, legally and illegally, grew very rapidly starting in the mid-1990s, hit a peak at the end of the decade, and then declined substantially after 2001.
- 🗶 In absolute numbers, slightly less than 50,000 children and youth in Colorado are foreign-born, as of 2004.

Nearly all children residing in Colorado are U.S. citizens, having been born here. A high-quality education is the best way to ensure that the second-generation of families who immigrated to the U.S. do not suffer the same economic and social handicaps as their parents. Education may help the children of immigrants to make the maximum possible contributions to the long-term economy of our state and the United States.

¹These data are based on a sample and are subject to sampling variability. The percentage of children in each category in individual counties may be significantly greater or less than the state average.


Using data from the U.S. Census Bureau's Current Population Survey, the Pew Hispanic Center estimates that between 200,000 and 250,000 undocumented immigrants live in Colorado.² Of these undocumented immigrants, between 30,000 and 40,000 are children. Based on this, approximately three percent of Colorado's child population is undocumented. Children are less likely than adults to be illegal immigrants because they tend to have been born here after their parents immigrated.


* Components of 'Other Legal Status' include legal permanent residents, naturalized citizens, temporary protected status and refugees/asylees. In 2004, Colorado's foreign-born child population numbered approximately 50,000. Nearly two-thirds of these children were born in Mexico, compared with 38 percent nationally.

Children in Immigrant Families: A Closer Look

Definition: children who are foreign-born or have at least one foreign-born parent

The Colorado Children's Campaign recognizes that the issue of immigration has recently been the focus of much examination and debate. We are an organization dedicated to providing reliable data that can contribute to informed and measured debate. We believe that the information provided in this report can help decision makers to better understand the scope of the issue and more specifically the impact on children.

- The latest estimate of the child population living in immigrant families in Colorado is 219,000 children.³
 - The proportion of children in Colorado who live in immigrant families is just slightly less than the national average.



Family Structure

Children in immigrant families are more likely than children in non-immigrant, U.S.-born families to live in married-couple families.

Children Living in Married-Couple Families by Immigrant Status: Colorado and U.S., 2002-04






Child Poverty

- Poverty for all children, regardless of immigration status, rose in 2004 to 14.2 percent, up from 9.2 percent in 2000.
- In Colorado, children in immigrant families are more than twice as likely to live in poverty as are children in U.S.-born families.
- Childhood poverty is the most consistent predictor of problems in school and throughout life. When compared to more affluent children, poor children are more likely to demonstrate low academic achievement, drop out of school, become teen parents and have health and emotional problems.

Children Living in Poverty by Immigrant Status: Colorado and U.S., 2002-04




- More than half of children in immigrant families live in low-income working families.⁴
- The gap between low-income, working immigrant families and lowincome, working U.S.-born families in Colorado is greater than the gap nationwide. Although a similar proportion of Colorado's immigrant families could be classified as the "working poor," (lowincome despite work effort), Colorado's U.S.-born families are less likely to fall into this category.



⁴ Definition: The share of all children under age 18 living in families that met two criteria: (1) the family income was less than twice the federal poverty level; (2) at least one parent worked 50 or more weeks during the previous year.

Secure Parental Employment


- Children in families without secure parental employment⁵ not only face higher rates of poverty, but are far more likely to be without health insurance and other family benefits that come with stable employment. When parents have secure employment, children are more likely to have good nutrition, decent, stable housing and adequate health care.
 - No real difference exists in the proportion of children living without secure parental employment based on immigrant status.



⁵ Definition:The share of all children under age 18 living in families where no parent has regular, full-time employment.

⁶ The share of children under age 18 whose resident parents are in the civilian labor force. For children living in a married-couple family, both parents are in the labor force. For children living in a single-parent family, the resident parent is in the labor force.)

A smaller proportion of children living in immigrant families have all available parents in the labor force⁶ than children in U.S.-born families.






SECURE PARENTAL EMPLOYMENT

Housing

A continuing challenge for families, both in Colorado and nationwide, is finding affordable housing. When housing costs take a higher proportion of a family's income, the family must make difficult decisions. This could include going without health insurance or cutting back in other crucial areas.

This problem is critical for immigrant families. Nearly half of children in immigrant families live in families that spend more than 30 percent of their income on housing.

Children Living in Families that Spend more than 30 percent of Income on Housing, by Immigrant Status: Colorado and U.S., 2002-04





How much does it take to be economically self-sufficient in Colorado?


The federal poverty level for a family of three is \$16,600. The Colorado Fiscal Policy Institute estimates that a single-parent family with two young children needs two or three times that amount – from \$33,000 to \$44,000 annually, depending on local costs – to meet their basic needs without relying on government assistance.

The percentage of income needed to meet basic needs in two Colorado counties is detailed below. $\overset{7}{\ }$

• Children in immigrant families are substantially more likely to live in "crowded households," those that have more than one person per room of the housing unit.






Parental Education

- ✓ Parental educational attainment can affect many aspects of a child's well-being, including readiness for school and overall educational achievement. Children of more highly educated parents are more likely to attend an early childhood education program and are more likely to be read to daily by a family member. Sometimes parents who have graduated from high school contribute to their children's success simply by providing an environment that is conducive to studying.
- In Colorado, more than one-third of children in immigrant families live in families where no parent has completed high school.
 - Colorado has a higher percentage of children in immigrant families where no parent has a high school diploma, compared to the nation. In addition, the parent education gap between US-born and immigrant families is greater in Colorado than in the nation.

Children Whose Parents All Have Less Than a High School Diploma, by Immigrant Status: Colorado and U.S., 2002-04




HOUSING / PARENTAL EDUCATION

Language


- Fully one-third of Colorado children in immigrant families live in linguistically isolated households.⁸
 - Limited English proficiency remains one of the most critical challenges facing immigrant families. A lack of English skills impedes immigrants' ability to improve their employment prospects and increase their earnings. It also limits their ability to help their children prepare for and succeed in school.

Children Living in Linguistically Isolated Households by Immigrant Status: Colorado and U.S., 2002-04



In Colorado, 29 percent of children in immigrant families have difficulties speaking English, compared to less than one percent of children in U.S.-born families. Of note, children in immigrant families in Colorado are more likely to have difficulties speaking English than children in immigrant families nationally. Children who have difficulty speaking English face greater academic challenges in school than their English-proficient counterparts.

⁸ Definition: A household in which no person 14 years or older speaks only English and no person 14 years or older who speaks a language other than English speaks English "very well".

Implications for Children in Immigrant Families

Children in immigrant families face difficulties that are likely to result in poor educational and developmental outcomes. Of note, children in immigrant families are more likely to:



Have limited English language exposure and proficiency.

- In Colorado, a full one-third of children in immigrant families live in linguistically isolated households (no household member over 14 years of age speaks English "very well").
- Over 40 percent (88,000 children) of children in immigrant families have difficulty speaking English.

Live in poverty.

- In Colorado, half of all children in immigrant families live in families with incomes below 200 percent of the poverty threshold (\$33,200 annually for a family of three).
- A full 100,000 children in immigrant families live in families with incomes below the poverty threshold (\$16,600 annually for a family of three).

Have parents with low educational attainment.

- In Colorado, 156,000 children live in families where no parent has completed high school.
- This is more than one-third of children in immigrant families.

Changes in population and demographic trends mean more than just numbers – they mean real changes in the lives of children. In Colorado, it is clear that immigration is an issue that will be the focus of much attention in 2006. As policymakers and community leaders make decisions about issues with important implications for our children, the Colorado Children's Campaign will continue to gather research, track data and provide information as a resource and reminder of the young lives these decisions will affect.



School-aged population (number) Number of children 5 to 17 years of age provided by the Colorado Demography Section, Colorado Department of Local Affairs.

Births to women smoking during pregnancy (percent)

Births in which women reported smoking during pregnancy on infant's birth certificate per 100 live births provided by the Health Statistics Section, Colorado Department of Public Health & Environment. Please note that this data is most likely underreported on birth certificates across the state due to mothers knowing they shouldn't smoke during pregnancy.

Infant mortality (rate per 1,000)

Deaths during the first year of life per 1,000 live births provided by the Health Statistics Section, Colorado Department of Public Health & Environment.

Child deaths (rate per 100,000)

Deaths per 100,000 children age 1 to 14 in Colorado provided by the Health Statistics Section, Colorado Department of Public Health & Environment. Includes deaths from natural causes (such as illness or congenital defects) and injury (including motor vehicle deaths, homicides and suicides). Note: This indicator differs from KidsCount reports prior to 2001 to be more consistent with the Colorado Vital Statistics series of reports.

Teen deaths due to injuries (per 100,000)
