Dear Senator Moreno:

In accordance with C.R.S. § 25.5-6-409.3 (4), The Colorado Department of Health Care Policy & Financing (the Department) respectfully submits a quarterly report on the status of the redesign of a consolidated Home and Community-Based Services (HCBS) waiver for Adults with Intellectual and Developmental Disabilities (IDD).

Since the October 2018 update, the Department has held stakeholder meetings, developed full drafts of all proposed wavier services, and has been analyzing the fiscal impacts of a consolidated waiver.

The Department benefits from stakeholder input on the development and implementation of a consolidated waiver. Over the last two years, the Department has primarily engaged stakeholders through the Waiver Implementation Council's (WIC) representative membership. In October, the Department and the WIC agreed to expand the stakeholder process to more directly engage the statewide stakeholder community. The Department then met with stakeholders over meetings in October and November. Over these meetings, the Department and stakeholders reviewed services and discussed fiscal analyses. Background information and meeting materials are available on the waiver redesign stakeholder website.

To date, the Department has drawn from stakeholder guidance to develop full drafts of all proposed services, including service and provider specifications, conditions of coverage, and associated processes. The Department, in turn, has been drawing from its service design and previous fiscal analyses to establish needs-based service limits and estimate costs for the consolidated waiver.
