THE MEDICAID MANAGEMENT INFORMATION SYSTEMS ROLL-FORWARD AUTHORITY

JANUARY 2, 2015

The Department of Health Care Policy and Financing rolled forward FY 2013-14 funds appropriated for the purpose of administering the Medicaid Management Information System (MMIS). This roll forward request has express legislative intent per 25.5-4-211 C.R.S. (added to statue by HB 13-1281). This statute requires the Department to report to the Joint Budget Committee regarding the roll forward by January 2nd of each year. This report is intended to fulfill this requirement by stating below the amount which the Department rolled forward from FY 2013-14 to be available in FY 2014-15 and the purpose for which the funds are being used.

MMIS Maintenance and Projects

The roll forward funds are being used to implement several MMIS system change projects that were not completed in FY 2013-14. These projects are the federally-mandated implementation of ICD-10 medical coding, the federally-mandated change to Health Care Claim Payment and Remittance Advice electronic transactions (EDI 835 transactions), the joint implementation of SB 13-242 "Medicaid Adult Dental Benefit" and the Department's FY 2013-14 R-9 Budget Request "Dental ASO," and the implementation of changes for SB 13-200 "Expand Medicaid Eligibility."

MMIS Reprocurement Contracts

The roll forward funds are being used to pay for a deliverable from the Department's Independent Verification and Validation (IV&V) vendor that was not completed in FY 2013-14. Furthermore, the Design, Development, and Implementation (DDI) contracts related to the Department's Reprocurement of the new MMIS were executed later than originally anticipated under the original budget request, thus shifting funding for the contracts into later year and necessitating a roll forward. The Department is truing up this line item in the Department's FY 2014-15 S-7, BA-7 "MMIS Adjustments."

MMIS Reprocurement Contracted Staff

The roll forward funds are being used to pay for the Department's contracted staff related to the implementation of the Department's new MMIS. The contracted staff were brought on later than originally anticipated under the original budget request, thus shifting the expenses into later years and necessitating a roll forward funding. The Department is truing up this line item in the Department's FY 2014-15 S-7, BA-7 "MMIS Adjustments."
