The Department of Health Care Policy and Financing rolled forward unspent FY 2016-17 funds appropriated for the purpose of administering the Medicaid Management Information System (MMIS). This roll forward has express legislative intent per Section 25.5-4-211, C.R.S. (added to statute by HB 13-1281). This statute requires the Department to report to the Joint Budget Committee regarding the roll forward on or before January 1st of each year. This report is intended to fulfill this requirement by stating below the amount of funds rolled forward from FY 2016-17 to FY 2017-18 and the purpose for which the funds are being used.

The roll forward funding will be used in FY 2017-18 primarily for costs related to the continued enhancements, design and development of systems in the Department's new MMIS which was implemented on March 1, 2017. This has been a multi-year project involving multiple vendors for the core MMIS (otherwise referred to as "Colorado interChange"), the Business Intelligence Data Management (BIDM) system, and the Pharmacy Benefits Management System (PBMS) and is now in the operational stage of the system. The MMIS Information Reprocurement Contracted Staff line item was eliminated in the FY 2017-18 Long Bill. FY 2017-18 is the final year of the MMIS Reprocurement Contracts line item.
