Policy clarification for injectable drugs Practitioners and/or clinics

- Injectable drugs given in a practitioner's office or clinic must be billed by the practitioner using HCPCS codes on the CO-1500 claim format.
- According to State policy (Volume 8, 8.831), pharmacies cannot bill for injectable drugs given in a practitioner's office.
- By State policy, practitioners may not send clients to pharmacies to get injectable drugs for use in the practitioner's office.

Pharmacies

- Injectable drugs, intended for self-administration or use in the client's home, must be billed by the **pharmacy** through PDCS.
- The exception to the above is allergen extracts (for selfadministration or use in the client's home). Allergen extracts may be provided by the practitioner and billed on the CO-1500 claim format.

Prescription drugs

The **prescriber** must telephone the prescription drug PAR to the Prescription Drug Card System (PDCS) at:

Supply/DME

Do **not** call PDCS to request prior authorization for *supplies or DME*. Submit PARs for supplies and DME electronically through WINASAP. Some services may require paper claim submission to the authorizing agent.

Drug and supply/DME claims

With few exceptions, Colorado Medicaid claims must be submitted electronically.

Paper claims

Some prescription drugs or supplies must be submitted on paper claims, such as new drugs with miscellaneous CPT coding. Submit these claims with an invoice showing acquisition costs. Generally, the following claims will be processed for payment on paper:

- Claims that, by policy, require attachments
- Claims from providers who consistently submit fewer than ten claims per month
- Claims for dates of service more than 365 days old
- Reconsideration claims
