Nursing Facility Prior Authorization Verification Tips

Bulletin B0000060 instructed providers to contact the Colorado Foundation for Medical Care (CFMC) if their claim(s) denied in error for no prior authorization on file. If the provider has a copy of the certified ULTC 100 from CFMC, the fiscal agent can correct the problem. The ULTC 100 must contain a legible client State ID number. The ULTC 100 can be faxed to the fiscal agent and entered into the Medicaid claims processing system. Please follow the steps below to expedite this process:

- Make a legible copy of the certified ULTC 100 from CFMC.
- Complete a fax cover sheet with the Provider facility name, phone number and contact name. Clearly indicate on the fax cover sheet. "Attn: Diane Backen - Edit 500 issue".
- Fax the cover sheet and ULTC 100 to:

Please note that this process only applies to ULTC 100s that relate to the prior authorization edit issue. Remittance statements will not be accepted in place of the ULTC 100. Providers must submit faxes by May 31, 2000. Effective June 1, 2000 providers must call the Medicaid Prior Authorization Unit at 303-534-0279 or 1-800-237-7647 (toll-free Colorado).
