### Billing instruction update for Ambulatory Surgery Centers (ASCs)

The Colorado Medicaid Program provides benefit for medically necessary Ambulatory Surgery Center (ASC) services and accommodations. Medicaid enrolled ASC providers must be Medicare certified. The Colorado Department of Health Care Policy and Financing (HCPF) is responsible for identifying surgical procedures that are authorized for performance in the ASC setting.

For payment purposes, ASC surgical procedures are grouped into reimbursement categories. The Colorado Medicaid program recognizes eight categories defined by the Centers for Medicare and Medicaid Services (CMS), formerly the Health Care Financing Administration (HCFA), and published by Medicare. Medicaid uses HCFA's Common Procedural Coding System (HCPCS) to identify surgical services. HCPCS includes all of the codes published in the American Medical Association's (AMA) Current Procedural Terminology (CPT). The AMA and CMS publish annual coding revisions. Medicaid bulletins notify providers when annual coding updates are adopted.

### Procedural coding

**Services must be reported using HCPCS surgical procedure codes.** During claim processing, the surgical HCPCS code is related to the appropriate ASC group for payment calculation.

### ASC authorized services

This bulletin contains a complete combined list of the CMS approved ASC procedure codes and the Medicaid approved ASC procedure codes effective 12/01/2001. The list is divided into the applicable payment groups. Medicaid specific codes are identified with an asterisk (\*). Surgical procedure codes that are not identified on the Medicare list and/or are not published in Medicaid Bulletins are not a Medicaid benefit when performed in an ASC setting. Revisions (additions and deletions) to the ASC reimbursement categories may occur in the following ways:

1. To address the needs of Medicaid clients, HCPF adds procedure codes for services commonly provided to children and young adults. Authorized procedure codes and effective dates are published in Medicaid Bulletins.
2. Codes that are deleted during the annual CPT and CMS coding updates are also deleted from the ASC groupings when the annual HCPCS revision is implemented. Medicaid Bulletins announce the date of the HCPCS implementation each year.
3. Medicare ASC changes (deletions and additions) are adapted by the Medicaid Program only when published in Medicaid publications.

## Reimbursement

For payment purposes, ASC surgical procedures are grouped into eight categories corresponding to the CMS defined groups. The Medicaid maximum allowable payment, by group, effective 07/01/2001, is as follows:

ASC GROUP 1	\$258.40	ASC GROUP 5	\$556.80
ASC GROUP 2	\$346.40	ASC GROUP 6	\$644.80
ASC GROUP 3	\$396.00	ASC GROUP 7	\$772.80

## Medicaid payment calculation

Providers are reminded that submitted charges must represent usual and customary charges. Do not adjust charges to correspond to the anticipated Medicaid payment.

Medicaid providers agree to accept Medicaid reimbursement as payment in full for benefit services. Medicaid clients may not be billed for charges that exceed the Medicaid allowance. Medicaid payment is calculated as the provider's billed charge or the HCPF established rate for the group, *whichever is less*.

## Multiple procedures

When multiple procedures are performed during the same session, the ASC claim should reflect the highest/most complex procedure. Additional payment is not available for multiple procedures performed at the same surgical setting.

## Medicare crossover payment

Medicaid payment for Part B Medicare crossover claims is made as follows:

1. The sum of reported Medicare deductible and coinsurance **or**
2. The Colorado Medicaid allowed benefit **minus** the Medicare payment, *whichever is less*. Third Party liability payments and Medicaid copay amounts, as applicable, will be subtracted after the crossover allowed payment has been determined.

If the amount paid by Medicare equals or is greater than the Medicaid benefit for the billed service on a Part B crossover claim, no additional payment will be made by Medicaid. This method of determining payment is commonly referred to as "lower-of-pricing".

Note: Except for applicable Medicaid copayment amounts, unpaid balances cannot be billed to the Medicaid client or the client's family.

## Services included in the ASC rate

The following services are included in ASC facility payment rate:

1. Nursing and technical personnel services
2. Accommodations/use of the ASC facility
3. Drugs, biologicals, surgical dressings, supplies, etc.
4. Diagnostic and therapeutic items and services
5. Administrative, record keeping and housekeeping services
6. All blood products (whole blood, plasma, platelets, etc.)
7. Anesthesia materials

## Services which may be billed separately

The following services/items are not included in the ASC rate and may be billed separately by the actual provider of services.

1. Professional fees (surgeon, assistant surgeon, anesthesia administration, etc.). Professional services must be billed by the practitioner.
2. Sale, lease or rental of durable medical equipment for use in the patient's home. Claims must be submitted by the medical supplier and, when applicable, prior authorization must be obtained.
3. Surgically implanted prosthetics. Specified, authorized implantable prosthetics may be billed separately on the CO 1500 claim format by the actual provider of the materials (ASC or surgeon).
4. Ambulance services. Benefit services are billable by the transportation provider.
5. Independent laboratory services. Services must be billed by the laboratory.

## Billing procedures

ASC facility claims are submitted on the Colorado 1500 claim format. Claim completion instructions are described in the Colorado 1500 and ASC Specialty Medicaid Provider Manuals. The following instructions supplement the provider manual and are specific to ASC claims for facility services. The information is not applicable to other provider types.

ASC claims may be submitted electronically. Electronic claims submission reduces billing expense and claims processing turnaround time. Information about electronic claims submission may be obtained from the ACS Electronic Data Interchange (EDI) Support at 1-800-987-6721, Monday through Friday from 6 AM to 5 PM Mountain Time.

**Procedure codes:** ASCs identify services using HCPCS surgical procedure codes. During claim processing, the surgical code is related to an appropriate ASC group for payment calculation.

The actual provider of the materials must bill implantable prosthetics. The following HCPCS codes are approved for billing by the ASC or the surgeon on the CO 1500 claim format:

- L8612 Aqueous shunt
- V2630 Intraocular lens, anterior chamber
- V2631 Intraocular lens, iris supported
- V2632 Intraocular lens, posterior chamber
- V2785 Processing, preserving and transporting corneal tissue
- L8642 Hallux Implant Prosthesis
- Q1001 New technology intraocular lens category 1 as defined by Federal Register notice
- Q1002 New technology intraocular lens category 2 as defined by Federal Register notice
- Q1003 New technology intraocular lens category 3 as defined by Federal Register notice
- Q1004 New technology intraocular lens category 4 as defined by Federal Register notice
- Q1005 New technology intraocular lens category 5 as defined by Federal Register notice

## Billing information

The ASC is responsible for obtaining required billing information from the surgeon. ASC providers are urged to verify Medicaid eligibility before services are rendered. If eligibility is not verified, payment may be denied.

**ICD-9-CM diagnosis:** The diagnosis field(s) must be completed with an appropriate ICD-9-CM diagnosis code(s).

**Place of service:** Complete the Place Of Service (POS) field with a "5" for ASC facility charges.

*Note:* Electronic billers should consult the software instructions to assure that POS coding is submitted properly.

**Rendering provider:** Complete with the 8-digit Medicaid provider number assigned to the operating surgeon.

**Referring provider:** If the client is enrolled in the Primary Care Physician (PCP) program and the operating surgeon is not the PCP, the PCP's Medicaid provider number must be entered in this field. PCP enrolled clients must obtain PCP referral if surgical services are performed by a physician other than the PCP. If the client does not have an assigned PCP, this field may be left blank.

*Sterilization procedures:* All sterilization claims must have an attached copy of a properly completed MED-178 sterilization consent form. The surgeon is responsible for providing a copy of the MED-178 to the ASC. Claims without a properly completed MED-178 are denied.

**Medicare crossover claims:** Medicaid pays the Medicare deductible and coinsurance **or** the Medicaid-allowed benefit minus the Medicare payment, **whichever is less**. If Medicare's payment equals or is more than the Medicaid allowed benefit, crossover claims are paid at zero.

Most Medicare crossover claims are transmitted electronically from Medicare to Medicaid. If a Medicare claim does not cross automatically, the provider is responsible for submitting a "hardcopy crossover" claim on the CO 1500 claim format. Refer to the provider manual for completed hardcopy crossover claim preparation instructions.
