## Breast and Cervical Cancer Program (BCCP)

The Breast and Cervical Cancer Program (BCCP) will be implemented July 1, 2002. BCCP was established by the Breast and Cervical Treatment Act of 2000 and authorized by Senate Bill 01S2-012 allowing presumptive eligibility and full Medicaid benefits.

The Department of Public Health and Environment's Colorado Women's Cancer Control Initiative (CWCCI) and the Department of Health Care Policy and Financing will coordinate benefits to reduce breast and cervical cancer mortality.

This new program is for women:

- Meeting eligibility requirements
- Screened at a CWCCI site
- Found to have breast or cervical cancer treatment needs including pre-cancerous treatment needs

### BCCP eligibility/screening requirements

1. Be a woman who has not yet attained age 65
2. Be a resident of Colorado
3. Be a citizen of the United States or a qualified alien
4. Meets the income requirements (at or under 250% poverty level)
5. Has not had a mammogram or Pap test within the past 12 months
6. Has been screened and found to be in need of treatment for breast and cervical cancer including pre cancerous conditions
7. Has received screening from a CWCCI site
8. Has no other creditable coverage including qualifying for Medicaid under other eligibility groups.

Clients eligible for BCCP are exempt from enrollment in managed care programs.

The BCCP coordinator will contact women who are eligible for BCCP. The BCCP coordinator's duties include:

- Monitoring the status of each client through case management;
- Determining with the client's physician if the client is in need of and/or receiving treatment;
- Evaluating clinical and claims data; and
- Notifying county eligibility, the physician, and the client at the time of disenrollment.

### Presumptive eligibility

Presumptive eligibility allows the woman to enroll in Medicaid for a short time before a Medicaid application is received and processed. Both the presumptive eligibility form and Medicaid application are filled out at the CWCCI site. A temporary Medicaid card for the BCCP allows full Medicaid benefits. This insures access to this program and immediate treatment.

Medicaid benefits include but are not limited to:

- Medicaid providers of acute inpatient services,
- Physician office visits,
- Laboratory and radiological services,
- Outpatient services,
- Prescription drugs,
- Long term care, including hospice and
- Reconstructive surgery if performed at the time of mastectomy.

Certain services require prior authorization as described in the Medicaid billing instructions and manuals published by the Fiscal Agent.

A copy of the BCCP Medicaid card and the designated CWCCI sites are included with this bulletin.

### BCCP Medicaid card

- ★ The eligible person is authorized to receive Medicaid benefits.
- ★ The expiration date may be extended if Medicaid eligibility has not been determined. After the expiration date, you must call Medicaid Fiscal Agent Provider communications for eligibility determination at 1-800-237-0044 or 303-534-3500 (Denver area).
- ★ The person named on this card has made application for Medicaid. Presumptive Eligibility provides temporary Medicaid coverage while the application is being processed.
