Dear Honorable Representative Vigil,

State statute requires the Colorado Commission on Higher Education (CCHE) to review institutions of higher education’s Two-Year Cash Funded Lists for capital construction projects exceeding two million dollars that are acquired or constructed solely from cash funds held by the institution (C.R.S.§ 23-1-106 (7)). The Commission is also required to review Five-Year State Funded Capital projection lists submitted by the institutions’ Governing Boards (C.R.S.§ 23-1-106 (6)).

The Two-Year Cash Funded Capital Construction Lists and the Five-Year State Funded Capital Lists for the following institutions were approved by the Commission at their December 5, 2014 meeting:

- Colorado State University – Fort Collins
 - Biology Building (Intercept) - \$81,596,432
