Colorado Resident and Non-Resident Student Enrollment

This report is prepared by the Colorado Department of Higher Education Pursuant to CRS 23-1-113.5 (4) (a) and (d) and provides a snapshot of resident and non-resident student populations at Colorado public institutions of higher education

Colorado strives to create a learning environment that promotes rich cultural diversity. However, the state also has a responsibility to primarily serve and education Coloradans. To strike a good balance, the Colorado General Assembly has recommended a set of limits to which Colorado's public institutions can admit resident and non-resident students. By creating policies based on this recommendation, the institutions have drawn top students from within and outside Colorado, enabled them to benefit from the resultant rich cultural diversity, and generated additional revenue.

CRS 23-1-113.5 sets several different thresholds for non-resident enrollment based on three different cohorts. For Fall incoming freshman, up to 45% of the incoming class can be non-resident. For the total student population as calculated by FTE (full-time equivalent), up to 33% of the student population can be non-resident (for the University of Colorado institutions, Colorado State University, Colorado School of Mines, and the University of Northern Colorado, this percentage is 45%). For Fall enrollment of foreign students, up to 15% can be foreign. Additionally, these percentages are calculated on a three-year rolling average.

Colorado statute allows several student populations to be excluded from these calculations and for institutions to receive added resident counts. These allowances provide further flexibility to Colorado campuses to enroll non-resident students. Due to these provisions allowed by statute, the resident and non-resident population proportions presented in this report do not fully summarize the entire student enrollment at Colorado public postsecondary institutions. A more detailed explanation of each these cohorts and the calculations used to assess statutory compliance can be found in the Methodology section below.

CRS 23-1-113.5 (4) (b) requires the University of Colorado and Colorado State University to report to the Colorado Commission on Higher Education information demonstrating that qualified in-state students are not displaced or denied admissions and that any increase in the enrollment of foreign students at the University of Colorado System or at Colorado State University is a result of increased capacity at the campuses. Additionally, CRS 23-1-113.5 (4) (d) requires institutions to demonstrate that academic admission standards for students who do not have in-state status are equal to or exceed those established for determining admission of in-state students.

Methodology

Percentage of Fall incoming freshmen classified as in-state

Per CRS 23-1-113.5 (4) (a) (I), the percentages of Fall incoming freshmen at each campus who are in-state students are presented for three years. These data are used to calculate a three-year rolling average. Incoming freshmen are defined as first-time, degree-seeking undergraduate students taking resident instruction hours. Pursuant to CRS 23-1-113.5 (4) (a) (I), foreign students are excluded. Additionally, all Native American students at Fort Lewis College are excluded due to Fort Lewis College's unique mission in serving Native American students and its participation in the Native American Tuition Waiver program. Percentage of total students enrolled classified as in-state (by FTE)

Per CRS 23-1-113.5 (4) (a) (II), the percentages of in-state students enrolled at each campus are presented for three years. From these data, a three-year rolling average is calculated. For these percentages by FTE calculations, undergraduate and graduate students taking resident instruction hours are identified. These populations are presented as FTE using the Colorado Commission on Higher Education (CCHE) FTE policy for calculating FTE (30 credit hours is equal to one undergraduate FTE and 24 credit hours is equal to one graduate FTE). Per CRS 23-1-113.5 (4) (a) (II), foreign students and students enrolled solely in online courses are excluded. Additionally, all Native American students at Fort Lewis College are excluded due to Fort Lewis College's unique mission in serving Native American students and its participation in the Native American Tuition Waiver program. Percentage of Fall enrollment for US resident and foreign students

This report also provides the percentages of the Fall enrollment classified as US residents and foreign at each Colorado public postsecondary institution for the past three years (as required by CRS 23-1-113.5 (V)). A chart visualizing US resident and foreign student data can be found on page 5.

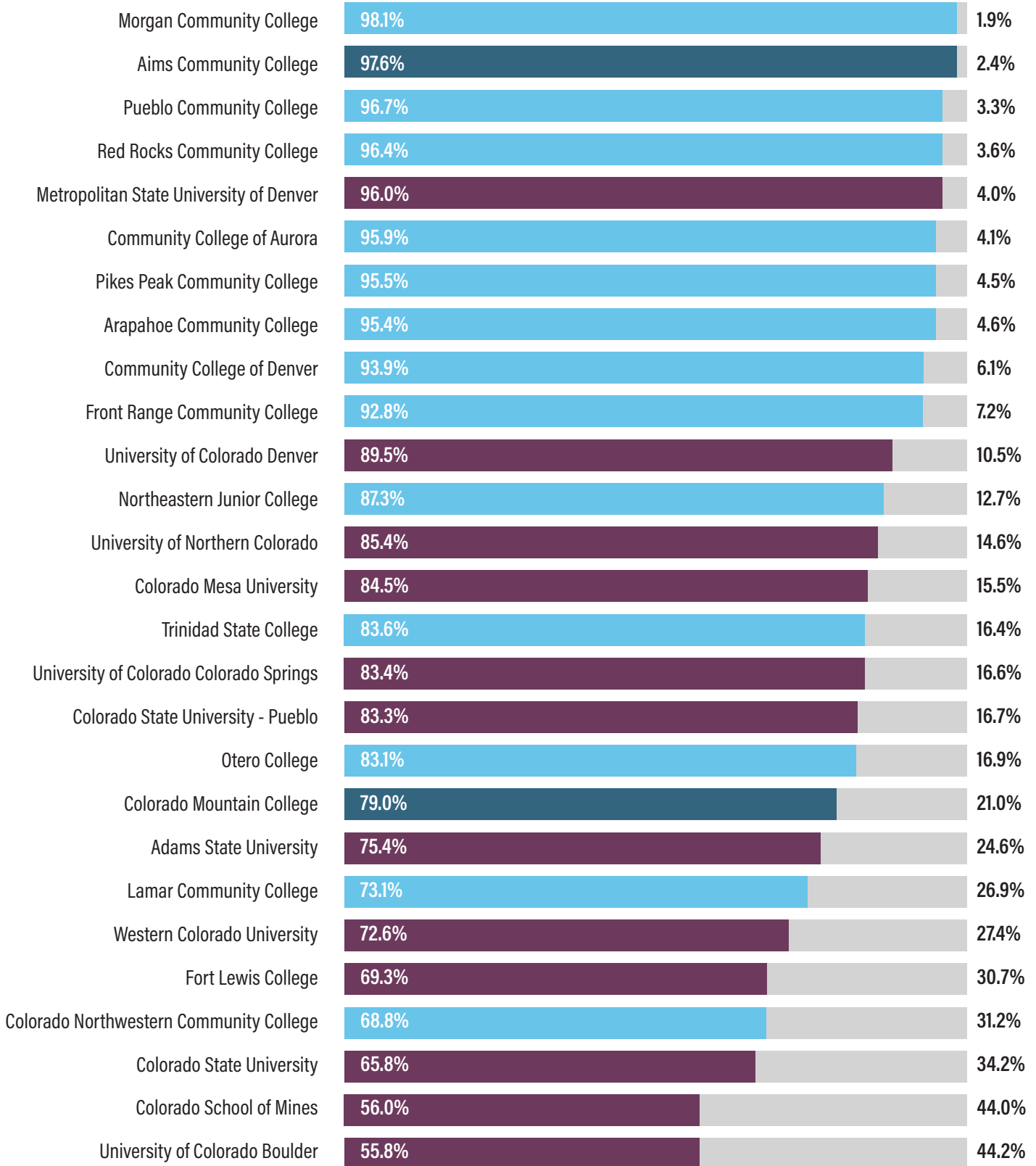
Colorado Scholars

Per CRS 23-1-113.5 (5) (a), a student identified by Colorado public postsecondary institutions as a Colorado Scholar as defined by CRS 23-1-113.5 (5) (e) (I) is counted as two in-state students. This is reflected in the percentages for each year and the three-year rolling averages.

Percentage of Fall incoming freshman classified as in-state

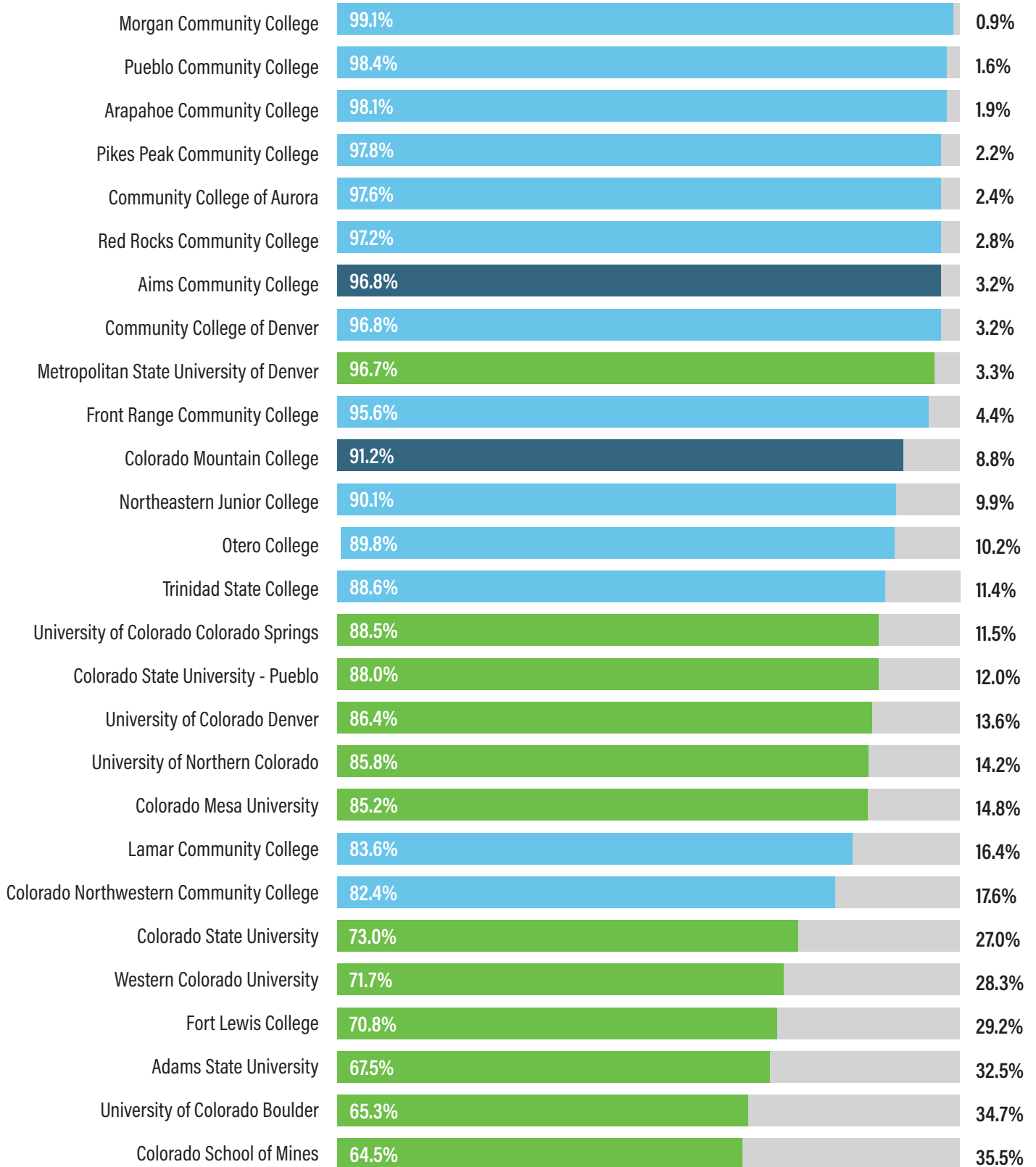

Percentage of Fall enrollment for US resident and foreign students

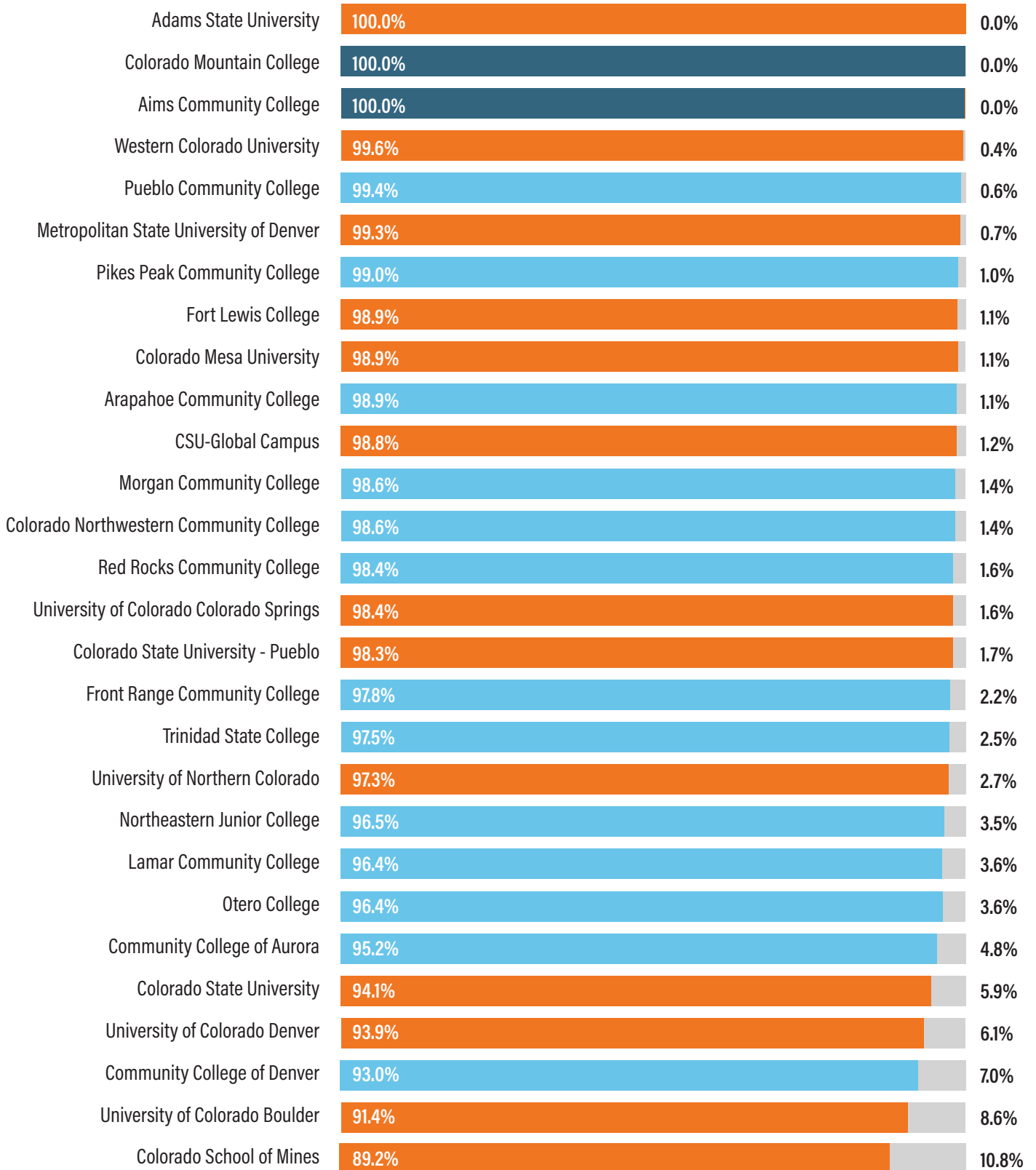
