Letter from the Colorado Historical Society's Chairman of the Board and the President

The 1990 Constitutional Amendment authorizing limited stakes gaming in three historic mining towns launched the State Historical Fund (SHF) in Colorado, which disburses a portion of the taxes generated from annual gaming revenues as grants for historic preservation and preservation education. This program has since become the envy of other states and serves as a model for programs around the country because of its impact on communities in Colorado.

The Merriam-Webster dictionary defines “community” with a series of definitions that each include the thread of a unified body of individuals with common interests—groups of people living in a common area, or having common characteristics such as history, social, economic or political interests.

Using any of the definitions above, the State Historical Fund grants have made an impact on each of these discretely defined communities in Colorado. Geographically, you can see the impact the grants have had on *Colorado as a whole* through the grants for the State Capitol building's Life-Safety Project, as well as through grants to establish the state-wide program to bring heritage tourists to Colorado. Using another definition, if you look at specific *local communities*, you can see the impact of the thousands of grants on buildings restored and programs started in rural towns and metropolitan areas throughout Colorado. Likewise, if you look at the *economic impact*, people across the state interested in generating jobs and stimulating the economy, you see gatherings such as those at the ribbon cutting at the new Kit Carson County Carousel Museum in Burlington. This was a county-wide celebration of citizens and visitors anxious not just to see the new museum, but the enhancement of a tourist and local revenue-producing venue that attracts people to this rural community. Finally, if you use Webster's “community” defined by those with a *common interest*, you again can see the results of SHF grants through a project such as the

Riverside School in Grand Junction that brought people together to revitalize and reuse an important historic resource in their community for the benefit of children and adults. Each of these “community” groups is separately defined, yet all of them have been helped by the State Historical Fund and its grants.

It takes a carefully established and well tested process to administer grants to such a wide audience. This process also serves as a model for other programs—beginning when SHF staff members assist applicants during the application process. As grants are received, they then assemble teams of reviewers in addition to the staff themselves to assure that a complete and professional recommendation is given to the Colorado Historical Society Board of Directors. As you can imagine, with more than \$192 million awarded by this program since the first grant in 1992, there is tremendous interest and competition for

the resulting program benefits. It takes a complex process to ensure all these communities of Colorado applicants are well served by the State Historical Fund. We are proud of the results achieved by the Fund. We invite you to see the benefits of the program in fiscal year 2007 through this Annual Report.

Letter from the Director of the State Historical Fund

I believe that most preservationists are happiest when members of a community use important historic places in the course of their daily lives. Perhaps they bank in an historic bank building, catch the bus at a former train depot, live in a loft in a converted warehouse, or worship in an historic church or synagogue. It may be that they don't always look up and wonder at the beauty of the places they use, but they, and the other members of their community, come together in these places and give them new meaning. When the use continues an historic use, there is a connection that binds them with their predecessors. Perhaps as long as a century ago someone else stood at that teller's cage hoping to get the loan that would start them out on a new life, walked through that waiting room en route to a visit with a loved one, piled supplies up against that brick wall before delivering them by wagon to a local retailer, or sat in that pew and prayed in thanks for the health of a child. Historic places can provide a remarkable connection to the past when used by people as more than just static, empty spaces.

This year, the State Historical Fund's annual report will tell you just a few of the stories associated with community projects supported by the Fund. In Burlington, the Kit Carson County Carousel spins again because of the perseverance of the members of that community. In Colorado Springs, the old Colorado City Carnegie Library will continue to serve its community after a complete interior and exterior restoration and rehabilitation project. The Romero House in Fort Collins tells the story of Northern Colorado's Hispanic community. In the former company town of Louviers, the bowling lanes will soon be open again and the community center will welcome events of all kinds, while the Riverside School in Grand Junction houses a community center, an after school tutoring program, school lunchroom, and library. In southern Colorado a unique effort to involve community members in stewardship of historic and prehistoric sites has inspired a national program. In Eads, high school students and recent graduates

are making the effort to rebuild their community through preservation projects that would provide new uses in abandoned commercial buildings. And in Granada, high school students are teaching us all about the lessons learned from the Japanese internment at Camp Amache during WW II, and the unique community that existed there.

All of these stories are inspiring. And yet they are only a few of the thousands of projects that have been assisted by grants from the State Historical Fund. For every story you read, remember that there are hundreds more, probably some just a few blocks away from where you're standing.

You'll also read about our progress with the State Capitol Life-Safety Project, our continuing support for the state's heritage tourism efforts, the latest on our partnership with the National Trust for Historic Preservation and Channel 9 with the new season of Explore Colorado, and get an update on the New Deal survey project being carried out by Colorado Preservation, Inc. on the eastern plains.

Of course there's always more to be done. And as the face of Colorado changes with population growth and land use issues, it's likely that more and more of the Fund's attention will be drawn toward efforts to retain the sense of community that we value so highly. We welcome this challenge, and hope that by preserving Colorado's important historic places we can help to protect a culture that is unique to the west.

State Historical Fund—Fiscal Year 2007

Establishment of the SHF

The State Historical Fund was created by Colorado voters through the passage of the 1990 constitutional amendment legalizing limited-stakes gaming in Black Hawk, Central City, and Cripple Creek. The amendment decreed that 22.4% of the state tax revenue generated by gaming activity would be used for historic preservation efforts around the state. Subsequent legislation placed these funds under the guidance of the Colorado Historical Society, which administers the State Historical Fund grant program.

In 1993 the State Historical Fund awarded its first grants. Since then hundreds of structures and sites in communities around the state have been saved and interpreted for future generations.

During fiscal year 2007 the SHF awarded approximately \$17 million through 166 grants (see Program Statistics on page 5), bringing the total number of projects funded over the past fourteen years to more than 3,100 and the total amount awarded to over \$192 million.

This year's annual report highlights the Fund's impact on communities throughout the state. These projects include the 30-year-long restoration of the Kit Carson County Carousel in Burlington, the restoration of the Romero House in Fort Collins, which brought diverse interests together to preserve the history of Hispanics in Larimer County, the efforts of students in the Southeast and volunteers in the Southwest to sustain their historic resources, the creation of community gathering places in Louviers and Grand Junction, and the planned completion of the Old Colorado City Carnegie Library project in Colorado Springs.

The report also includes an update on the SHF's continued support of the State Capitol Life-Safety Project and the Colorado Tourism Office's Heritage Tourism Program, SHF's partnership with KUSA television (Channel 9 in Denver) and the National Trust for Historic Preservation to present Explore Colorado, and a summary of Colorado Preservation, Inc.'s cultural resource survey of New Deal sites in the eastern plains counties.

The projects funded by the State Historical Fund represent a broad scope of projects that enhance the experi-

ence of visitors to, and residents of, our diverse communities. The Colorado Historical Society, through the Fund, is proud to support the efforts of these and other communities across the state to maintain our heritage, improve the quality of life in our state, and share our stories with visitors.

SHF Program Guidelines

Because SHF grant funds are intended for public benefit, only public entities and nonprofit organizations may apply directly for SHF grants. However, private individuals, businesses, and federal agencies may participate in SHF projects by partnering with a state or local public entity or nonprofit organization willing to apply for, and administer, a grant on their behalf. Projects involving restoration, rehabilitation, and archaeological excavation require properties be officially designated on the State Register of Historic Properties, the National Register of Historic Places, or through a local landmarking program.

Grants are available in three categories: **General Grants** are accepted twice yearly and include applications for historic preservation funding in any amount; **Historic Structure Assessment Grants** and **Archaeological Assessment Grants** are noncompetitive grants of \$10,000 or less, provided for the sole purpose of preparing a professional architectural or archaeological assessment of a site in order to help property stewards plan future historic preservation efforts; and **Emergency Grants** provide assistance for historic resources damaged through sudden and unexpected events.



Community Perseverance— The Kit Carson County Carousel in Burlington

Community members in Kit Carson County, through the Kit Carson County Carousel Association, have spent the past thirty years restoring the Kit Carson County Carousel. Their persistence, and \$2.5 million, has resulted in this one-of-a-kind National Historic Landmark carousel drawing visitors to eastern Colorado from all over the country.

Originally built for Denver's Elitch Gardens in 1905 by the Philadelphia Toboggan Company, the carousel features a menagerie of 46 hand-carved animals, including giraffes, zebras, and lions, as well as horses clad in trappings reminiscent of the Napoleonic War. It is the only carousel in the nation with a working 220-pipe Wurlitzer Monster Military Organ, the only surviving menagerie carousel manufactured by the Philadelphia Toboggan Company, and is the only antique carousel in America with its original paint on both the scenery panels and the animals.

When Elitch's bought a more modern carousel in 1928, they sold the old one to Kit Carson County for \$1,200. The Great Depression ensued, and Kit Carson County suspended its annual fair; the carousel spent six years standing motionless in a storage hangar, half-buried in government-surplus cornstalks. Rodents and birds took up residence, destroying the mighty Wurlitzer and gnawing wounds into the animals' painted hides.

The carousel finally began running again in 1937 and limped along until the mid-1970s. Preservation efforts began in 1976 and have included the restoration of the Wurlitzer Monster Military Band Organ, 45 original oil paintings, and the animals themselves. Replicas of the original valances were reconstructed, a park was created around the carousel, and the building that houses the carousel was restored.

While the restoration of the carousel itself was completed in 2001, the Association continued its efforts to enhance the experience of visitors to this landmark. In June 2007 they opened an exhibition in an adjacent building that tells the story of the carousel and the restoration efforts. The State Historical Fund has awarded grants of nearly \$500,000 toward the Carousel's restoration and interpretation.

"Restoring the carousel has been a massive 30-year project that could not have been completed without the commitment of the people in the Carousel Association and the help of the State Historical Fund," said Jo Downey, Project Director for the Kit Carson County Carousel Association.

The Association carried out a number of creative fundraisers over the years to match SHF funds, including a "slumber party" at the newly-opened prison in Burlington in 1998. "We have begged and borrowed, but we never stole," says Jo Downey, "It has all been worth it because now the Carousel is a heritage tourism anchor in eastern Colorado."

On Feb. 7, 2007, Governor Bill Ritter presented the Association with the Colorado Historical Society's annual *Governor's Award for Historic Preservation* in honor of this community's long-term efforts to restore and interpret this important and unusual site.

"The [award] is well-deserved by the people of the Kit Carson County Carousel Association because of their commitment to the project, every step of the way," says Mark Wolfe, director of the State Historical Fund and Colorado's deputy state historic preservation officer. "We are proud to have been able to help preserve this delightful attraction for future generations."

Bringing Communities Together— The Romero House in Fort Collins

In the 1990's the residents of the Tres Colonias neighborhood of Fort Collins (Alta Vista, Buckingham, and Andersonville) battled a ballot initiative that would have relocated a truck route through their neighborhood. Winning that fight galvanized members of the community and spurred discussion of ways to protect the neighborhood in the future. One suggestion was to increase awareness of the important contribution this primarily Hispanic, working class neighborhood had made to the history of Fort Collins by restoring a historic property as an interpretive center, or Museo.

The restoration of the Romero House began a couple of years later when members of the Poudre Landmark Foundation (PLF) and the Tres Colonias neighborhood—including Joan Mangle, Virginia McMillan, Sally Ketcham, Margaret Guzman, and Betty Aragon-Mitotes—decided to identify a project that could be embraced by members of the Tres Colonias and historic preservation communities. Karen McWilliams of the City of Fort Collins' Historic Preservation Office was consulted and she informed the group that the historic adobe home of the Romero family was for sale.

Talks began with the Romero family and the developer of a big-box project, who had expressed to members of the neighborhood a desire to give back to the community. The developer purchased the house from the Romeros and donated it to the City of Fort Collins for use as an interpretive center to highlight Hispanic life and culture in the Fort Collins area. As with other PLF projects the city then leased the property to PLF who created an auxiliary group, Museo de las Tres Colonias, to carry out planning, fund-raising, and restoration activities. The founding members of the Museo project saw the museum, "...as a gateway to educate the community and others about Hispanic life and culture, starting with the early Hispanic pioneers who came to Fort Collins in the early 1900s and acknowledging their contributions to the city." They believed the Museo would be an asset to the community as a whole and stand as a symbol of pride for the Fort Collins Hispanic community.

"I am extremely grateful to everyone who has worked on this project; we have really wonderful people who have given so much of their time to help make a dream come true." says Betty Aragon-Mitotes, a founding member of the Tres Colonias group.

John Romero, a leader in the Hispanic community, built this four-bedroom adobe house between 1927 and 1935. He and his wife, Inez Rivera Romero, raised their seven children here and members of the Romero family continued to live in the house until May 2001.

The house is a rare example of adobe construction in northern Colorado and reflects the building traditions early New Mexican migrants brought to Larimer County. The house expresses the skills of these migrants in building adaptable, inexpensive, yet sound and long-lasting structures in a short period of time. Open to the public as of September 2006, the Museo recognizes the importance of the sugar beet industry to the development of Fort Collins, and of the immigrants and migrant workers who made that industry possible. This community restoration project tells the story of the life of Hispanic families between 1927 and 1940 through the interpretation of its construction materials and methods, as well as artifacts and exhibits.

The State Historical Fund provided three grants to the PLF. These included funding to conduct a Historic Structure Assessment of the house and an Archaeological Assessment of the site, as well as \$201,396 for restoration of the house itself.

In May 2007 the Poudre Landmarks Foundation and its auxiliary group Museo de las Tres Colonias were honored by Colorado Preservation, Inc. with a State Honor Award, and by the City of Fort Collins with a Friends of Preservation Award.

Communities Working Toward Sustainable Solutions

Youth Promoting Historic Preservation in Southeast Colorado

Citizens in the southeastern part of the State are working hard to preserve their heritage and use historic preservation as an economic development tool. From planning for restoration of city parks in La Junta and Lamar, to a regional heritage tourism project, preservation professionals and government officials are searching for creative ways to sustain the quality of life and economy in this part of the state.

Young people are also involved in these efforts to create sustainable communities. High school students in Eads have spearheaded efforts to save the historic Plains Theater and adjacent buildings and rehabilitate them as the Crow-Luther Arts Center. Led by Eads High School Principal Betsy Barnett, these students have conducted historical research on the buildings for local landmarking, developed a business plan for their future use, operated the theater for the public, and carried out fund-raising activities to provide cash match for grant requests. These efforts, and the partnerships they have developed, helped

the Town of Eads secure SHF grants totaling \$135,219 for emergency stabilization of the

buildings, and the development of a Historic Structure Assessment and design documents for the eventual full rehabilitation of the three buildings. This project has sparked the students' interest in becoming more involved in historic preservation activities in their community through such projects as "Sample Town," where students propose new uses for vacant historic buildings in their town, and by participating in the first Colorado Preservation Youth Summit in April 2007, organized by Ann Pritzlaff and Colorado Preservation, Inc. (CPI).

Southeast of Eads another group of high school students are working to find sustainable solutions for an important historic landmark in their community—the former Japanese Internment Camp known as Amache or the Granada Relocation Center. Granada High School students, led by history teacher John Hopper, keep the camp cemetery mowed, maintain interpretive signage at the site, re-established the main gate and help run a small museum of camp artifacts and archives. They also provide presentations around the state on the history and importance of the site. SHF has provided \$77,751 in grants to the Optimist Club and the Town of Granada to develop a nomination to the National Register of Historic Places and conduct an archaeological assessment of the site. The Granada students also participated in the Colorado Preservation Youth Summit this past spring and presented their work

to 50 other interested students from Campo, Hulstrom Middle School in Northglenn (who have participated in a project to provide podcasts on the history of Colfax Avenue in Denver), and Cheyenne and Arapaho youth from Oklahoma, as well as the student preservationists from Eads.

These projects have made history come alive for these future leaders of the preservation community, and provided them with tools to be a part of their communities' sustainability.

Volunteer Site Stewards in the Southwest

With the help of six SHF grants since 2000 totaling more than \$200,000, the San Juan Mountains Association (SJMA) has trained 100 volunteer site stewards through the Southwest Colorado Cultural Site Stewardship Program (CSSP). The program monitors over 110 prehistoric and historic archaeological sites in southwest Colorado. Since 1998 those stewards have provided more than 8,000 volunteer hours monitoring, protecting, and preserving these important resources.

SJMA is the result of a partnership developed in 1988 between the San Juan National Forest and local citizens with the goal of facilitating communication between federal agencies and residents of the communities surrounding public lands in southwest Colorado. This area of the

state has an array of historic and prehistoric cultural resources including Ancestral Puebloan, Spanish Trail, mining and ranching sites. Each resource represents Colorado's diverse and colorful history. The purpose of the program is to help protect archaeological sites from the pressures of increased development, recreational activity and site visitation, as well as vandalism.

Studies show the most effective way to protect endangered cultural resources is by educating the public about their importance and involving community members in their protection. It was for this purpose that the San Juan Mountains Association established the CSSP with a goal of training volunteers and educating local communities and individuals about how to protect and preserve the cultural resources in their area. The program trains volunteer stewards to monitor cultural resources for damage caused by both humans and the environment.

John Nau, Chairman of the President's Advisory Council on Historic Preservation, was so impressed by the success of this program, and its impact on Bureau of Land Management lands, that he recently announced a national effort to create similar programs across the country.

Preserving Community Gathering Places

Louviers Village Club in Douglas County

Constructed in 1917 by E.I. du Pont de Nemours and Company, the Louviers Village Club served as a social and recreational center for the company town of Louviers. To foster a sense of community in the new town, Du Pont built the first Louviers Village Club in 1908, which was replaced by the current, more elaborate structure. The largest building of its kind in the county at the time, the Craftsman-style behemoth contained an assembly hall, a

“women’s talk room,” a grocery store, and a post office. It also boasted a two-lane maple-floored bowling alley with hand-loaded pin setters. Du Pont ran the club until 1963, when it leased the facility to the town. Douglas County obtained ownership in the 1970s but was unable to contemplate comprehensive rehabilitation of the building until receiving four State Historical Fund grants totaling almost \$500,000, which made this project possible.

The county began by conducting a historic structure assessment that guided subsequent rehabilitation work. During the last five years, preservation contractors have restored the main meeting room, repaired and replaced windows, removed a non-historic drop ceiling, restored exterior woodwork and masonry, and added ADA-compliant access to the building.

Current and former Louviers residents backed the projects from the beginning. “As the daughter of a retired Du Pont employee and former resident of Louviers when it was a company town, I am very excited about the restoration,” said Sandra Richardson. “I personally remember learning how to bowl at the two-lane bowling alley.”

With restoration and rehabilitation projects scheduled for completion in September, this community center will

once again be available to the public for weddings and other family or community events, and continue to foster the sense of community started by Du Pont nearly 100 years ago.

Riverside School in Grand Junction

Built in 1918, the Riverside School was attended by Grand Junction children until the school district closed the doors in 1982 due to lack of funds to maintain the building. The school remained empty for more than 20 years while the roof failed, rain seeped in, and the interior continued to deteriorate. That is until members of the community joined together and formed the Riverside Task Force, a non-profit neighborhood association. Since then the Task Force has provided the fund raising and leadership direction to save this important resource.

Partnering with the school district, the Riverside Task Force has restored and rehabilitated the school building as a community center. The building is also used by its next-door neighbor, the Dual Immersion Academy. The Academy is a school of choice that provides classes in both Spanish and English. In addition to using the building as a place for community events and classes, the Academy's students have access to a computer room and library with English and Spanish books. They eat their lunch in Riverside School's for-

mer auditorium, which still has the original raised stage. Other programs housed in the school include a tutoring program, the Riverside Youth Council, Ballet Folklorico, a business incubator program and Project Common Ground, which supports immigrant and refugee families in the community.

Due to the extreme deterioration of the roof, much of the interior finishes and trim required replacement. However, with the assistance of \$352,067 from the State Historical Fund through four grants this work, and more, has taken place. With the help of this funding the Task Force has replaced the failing roof, recreated and repaired the damaged wood trim, floors and plaster walls, restored the windows, doors and transoms, and repaired and patched the stucco exterior. Other funds for the project were provided by the Gates Foundation, El Pomar Foundation, the City of Grand Junction, and the local Lions Club.

"The neighborhood has a desire to remain an old, viable neighborhood; they have an incredibly strong sense of community," said Kathy Portner, assistant community development director for the city of Grand Junction, in a recent article in the Grand Junction Sentinel. Restoration and rehabilitation of this important neighborhood landmark helps maintain that sense of community.

Providing Community Services— Old Colorado City Carnegie Library, Colorado Springs

The Old Colorado City Carnegie Library opened in 1904 on West Pikes Peak Avenue thanks to a gift from Andrew Carnegie. When Colorado City was annexed to the city of Colorado Springs in 1917, the library board of directors sold its rights and interests to the Colorado Springs Public Library for \$1, and the Old Colorado City Library became the West End Branch.

One of 19th-century industrialist Andrew Carnegie's many philanthropies, Carnegie libraries entertained and educated millions across the nation. Between 1886 and 1919, Carnegie donated more than \$40 million to build 1,679 new library buildings in communities large and small across America. Of the 36 original Carnegie libraries in Colorado, 30 remain standing. Most (19) are still used as libraries. Others are used as government offices and museums, or for more unusual uses such as a church and bed and breakfast.

In May 1977, the Pikes Peak Library District (PPLD), in response to a renewed interest in the historical significance of the area, rededicated the building as the Old Colorado City Branch Library. The building was "renovated" in 1980, which resulted in the loss of many of its interior historic features. In 2003 the PPLD began fund-raising with a \$1.2 million goal to restore and rehabilitate the

library to meet the needs of its 21st century clientele, while maintaining and even recreating its historic features.

With the help of more than \$424,000 in SHF grants, and significant funding from other sources, the PPLD has managed to carry out necessary structural repairs (cracks and gaps between floors and walls indicated serious shifting of the foundation), repair and restore windows and doors, and replace the front steps. Other work on the building included rewiring the main floor to meet current technology needs, replicating historic light fixtures, installing new heating and cooling systems, replacing the plaster ceiling, reconstructing wood features such as the main desk and shelving, expanding the community meeting room in the basement and adding ADA accessibility features.

The library remains an important and vital part of the Westside community and the Old Colorado City National Register Historic District with circulation up 93% and the number of people who visit the library up 53% since 2000.

Update on SHF Initiatives

Heritage Tourism Program

Tourism is big business in Colorado, generating \$7.3 billion in visitor spending and employing 138,400 residents throughout the state. Heritage travelers represent one of tourism's fastest growing market segments. In the U.S., heritage travel has grown at twice the rate of overall travel in the past decade, and by spending money in smaller towns and rural areas as well as in larger cities, heritage travelers bring economic benefits to the entire state.


Since its inception in 1990, the State Historical Fund has supported Colorado's heritage tourism efforts. The Fund has provided more than \$192 million in grants to restore, rehabilitate, and interpret historic architectural and archaeological sites all over the state, many of which are tourist destinations.

The State Historical Fund's involvement in heritage tourism accelerated in 2004 with a \$550,000 grant to the Colorado Tourism Office to develop the state's first official Strategic Plan for Colorado Heritage Tourism Enhancement. Completed in 2006, the plan improved understanding of the state's heritage tourists and provided communities with tools to create heritage tourism development strategies of their own. The same grant funded improvements to the heritage content in the *Official State Vacation Guide* and the state's tourism website, www.colorado.com, and funded pilot project grants in four areas: southeast Colorado, Park County, the San Luis Valley, and southwest Colorado. Currently twenty counties are represented in the pilot project effort.

A second grant to the Colorado Tourism Office, awarded in fiscal year 2007, is expanding the Heritage Tourism program. With this \$428,024 grant the Colorado Tourism Office is establishing quality and authenticity standards for historic sites using information gathered from the pilot projects and public input. Creative marketing materials are being developed that focus on sites reflecting important themes in Colorado history, and the *Official State Vacation Guide* and website have been further enhanced. Many additional partners are joining together

to help maximize the benefits of heritage tourism to Colorado communities and leverage the SHF grant dollars, including the Colorado Department of Local Affairs, the Colorado Council on the Arts, the National Preserve America program, the Historic & Scenic Byways program, the Anshutz and El Pomar Foundations and local governments throughout Colorado.

The most recently awarded grant of \$411,260 for the program will provide funds in fiscal year 2008 to further develop quality standards and inventory heritage tourism "products" around the state. An additional pilot project will be funded based on a thematic venue and future marketing materials will include a Scenic & Historic Byways guide, additional updates to the *Official State Vacation Guide* and www.colorado.com, as well as an overall branding effort for the program.



Explore Colorado

The State Historical Fund provided nearly \$125,000 in 2006 to develop Explore Colorado, a collaborative effort between KUSA television (Channel 9 in Denver) and the National Trust for Historic Preservation. During the summer of 2006 Explore Colorado promoted heritage tourism sites on the 9NEWS website and through broadcast programming. The programming encouraged Coloradans to discover areas of cultural and historic interest, and in turn to help rural and "off the beaten path" areas of the state improve their economies through increased tourism activities. The program, which initially ran from May to October 2006, highlighted sites that were featured on the 9NEWS website and profiled on the station's weekly *Colorado & Company* interview program. The featured sites covered the Colorado map and included such diverse offerings as prehistoric homelands, pioneer settlements and historic theaters and courthouses.

Because of the program's success, the SHF awarded an additional \$225,750 to the National Trust for Historic Preservation in 2007 to provide additional educational


vignettes and highlight an additional 20 segments during the 2007 summer season.

Most of the sites profiled on *Colorado & Company* and the Explore Colorado website have received SHF funding. These important historic resources have been preserved and protected with the help of SHF grants and technical expertise. Together, these sites have received millions of dollars in historic preservation grants since 1993.

The program continues to be a success, resulting in increased visitation to the featured historic sites and tens of thousands of page views on the Explore Colorado section of 9news.com.

State Capitol Life-Safety Upgrades & Mr. Brown's Attic

Phase III of the six-year, five-phase Colorado State Capitol Life-Safety Project is complete and the attic level on the west side of the Capitol has been transformed into Mr. Brown's Attic, a 2,000-square-foot public gallery dedicated to the history and significance of Colorado's statehouse. Funded as part of the \$4.7 million Phase III SHF grant, Mr. Brown's Attic features photos, displays and artifacts that tell the story of the Capitol from its beginnings to the present day. The space is named for Henry Cordes Brown, a far-seeing Coloradan who donated land on a high bluff with a stunning view of the Rocky Mountains for a capitol building in 1868—eight years before Colorado became a state.

Windows from the gallery into the unfinished part of the attic give visitors a peek through the rafters at the naked steel, brick, and stone of the Capitol's superstructure. The original architect's drawings, presented in 1886, are among the displays that lead viewers on a fascinating tour of the building's architecture and construction. The Capitol's role as "the people's building" is traced through historic photos of celebrations, rallies, funeral processions, protests and public art dedications.

"We wanted to show how the Capitol has evolved and changed because of important events and social movements," said public historian Dianna Litvak, curator of the attic gallery. "It has been a gathering place for generations of Coloradans. From the territorial years to the present, our Capitol tells the stories of wars, Depression and social protests—as well as triumph, honor and pride."

Some of the Capitol's original building materials—granite, iron and marble—are available to touch, and an interactive timeline invites youngsters to line up historic national events with Colorado history. Finally, the attic gallery shows visitors what's being done today to preserve the Capitol's historic character and how the current historic preservation and life-safety upgrades aim to preserve the Capitol as the seat of state government and a legacy of art and architecture.

As life-safety upgrades continue to be made, care is taken to preserve the signature features of the original building. Materials and designs are chosen to complement, but not mimic, the original. “New elements are designed to be slightly less elaborate than the original, in order to respect the historic integrity of the existing fabric,” said James Stratis, SHF Preservation Projects Manager.

Phase III of the Life-Safety Project also includes developing a comprehensive Historic Structure Assessment to guide future preservation planning for this Classical Revival monument to civil government. “Our work is to elevate the stewardship of this important structure and to promote its ongoing care,” Stratis says.

Funding of \$4.5 million for Phase IV of the project was provided in fiscal year 2007. That work will take place during the 2007 legislative recess. The final phase will also be funded with a SHF grant of \$6,034,249 that will be carried out in the fall of 2008.

Colorado Preservation, Inc.’s New Deal Cultural Resource Survey

Colorado Preservation Inc.’s New Deal Cultural Resource Survey project, funded by three SHF grants totaling \$360,000, has developed a history of the New Deal programs and projects on Colorado’s Eastern Plains and identified numerous New Deal

Sites in several counties. During the project’s first and second phases, resources such as schools, gymnasiums, parks, government buildings, bridges and culverts were surveyed in twelve counties: Baca, Kit Carson, Prowers, Sedgwick, Bent, Kiowa, eastern Las Animas, Logan, Otero, Phillips, Washington, and Yuma. In the third year (funded in fiscal year 2007), the project is focusing on resources in Cheyenne, Crowley, Elbert, Lincoln, and Morgan counties and the eastern portions of Adams, Arapahoe, El Paso, Huerfano, Pueblo, and Weld counties.

CPI’s staff have researched New Deal activities in Colorado’s plains counties and are surveying all New Deal sites and buildings in eastern Colorado. Surveyed resources are

being evaluated for their potential to be listed on the National Register of Historic Places and many have been nominated for listing. National Register listing provides recognition that can help provide a basis for increased historic preservation and heritage tourism activity in eastern Colorado—as well as qualifying buildings for economic incentives such as SHF grants and tax credits.

The New Deal construction programs during the 1930s resulted in the construction of numerous buildings and structures throughout the country. Due to the extensive federal land holdings in Colorado, along with the regional impact of the Great Depression and Dust Bowl, Colorado received a significant portion of the federal money distributed nation-wide as part of the New Deal programs. The result is New Deal resources found in every county, and virtually every town in the state. Because of its agricultural-based economy, the eastern portion of the state was especially hard hit by the economic and environmental conditions and subsequently has a high concentration of public buildings constructed through the Works Progress Administration (WPA), the Civil Works Administration (CWA), the Public Works Administration (PWA), the Civilian Conservation Corps (CCC), and other programs collectively known as Roosevelt’s “alphabet army.”

The New Deal Era and its structures and landscapes are an important chapter in Colorado’s history. One of CPI’s goals is to work with eastern Colorado residents and communities to help them learn more about the role the New Deal played in their local history, and to assist them in preserving these sites for use by future generations.




Total Grant Dollars Awarded by County*
