The Water Quality Forum Practical Quantitation Limit (PQL) Work Group has completed a "draft final" version of a Practical Quantitation Limit Guidance Document and is seeking comment prior to finalizing the document. A previous version of this document was presented to the Water Quality Control Commission at an October 2006 informational hearing. Since that time, the Work Group discovered that many of the analytical methods upon which the PQLs had been based were not being used by commercial laboratories in Colorado. Therefore, consistent with the work group criteria that the PQL be based on a method that is commercially available, PQLs for the affected compounds have been revised.

Public Notice of New Policy Proposed by Water Quality Control Division

"IMPLEMENTATING NARRATIVE STANDARDS IN DISCHARGE PERMITS FOR THE PROTECTION OF IRRIGATED CROPS"

Background

In 2006, the Water Quality Control Division (WQCD) and the Water Quality Control Commission (WQCC) were made aware of concerns about the impacts of industrial discharges, containing elevated concentrations of certain salts on the quality of downstream water and its suitability for use in irrigating crops. The WQCD investigated the concern and decided that further evaluation was needed. The Division determined that additional controls to protect this beneficial use were

appropriate and, working with stakeholders, proceeded to develop a policy for implementing the narrative standards for protection of irrigated crops (i.e., "no harm to plants" and "no harm to the beneficial uses") in discharge permits. The development of this policy does not preclude the WQCD's option to propose changes to the WQCC at some point in the future to add numeric standards to Regulation No. 31.

The WQCD undertook a three-step process to develop this proposed policy.

- Joint effort with the Colorado Water Quality Forum to start a public, stakeholder process (i.e. Agricultural Diversions Workgroup) to scope the issue, to discuss the prime components of the issue, to provide input to WQCD on preliminary drafts of the policy, and to provide WQCD feedback to stakeholders.
- The WQCD continued to internally discuss how to implement these narrative standards and to further comprehend the consequences of proposed changes in statewide permitting practices to control salts.
- The WCQD prepared a proposed policy for public review (see below), with comments provided to the WQCC, as
 well, and then met with the WQCC and interested parties to discuss the draft, public comments, and to answer
 WQCC questions.

Public Comment Period

The proposed policy will be available from the WQCC Office and on the web site by **December 3, 2007**. Written comments on the proposed policy should be sent to the WQCC Office by **January 2, 2008**, so they can be distributed to the WQCC members.

As noticed elsewhere in this Bulletin, the WQCC will hold a public Informational Hearing (**January 14, 2008**) to receive and to discuss public comments regarding this proposed policy. Interested parties are encouraged to provide oral comments at this hearing.

SPECIAL NOTES

The WQCD has prepared for public review a draft of Division policy WQP-23, "Procedures for Conducting Assessments for Implementation of Temperature Standards in Discharge Permits". The Division will be accepting comments on draft policy WQP-23 until January 2, 2008.
