Water Quality Certifications, under Section 401 of the Clean Water Act, provide for Division determinations that federally issued permits and licenses will comply with the Basic Standards and Methodologies for Surface Water, the Basic Standards for Ground Water, surface and ground water classifications and water quality standards, and all other applicable water quality requirements for the affected waters.

On April 8, 2007 the Water Quality Control Commission, in accordance with HB 06-1337, adopted Regulation #55 establishing the Water Quality Improvement Fund (WQIF). The Rules provide that any penalties levied for water quality control violations that occurred after May 26, 2006 shall be paid to the State Treasurer and then appropriated annually to the WQIF. Funds collected will be available to provide grants for the improvement of water quality in the impacted community/water body, planning, design and construction of stormwater and domestic wastewater treatment facilities, and nonfederal match funding for non-point source projects.

Applications for Category 1 projects will be accepted thru August 1, 2008.

Category 1 Projects are defined in the rules as those projects that improve the water quality in the community or water body which has been impacted by a water quality violation that resulted in a penalty being imposed.

Applications for Category 2 projects will be accepted thru August 1, 2008.

Category 2 Projects include planning, design, construction, or repair of stormwater projects and domestic wastewater treatment works, based on the current fiscal year's Water Pollution Control Revolving Fund and State Domestic Wastewater Treatment Grant Program Intended Use Plan (www.cwrpda.com/WPCRFsubmenu.htm).

Applications for Category 3 will be accepted in accordance with the State's existing Nonpoint Source Management Area application process. In general, the application process starts in the fall and project proposal are due in early December. For more information, consult the NPS web site at www.npscolorado.com or contact Lucia Machado at (303) 692-3585.

Category 3 projects provide the non-federal match funding for the current fiscal year's nonpoint source projects as approved by the Commission.
