E. WATER QUALITY CERTIFICATIONS (Section 401)

Water Quality Certifications, under Section 401 of the Clean Water Act, provide for Division determinations that federally issued permits and licenses will comply with the Basic Standards and Methodologies for Surface Water, the Basic Standards for Ground Water, surface and ground water classifications and water quality standards, and all other applicable water quality requirements for the affected waters.

1. For the purposes of the antidegradation requirements found in Section 31.8 of the Basic Standards and Methodologies, the following projects have been reviewed to make a preliminary determination of the significance of such projects and a draft certification determination. Pesticide Permit Timeline

WQCD has sent EPA a letter requesting the agency to seek an extension of the April 9, 2011 stay of the requirement to obtain an NPDES permit for application of pesticides in order to provide states more time to have a final permit in place. A copy of the letter is available at http://www.cdphe.state.co.us/wq/PermitsUnit/index.html. The WQCD had planned and still plans to prepare a draft general permit, based on EPA's final general permit, for public notice shortly following EPA's issuance of their final general permit. WQCD does not intend to form a work group to identify and discuss any significant changes to EPA's general permit. The WQCD permit would be for a short duration until WQCD receives additional funding and staff resources to further implement pesticide permitting and compliance oversight. During that short permit duration, entities proposing pesticide applications will not need to send WQCD a Notice of Intent (NOI) to be covered. In a mid-December conference call between EPA and states, EPA indicated they would extend their schedule for issuance of a final general permit to February 2011 (which is later than their last planned schedule of December 2010). Because of the high level of statewide interest in the pesticide general permit, WQCD intends to schedule a public meeting on the draft permit during the comment period. In accordance with Regulation 61.5(2)(d), the Division would also need to extend the comment period to 60 days. As a result, because of EPA's change in schedule, WQCD will not be able to prepare a draft general permit based on EPA's final permit, hold public notice including a public meeting, issue a final permit, and have that permit effective prior to April 9, 2011.
