E. WATER QUALITY CERTIFICATIONS (Section 401)

Water Quality Certifications, under Section 401 of the Clean Water Act, provide for Division determinations that federally issued permits and licenses will comply with the Basic Standards and Methodologies for Surface Water, the Basic Standards for Ground Water, surface and ground water classifications and water quality standards, and all other applicable water quality requirements for the affected waters.

1. For the purposes of the antidegradation requirements found in Section 31.8 of the Basic Standards and Methodologies, the following projects have been reviewed to make a preliminary determination of the significance of such projects and a draft certification determination. Public comment on these preliminary determinations will be received for thirty days following the date of publication of this newsletter. COLORADO DISCHARGE PERMIT SYSTEM (CDPS)

BASIS FOR WITHDRAW OF THE <u>STATEWIDE AMENDMENT</u> REGARDING DMR REPORTING AND PRACTICAL QUANTITATION LIMITS

In April of 2009, the Water Quality Control Division (Division) noticed its intention to do a Statewide amendment to all permits which have conditions regarding practical quantitation limits (PQLs), method detection limits (MDLs) and conditions for reporting nondetects or non quantified results including individual permits, general permits, certifications under a general permit, and groundwater permits. The Division received comments on various issues including but not limited to: the procedural process for which the amendment was noticed; the administrative process for which each separate permit would be amended; the PQL values published in the amendment and; the ability for facilities to create site specific PQLs.

The Division is withdrawing this amendment based on two underlying issues. First, issuance of the amendment would set the proposed PQLs in each permit, without considering permittee's abilities to get site specific PQLs. This would potentially set up numerous amendments to specific permits to incorporate a site specific PQL. Second, the Division is unable to amend administratively extended permits. Currently, approximately 30% of the permits that would be subject to the proposed statewide amendment are administratively extended.

In April 2009, the Division provided guidance to permittees under separate cover regarding reporting non detects or non quantified results on discharge monitoring reports (DMRs). The Division has also been working with permittees on a case by case basis to further explain reporting requirements and receive corrected DMRs as appropriate. The Division has been incorporating the changes contemplated in the statewide amendment into each individual permit, general permit, and certification as it is renewed. This has been occurring since the proposed statewide amendment was public noticed, and will continue until the changes have been made to each permit. Permittee's are able to comment specifically to their permits, as they come up for renewal during the public notice of the draft permit or of the master general permit as appropriate.
