### E. WATER QUALITY CERTIFICATIONS (Section 401)

Water Quality Certifications, under Section 401 of the Clean Water Act, provide for Division determinations that federally issued permits and licenses will comply with the Basic Standards and Methodologies for Surface Water, the Basic Standards for Ground Water, surface and ground water classifications and water quality standards, and all other applicable water quality requirements for the affected waters.

1. For the purposes of the antidegradation requirements found in Section 31.8 of the Basic Standards and Methodologies, the following projects have been reviewed to make a preliminary determination of the significance of such projects and a draft certification determination. ### **SPECIAL NOTES**

### Same Issuance and Effective Date for CDPS General Permit No. COG860000 for Discharges from Applications of Pesticides

The Division is disclosing intent to have this general permit in effect when issued and to not to follow the practice of providing a 30-day period between the issuance date and the effective date.

Regulation 61.6.d identifies this time period and Regulation 61.7.a describes the purpose is to provide an opportunity for a demand for an adjudicatory hearing to stay the permit. This process is mandatory for individual permits and, historically, the Division has chosen to follow the same practice for general permits. For the reasons provided below, the Division will not continue with this practice for general permit COG860000. Essentially, EPA has followed a practice of having the same issue and effective date for their general permits (i.e., Vessel General Permit for Discharges Incidental to the Normal Operation of a Vessels was issued on December 18, 2008, and was effective on December 19, 2008).

In 2010, the Division made the decision to develop and issue a general permit that mirrors EPA's general permit with a few notable exceptions. This position was stated in the Fact Sheet when the draft of the general permit was sent to public notice on January 28, 2011. The Division's draft permit was based on EPA's draft sent to public notice in 2010. Consequently, the federal court's deadline for having EPA's permit in effective was changed from April 11, 2011 to October 31, 2011.

As of September 21, 2011, EPA did not have a permit in effect and has indicated that a number of changes have been made to the draft permit sent to public notice in 2010. Without EPA's final permit, the Division permit can not be completed and be publically available 30 days before the effective date of October 31, 2011. Upon receipt of EPA's effective permit, the Division's permit will be finalized and placed in effect on October 31, 2011.
