SUBJECT: 2013 Water Quality Control Commission Appointments

The Colorado Water Quality Control Commission consists of nine members with staggered 3-year terms. Commission members are appointed by the Governor, subject to confirmation by the Colorado Senate. The following members' terms expire February 15, 2013: Andrew Todd (finishing his second term), Patti Wells (finishing her second term) and Chris Wiant (finishing his fifth term). Governor Hickenlooper has established a policy of generally not reappointing current Board or Commission members who have already served two or more terms.

There are no specific statutory constraints on qualifications for these positions on the Water Quality Control Commission. The Colorado Water Quality Control Act does provide that: "Members of the Commission shall be appointed so as to achieve geographical representation and to reflect the various interests in water in the state." In view of the specific expertise potentially lost with this coming round of expired terms, there is an interest in applicants with substantial experience with Colorado's water quality management system. More specifically, applicants with scientific expertise, particularly with respect to aquatic life protection, and applicants with experience with local environmental health departments are encouraged.

Anyone interested in applying to be a member of the Water Quality Control Commission should submit an application and resume at your earliest convenience, but at least by early January, to the Governor's Office of Boards and Commissions. Water Quality Certifications, under Section 401 of the Clean Water Act, provide for Division determinations that federally issued permits and licenses will comply with the Basic Standards and Methodologies for Surface Water, the Basic Standards for Ground Water, surface and ground water classifications and water quality standards, and all other applicable water quality requirements for the affected waters.
