Colorado Water Quality Management and Drinking Water Protection Handbook (WQCC Policy 98-2)
This document has been undergoing revision by the Water Quality Control Division. The resulting draft titled "A Guide to Colorado Programs for Water Quality Management and Safe Drinking Water" has been posted under public notices on the Division's web site in an effort to solicit feedback from interested parties on the proposed changes. The Water Quality Control Commission will consider revisions to this policy during an Administrative Action Hearing scheduled for August 12, 2013. A memorandum by Division Director Steven H. E. WATER QUALITY CERTIFICATIONS (Section 401)

Water Quality Certifications, under Section 401 of the Clean Water Act, provide for Division determinations that federally issued permits and licenses will comply with the Basic Standards and Methodologies for Surface Water, the Basic Standards for Ground Water, surface and ground water classifications and water quality standards, and all other applicable water quality requirements for the affected waters.

1. For the purposes of the antidegradation requirements found in Section 31.8 of the Basic Standards and Methodologies, the following projects have been reviewed to make a preliminary determination of the significance of such projects and a draft certification determination. Public comment on these preliminary determinations will be received for thirty days following the date of publication of this newsletter. (WQCC Policy 98-2)

The Colorado Water Quality Management and Drinking Water Protection Handbook is scheduled to expire on December 31, 2013. The Water Quality Control Commission (Commission) will consider revisions to this policy during an Administrative Action Hearing scheduled for August 12, 2013. This notice is provided in an effort to solicit feedback from interested parties on the Water Quality Control Division's (Division) proposed changes. Policy 98-2 serves two purposes:

- 1. Provide a summary of the water quality management and drinking water protection system in Colorado; and
- 2. Describes the water quality "continuing planning process" currently applied in Colorado (required by section 303(e) of the federal Clean Water Act).

The draft revised document titled "A Guide to Colorado Programs for Water Quality Management and Safe Drinking Water" is available under public notices on the Division's web site and was emailed to the Water Quality Forum, Drinking Water and Wastewater Utility Councils and other interested parties. A notice was also included in the Water Quality Information Bulletin.
