Water Quality Certifications, under Section 401 of the Clean Water Act, provide for Division determinations that federally issued permits and licenses will comply with the Basic Standards and Methodologies for Surface Water, the Basic Standards for Ground Water, surface and ground water classifications and water quality standards, and all other applicable water quality requirements for the affected waters.

1. For the purposes of the antidegradation requirements found in Section 31.8 of the Basic Standards and Methodologies, the following projects have been reviewed to make a preliminary determination of the significance of such projects and a draft certification determination. The WQCD is noticing its intent to issue a new Low Risk Discharge guidance document under the framework of **Division Policy WQP-27**, **Low Risk Discharges**. The new guidance will add Discharges from Potable Water Monitoring Devices as a low risk discharge under the policy, and will include guidance for best management practices applicable to this source.
