SPECIAL NOTES

The Division has published a new implementation policy for "CW-5: Discharge from Water-Based Fire Suppression Systems."

The purpose of this policy is:

- 1. To define a category of discharges of non-potable water from water-based fire suppression systems for which the Water Quality Control Division will not seek application for CDPS permit coverage or take enforcement action against those operators that have not obtained permit coverage.
- 2. To establish that the Water Quality Control Division will not issue general permit coverage for discharges from water based fire suppression systems. Water Quality Certifications, under Section 401 of the Clean Water Act, provide for Division determinations that federally issued permits and licenses will comply with the Basic Standards and Methodologies for Surface Water, the Basic Standards for Ground Water, surface and ground water classifications and water quality standards, and all other applicable water quality requirements for the affected waters.

1.
