2016 IR Summery

The Integrated Water Quality Monitoring and Assessment Report, or the "Integrated Report" (IR) for 2016 summarizes water quality programs and data collected by state, federal, volunteer water monitoring organizations, and other sources. The IR includes the assessment status of monitored waterbodies according to their assigned water quality standards. This document integrates the reporting requirements of the Clean Water Act sections 303(d), 305(b), and section 314 (jurisdictions report to EPA biannually on the conditions of waters within their boundaries).
