### Colorado Nutrients Management Plan and 10-Year Water Quality Roadmap

As part of the 2017 nutrients rulemaking hearing, the Water Quality Control Division developed a recommended plan for managing nutrients and a plan for developing recommendations for new and updated water quality standards between 2017 and 2027. These plans received support from the 2017 nutrients work group and the Water Quality Control Commission. Policy CW8 should be used to guide efforts to reduce point and nonpoint sources of nutrients, develop information that will be used to recommend new and updated water quality standards, and guide the implementation of new water quality standards discussed in this policy.

This policy details the Water Quality Control Division's (division) recommended Colorado Nutrient Management Plan and 10-Year Water Quality Roadmap. This plan and roadmap were developed as part of the nutrients work group effort in 2016-2017. The plan:

- Provides an overview of Colorado's current nutrient management framework
- Discusses plans for further reducing nutrients from point source and nonpoint sources
- Outlines the major milestones the division, Water Quality Control Commission, and stakeholders will need to undertake over the next 10 years to implement the plan
- Provides an overview of how Colorado will continue to make progress on revising nutrient standards
- Summarizes other standards development efforts through 2027
- Details plans for developing feasibility information over the next 10 years
- Establishes how the division will monitor and measure progress related to nutrients controls

This plan was modeled after the 2011 memo from the Environmental Protection Agency's (EPA) Nancy Stoner titled "Working in Partnership with States to Address Phosphorus and Nitrogen Pollution through Use of a Framework for State Nutrient Reductions" and EPA's 2016 memo from Joel Beauvais titled "Renewed Call to Action to Reduce Nutrient Pollution and Support for Incremental Actions to Protect Water Quality and Public Health."

### D. WATER QUALITY CERTIFICATIONS (Section 401)

Water Quality Certifications, under Section 401 of the Clean Water Act, provide for Division determinations that federally issued permits and licenses will comply with the Basic Standards and Methodologies for Surface Water, the Basic Standards for Ground Water, surface and ground water classifications and water quality standards, and all other applicable water quality requirements for the affected waters.

1. For the purposes of the antidegradation requirements found in Section 31.8 of the Basic Standards and Methodologies, the following projects have been reviewed to make a preliminary determination of the significance of such projects and a draft certification determination. Public comment on these preliminary determinations will be received for thirty days following the date of publication of this newsletter.
