- ***Localized reclaimed water treatment system requirement implementation under Regulation 84 policy***

The Water Quality Control Division has issued an implementation policy for localized reclaimed water treatment systems under the Implementation Policy Number CW-18. The policy provides additional information to support the implementation and design of localized reclaimed water treatment systems as defined in Regulation 84, Reclaimed Water Regulations. The policy clarifies the definition of a localized reclaimed water treatment system and provides log reduction value crediting framework and process control monitoring requirements for treatment processes used to achieve log reduction values (LRVs) for the intended use category of the reclaimed water. The policy is posted on the division's web page here (under the CW 18 header).

*Water Quality Certifications, under Section 401 of the Clean Water Act, provide for Division determinations that federally issued permits and licenses will comply with the Basic Standards and Methodologies for Surface Water, the Basic Standards for Ground Water, surface and ground water classifications and water quality standards, and all other applicable water quality requirements for the affected waters.*

- For the purposes of the antidegradation requirements found in Section 31.8 of the Basic Standards and Methodologies, the following projects have been reviewed to make a preliminary determination of the significance of such projects and a draft certification determination. Public comment on these preliminary determinations will be received for thirty days following the date of publication of this newsletter.
