Water Quality Certifications (Section 401)

Water Quality Certifications, under Section 401 of the Clean Water Act, provide for division determinations that federally issued permits and licenses will comply with the Basic Standards and Methodologies for Surface Water, the Basic Standards for Ground Water, surface and ground water classifications and water quality standards, and all other applicable water quality requirements for the affected waters.

For the purposes of the antidegradation requirements found in Section 31.8 of the Basic Standards and Methodologies, the following projects have been reviewed to make a preliminary determination of the significance of such projects and a draft certification determination. Public comment on these preliminary determinations will be received for thirty days following the date of publication of this newsletter. More information on the specific projects can be obtained from Alex Powell (alex.powell@state.co.us, 303-692-3618). The U.S. Army Corp of Engineers (COE) may also review these projects, under Section 404 of the Clean Water Act, and a list of their current public notice can be found on their website.

#4512 - Town of Erie	NWO-2024 01753	Erie is proposing a channel restoration and flood control project along portions of Coal Creek near County Line and Kenosha Roads in Boulder and Weld counties. The project area was severely flooded September 2013. Due to undersized culverts at County Line Road and Kenosha Road, the floodwater caused Coal Creek to overtop its banks and flood adjacent roads and area neighborhoods. The overall project area is approximately 1.25 miles of Coal Creek at two locations. Reach 2 starts upstream near County Road 1.5 at The Boneyard at Reliance Park and extends along Coal Creek to approximately 650 feet downstream of County Line Road, and Reach 4 occurs further downstream of Reach 2 along Coal Creek just upstream and downstream of Kenosha Road. The basic purpose of the project is channel restoration and flood control improvements to construct a high functioning, lower maintenance channel. The overall purpose of the project is to increase channel capacity, reduce flood risk at adjacent properties, address channel erosion, provide long-term channel stability, enhance the open space corridor for public use, and improve the habitat and overall health of the stream.
