# Introduction

---

The United States Environmental Protection Agency (EPA) established the Public Water System Supervision (PWSS) Program under the authority of the 1974 Safe Drinking Water Act (SDWA). Under the SDWA and the 1986 Amendments, EPA sets national limits on contaminant levels in drinking water to ensure that the water is safe for human consumption. These limits are known as Maximum Contaminant Levels (MCLs). For some regulations, EPA establishes treatment techniques (TTs) instead of MCLs.

EPA also sets standards on how often public water systems (PWSs) monitor their water for contaminants and report the sample results. Generally, the larger the population served by a water system, the more frequent the monitoring and reporting (M&R) requirements.

In addition, EPA requires select PWSs to monitor for unregulated contaminants to provide data for future regulatory development. The 1996 Amendments to the SDWA require public notification to include a clear and understandable explanation of the nature of each violation, its potential adverse health effects, steps that the PWS is undertaking to correct the violation, and the possibility of alternative water supplies during the violation.

The Colorado Department of Public Health and Environment's (CDPHE) Safe Drinking Water Program (SDWP) implements the SDWA, with amendments, pursuant to Regulation 11 (Colorado Primary Drinking Water Regulations) for the State of Colorado.

The Annual Compliance Report (ACR) is intended to provide a total annual representation of the number of violations. Violations fall into one of two categories:

1. Health-Based.
2. Non-Health-Based.

# Definitions

---

- **Public Water System (PWS):** An entity that provides water via piping or other constructed conveyances for human consumption to at least 15 service connections or serves an average of at least 25 people for at least 60 days each year. There are three types of PWSs:
  - Community (e.g., cities or towns).
  - Non-Transient, Non-Community (e.g., schools or factories).
  - Transient, Non-Community systems (e.g., restaurants, rest stops, or parks).
- **Health-Based:** Potential short-term or long-term health risks.
  - **Maximum Contaminant Level (MCL):** The highest level of a contaminant allowed in drinking water. Note: Under the Lead and Copper Rule, MCLs were not established. For this rule, “action levels” rather than MCLs define the levels at which a public water system must take action to reduce the concentration of lead and/or copper.
  - **Maximum Residual Disinfectant Level (MRDL):** The highest level of a disinfectant (added for the treatment of water) allowed in drinking water. MRDLs are enforceable in the same manner as MCLs.
  - **Treatment Techniques (TT):** Unacceptable levels, in lieu of a MCL, for selected water characteristics or a failure to correct an identified issue. Turbidity, for example, measures the cloudiness of water.
- **Non-Health-Based:** No health risks or health risks are unknown.
  - **Monitoring and Reporting (M&R):** To monitor, test, and report for water characteristics (e.g., contaminants) present in drinking water. All minor and major violations are included.
  - **Public Notice (PN):** A requirement for the PWS to notify their customers of any and all violations. PN requirements take into account the seriousness of the violation (or situation) and any potential adverse health effects that may be involved.
- **Variance:** A departure from a primary drinking water regulation if the characteristics of the raw water sources available to the PWS do not allow the system to meet the MCL.
- **Exemption:** Temporarily relieves a PWS of its obligation to comply with an MCL, TT, or both, due to compelling factors (which may include economic factors).

# National Primary Drinking Water Regulations

---

The Safe Drinking Water Act (SDWA) is the federal law that regulates the quality of drinking water. The SDWA sets standards for drinking water quality and stipulates the monitoring requirements for PWSs. The following regulations have been promulgated under the CPDWR:

- **Chemical Phase Rule:** Provides public health protection through the reduction of chronic risk (e.g., cancer, organ damage, etc.) from the exposure of:
  - Inorganic Chemicals (IOCs).
  - Nitrate and Nitrite (NOX).
  - Synthetic Organic Chemicals (SOCs).
  - Volatile Organic Chemicals (VOCs).
  - Radionuclides (RADs).
- **Consumer Confidence Rule (CCR):** A drinking water quality report that PWSs distribute to their customers by July 1 each year. The report contains information regarding sources used (i.e., rivers, lakes, reservoirs, etc.), detected contaminants, violations, and educational information.
- **Cross-Connection Control Rule (CCX):** Requires PWSs to inspect their system for cross-connections and backflow prevention devices.
- **Microbial, Disinfection, and Disinfection Byproducts (MICRO, DIS, and DBPs):** In general, drinking water must be disinfected to inactivate microbial pathogens (e.g., *E. coli*, salmonella, etc.). To protect against potential microbial contamination, PWSs add disinfectants such as chlorine. However, disinfectants can react with naturally occurring material in the source water and form byproducts which may pose adverse health risks. PWSs must carefully maintain a balance between addressing potential microbial contamination and byproduct formation. The following rules address this issue:
  - **Groundwater Rule (GWR):** The purpose of the GWR is to provide increased protection against microbial pathogens in PWSs that utilize groundwater sources.
  - **Disinfection (DIS):** The purpose of these rules is to provide protection against microbial contamination.
  - **Disinfection Byproduct Rules (DBPs):** The purpose of these rules is to reduce exposure to disinfection byproducts for customers of PWSs that add a disinfectant to the drinking water during any part of the treatment process.
  - **Surface Water Treatment Rules (SWTRs):** The purpose of the SWTRs is to prevent waterborne diseases caused by viruses, *Giardia*, and *Cryptosporidium*. The rules require surface water systems to filter and disinfect their water to reduce the occurrence of microbial contamination.
  - **Revised Total Coliform Rule (RTCR):** The purpose of this rule is to increase public health protection through the reduction of contamination in the drinking water distribution system.
- **Lead and Copper Rule (LCR):** Protects public health by minimizing the public's exposure to lead and copper.

- **Notification, Record Keeping, and Monitoring Plan (Notification):** Requires PWSs to notify the state of any drinking water violations or situations that may pose an adverse health risk, retain records, and have a monitoring plan.
- **Operator Certification Rule (Op Cert):** Requires PWSs to have a certified operator.
- **Plans and Specifications (P&S):** Requires PWSs to get approval before making physical modifications to the water system.
- **Public Notice Rule (PN):** Requires PWSs to notify their customers of any drinking water violations or situations that may pose an adverse health risk.
- **Sanitary Survey (SS):** Requires PWSs to correct deficiencies found during an inspection.
- **Storage Tanks (Tanks):** Requires PWSs to perform inspections on finished water storage tanks and fix any issues identified.
- **Water Hauler Rule (Hauler):** Requires PWSs that haul water to meet special requirements.



# Violations

## Overview

The number of PWSs in the state changes on a daily basis. This is due to seasonal operations, new PWSs opening, existing PWSs closing, and changes to the population being served. Table 1 displays a typical number of systems, on any one day, by population and system type.

Table 2 summarizes the number of violations and the number of systems by each drinking water rule and violation type. The subsequent sections provide further details for each of the drinking water rules.

Violations are based on data compiled in April 2024 from Colorado’s production SDWIS/State database. If a violation: (1) was unresolved as of January 1, 2023, or (2) occurred in calendar year 2023, it was included. M&R violations for PWSs sampling less frequently than annually will be reported in the third, sixth, or ninth year of a compliance cycle. Calendar year 2023 was the first year in a compliance cycle.

Appendix A identifies the public water systems that were in violation of maximum contaminant levels and/or treatment technique requirements. The final column indicates if the violation was resolved.

## Exemptions, Variances, and Waivers

---

Colorado's Safe Drinking Water Program did not issue any variances or exemptions to any public drinking water system in 2023. There are no active prior variances or exemptions in place in Colorado for MCLs. EPA granted the Denver Water Board a [variance from the Lead and Copper rule](#) in 2019 and 2022. In partnership with the EPA, the state is helping oversee the implementation of the variance. There are state-wide monitoring waivers in place for asbestos, cyanide (except for Cripple Creek and the City of Victor, which are required to monitor for cyanide), and glyphosate (if the system is chlorinating).
