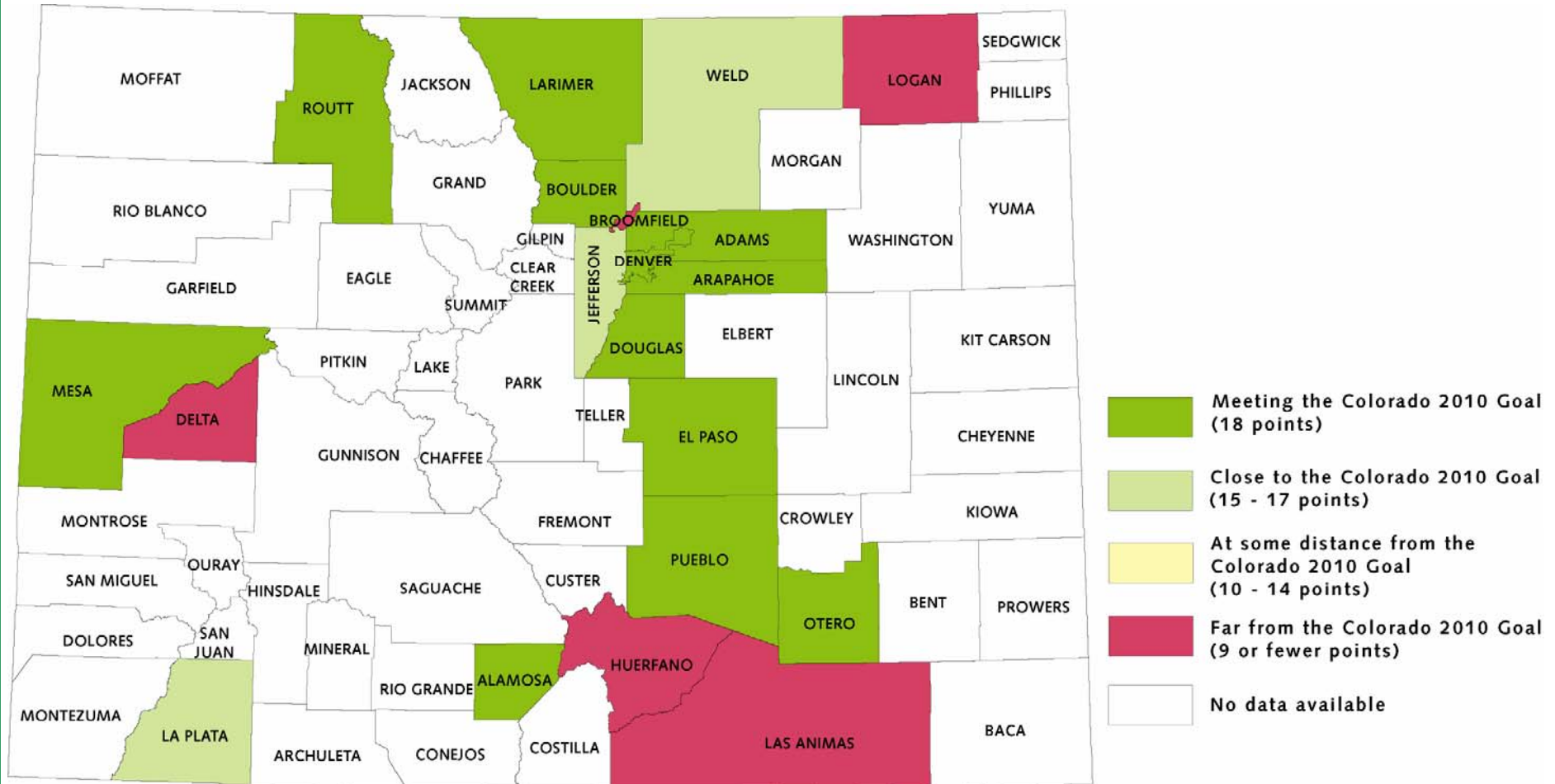


Family Participation

(Degree on a Scale of 0-18)
National Performance Measure 2

Colorado 2010 Goal: To increase the degree to which the state assures family participation in program and policy activities in the state Children with Special Health Care Needs program to 18 points.

Comparisons are based on the Colorado 2010 goal of 18. Data are available for Fiscal Year 2006-2007, but are not available for most counties. Low scores may indicate startup regional offices or vacancies.



Counties categorized as close to the goal are within 80 percent of the goal; counties at some distance from the goal are between 51 percent and 79 percent of the goal; and counties far from the goal are 50 percent or less of the desired goal.

Point scores for FY 2007 (scale of 0 to 18) should not be compared with point scores for FY 2002 (scale of 0 to 15), but may be compared with point scores for FY 2001, FY 2003, FY 2004, FY 2005, and FY 2006 (scale of 0 to 18).
