FAMILY PLANNING SERVICES

Colorado Title X Family Planning (FP) clinics provide a range of preventive health services, including reproductive health exams; contraceptive supplies; pregnancy testing; screening for cancer and STDs, including HIV; basic infertility services; and referrals to other health and social services. In addition, clients receive education and counseling about contraception (including abstinence), sexually transmitted infections, and general preventive health practices. Family planning clinics often are an entry point into the health care system for women and families who otherwise lack access to health care services.

Family Planning services are confidential. Clinic charges are based on the patient's ability to pay. It is not necessary to live in the county where services are received.

PRENATAL PLUS PROGRAM

Prenatal Plus is a Medicaid-funded program that provides care coordination, nutrition, and mental health counseling to Medicaid-eligible pregnant women. The goal of the Prenatal Plus Program is to improve birth outcomes by reducing the number of low birth weight infants born to qualifying women. An initial assessment identifies risk factors and enrolls those women who are at highest risk for delivering low birth weight infants.

Prenatal Plus Services enhance the medical component of prenatal care by addressing the lifestyle, behavioral, and other non-medical aspects of a woman's life likely to affect her pregnancy. A care coordinator, registered dietitian, and mental health professional work as a multi-disciplinary team to provide interventions based on individual client needs. Services are offered at county health departments, county nursing services, community health centers, and non-profit organizations throughout the state.

NURSE HOME VISITOR PROGRAM / NURSE-FAMILY PARTNERSHIP

The Nurse Home Visitor Program is a state grant that funds nurse home visitation services, specifically Nurse-Family Partnership. Nurse-Family Partnership (NFP) is a home visitation, case-management program. Nurses follow specific visit-by-visit guidelines that focus on six domains: personal, health, life course development, maternal role, family and friends, and health and human services. The program goals are to improve pregnancy outcomes, child health and development, and parental life course.

Registered nurses make regular home visits throughout this intensive, long-term program. They provide maternal and child health assessments and extensive teaching on health, parenting, safety, and environmental health. They also provide links to other community services and support as needed.

Criteria for enrollment are first-time (defined as no previous live births), pregnant women or whose first child is less than one month old and who are at or below 200% of the Federal Poverty Level. Although NFP encourages enrollment as early in pregnancy as possible, enrollment can be within one month postpartum, until the child is age 2.
