The list below applies to physicians and hospitals. Laboratories have separate reporting requirements. A case must be reported to the state or local health department following diagnosis within the timeframe indicated.

The State Health Department recommends reporting all suspected cases, whether or not supporting laboratory data are available.

1. The disease or condition being reported
2. Patient's name, date of birth, sex, race,
ethnicity, address (including city,
county, and phone number)
3. Physician's name, address and
telephone number
