

In 2018 the CHS methodology for data collection changed, allowing participants to either complete the survey electronically (on a smartphone, tablet or computer) or over the phone (as we always have.) The addition of electronic surveys changed who responded to the survey enough that we are not able to combine it with previous years where only telephone surveys were completed. Therefore, the 2018 methodology changes do not allow 2018 data to be combined with prior data years. Data collection methods remained the same in 2019 so we will have the ability to combine 2018 and 2019 together in the future.
