Summary of Designated Uses and Attainment for Colorado Lakes 2006 305(b) Report

Lake acres were determined by the USGS as part of the National Hydrography Dataset (NHD), which can be found at <http://nhd.usgs.gov/data.html>. The Division is aware that the acreages of many reservoirs and lakes in the NHD may not reflect the current size of those waterbodies. The NHD was created using existing USGS topographic maps, which in some cases may be decades old, and may not represent the current size of a waterbody. Furthermore, the nature of fluctuating reservoir levels in Colorado makes it difficult to assign an accurate acreage to a waterbody.

To conform to EPA's reporting requirements within the Assessment Database (ADB) some of Colorado's WBID descriptions have further segregated and refined. In these cases, a numeric flag, based on geographic location, has been appended to those WBID as an additional identifier. These additional identifiers have no bearing on the water quality standards that have been adopted in Colorado, but rather are utilized to assist in determining the location of the segment in question.
