# Problem Gambling/Gambling Addiction Grant Report (12-47.1-1601 (4) (a.5) (II), C.R.S. 2014)

Report to the General Assembly Colorado House Public Health Care and Human Services Committee and Senate Health and Human Services Committee

#### Introduction

The Colorado Department of Human Services Office of Behavioral Health respectfully submits the Fiscal Year (FY) 2013-2014 Report entitled, Problem Gambling/Gambling Addiction Grant Report to the to the Colorado House Public Health Care and Human Services Committee and Senate Health and Human Services Committee in compliance with:

## 12-47.1-1601 (4) (a.5), (II) C.R.S. 2014

(II) By January 1, 2009, and by each January 1 thereafter, the department of human services shall submit a report to the health and human services committees of the senate and house of representatives, or their successor committees, regarding the grant program. The report shall detail the following information for the fiscal year in which the report is submitted:

(A) The amount of moneys allocated to the gambling addiction account pursuant to paragraph (a) of subsection (1) of this section;

(B) The number of grant applications received and the total amount of grant moneys requested by grant applicants;

(C) The total amount of moneys in the gambling addiction account that was awarded as grants to applicants; and

(D) The entities or programs that received grants and the amount of grant moneys each grant recipient received.

### Problem Gambling/Gambling Addiction Grant Program

The intent 12-47.1-1601 (4) (a.5) C.R.S. 2014 is to address the issue of problem gambling and gambling addiction in Colorado. This is completed through a process of awarding grants to state or local, public or private, entities or programs that provide gambling addiction counseling services and that has, or is seeking, nationally accredited gambling addiction counselors. Grants are awarded to behavioral health professionals and addiction counselors who are actively pursuing national accreditation as gambling addiction counselors and have completed at least half of the counseling hours required for national accreditation.

The Department of Human Services determined that the most efficient and effective method The to achieve the legislative intent was to subcontract the administration of the program. Department has pursued bids through the documented quote process for services in FY 2013-14. A documented quote was released in July 2013. An award was made to the Center for Governmental Training which was chosen as a fiscal agent for the grant award process. The Center for Governmental Training awards grants to behavioral health professionals and addiction counselors pursuing national certification as gambling counselors, who have completed at least half of the counseling hours required for national accreditation.

Contractor marketing and outreach activities

- 1. Emailing to Community Mental Health Centers and presentation to the clinicians group from the Colorado Behavioral Health Council. Contractor provided a flyer and a grant application for people to complete.
- 2. Discussions with and email to substance use disorder treatment providers through trade associations and business practices.
- 3. Exhibit at conferences with the flyer and application.
- 4. Word of mouth through treatment professionals including nationally certified counselors in Colorado.
- 5. Contact with therapists, who list themselves as "Gambling Therapists" through the Psychology Today website for Colorado.
- 6. Outreach through the Problem Gambling Coalition of Colorado (PGCC) website, which includes flyers and application.

The contractor anticipates the addition of Problem Gambling to the list of Addictive Disorders in the new Diagnostic Statistical Manual of Mental Disorders 5, will add to interest in training and certification.
