Part C State Annual Performance Report (APR) for FFY 2007 (July 1, 2007- June 30, 2008)

Overview of the Annual Performance Report Development: The Colorado Department of Human Services, Division for Developmental Disabilities (DDD), as the lead agency for Part C in Colorado, developed the APR with broad stakeholder input from the Colorado Interagency Coordinating Council (CICC), the Memorandum of Understanding (MOU) Sub-Committee of the CICC (which consists of the five state agencies primarily responsible for early intervention services at the state level), feedback from Community Centered Board (CCB) Early Intervention programs (which represent the primary service delivery system), and other state and local interagency partners.

Monitoring Priority: Early Intervention Services in Natural Environments

Indicator 1: Percent of infants and toddlers with IFSPs who receive the early intervention services on their IFSPs in a timely manner.

(20 U.S.C. 1416(a)(3)(A) and 1442)

Measurement:

Percent = [(# of infants and toddlers with IFSPs who receive the early intervention services on their IFSPs in a timely manner) divided by the (total # of infants and toddlers with IFSPs)] times 100.

Definition of "timely" receipt of services: Colorado defines "timely" receipt of services as "services to begin as soon as possible but no later than 28 calendar days from the date the parent(s) consents to services on the IFSP."

Data Analysis: The data on the number of infants and toddlers from all 20 CCBs who had initial Individualized Family Service Plans (IFSP) and subsequent six month and annual reviews was captured in the statewide data analysis of all children who entered the early intervention system between October 1, 2007 and March 31, 2008. Colorado collects data from all early intervention programs in a statewide data system and reports for 100% of the children for whom new services were listed on an initial, review or annual IFSP.

- 1,922 = Total number of infants and toddlers with IFSPs with new services (from initial IFSPs and subsequent reviews and annuals).
- 1,400 = Total number of infants and toddlers with IFSPs who had timely receipt of services in 28 days or sooner.

Explanation of Progress or Slippage for FFY 2007: The target of 100% was not met but progress was made in the amount of children who received their early intervention services within the 28-day timeline from 81.60% reported in FFY 2006 to 84.76% in FFY 2007.

While incremental progress has been made, the system's ability to accurately capture and report the data has improved significantly. In October 2007, the statewide data system was migrated into a web-based system. A detailed instruction manual was distributed and five web-based trainings were conducted to ensure the participation of all CCBs. Detailed explanations of the required fields necessary to capture the data points for the timely initiation of early intervention services along with a step-by-step demonstration of the data fields was given.

Edit reports were created and made available to CCB staff in order to identify gaps in data entry to ensure the validity and reliability of data collected and enable self-monitoring of their performance. In order to ensure progress in meeting 100% compliance on Indicator 1, DDD provided extensive technical assistance to early intervention programs, including data managers, regarding the specific data to be collected and how to use the new measurement to report separately the number of documented delays in initiating services attributable to exceptional family circumstances versus delays due to systems issues. The statewide data system that is now in place effectively captures accurate, valid and reliable child-specific data for Indicator 1.

To address the 15.24% of noncompliance that occurred in FFY 2007, DDD has reviewed the improvement activities described above and revised them where appropriate, and the following improvement activities have been added which are described in the SPP submitted February 2, 2009:

- DDD will conduct a statewide fiscal study that includes analysis of average service levels, provider rates and average cost per child;
- DDD will collaborate with professional development faculty and programs to develop a strategic plan for professional training and education opportunities;

- Direct service provider recruitment activities will be developed to address personnel shortages, including the development and distribution of a printed and web-based brochure to encourage professional and paraprofessional interest in early intervention careers;
- A statewide database of early intervention providers will be developed and maintained to identify where personnel shortage exists, what area(s) of expertise providers have, and what specialized trainings have been completed by providers;
- Materials for families about the IFSP process, with an emphasis on service delivery and new state regulations on insurance and CHP+ funding will be developed and distributed; and
- Training for direct service providers specific to supporting children with significant social/emotional concerns will be provided.

Based on the data from FFY 2007, DDD issued a finding of noncompliance to eight CCBs in December 2008, with scheduled correction as soon as possible, but no later than one year from date of notification. All eight are on target for timely correction.

DDD revised the written notification of noncompliance and Plan of Correction (POC) procedures to ensure that CCBs understood the areas of noncompliance and to ensure they successfully completed their plans of correction. The changes included more direction from DDD on incremental targets (required evidence of change) that were expected and reporting requirements were built into the POCs so that CCBs regularly provided data to DDD on the progress that they were making. A review of January 1, 2008 – March 31, 2008 data on Indicator 1 shows that the more highly focused efforts began to show their effectiveness with statewide performance in the last quarter of the fiscal year rising to 85.03%.

DDD publicly reports local program performance (including status determinations) on an annual basis by comparing each CCB with other CCBs of similar size and with state targets on compliance and performance measures. In late Spring 2008, reports for FFY 2006 were publicly released and are published on the website at www.eicolorado.org.

For those CCBs who are in year two of the status determination category of "Needs Assistance", DDD issued a menu of technical assistance activities which is posted on the website and will document which resources are utilized to help inform technical assistance efforts in the future.

Resolution of previously identified noncompliance in FFY 2006: Based on the data from FFY 2006, DDD issued a finding of noncompliance for this indicator to two CCBs [Note: a typographical error occurred in the APR submitted February 1, 2008, reporting that twelve CCBs would be issued POCs] and issued POCs with scheduled correction as soon as possible, but no later than one year from date of notification. DDD also revised the written notification of noncompliance and POC procedures to make certain that CCBs understood the areas in which there was noncompliance to ensure they successfully completed their POCs. The changes included more direction from DDD on incremental targets (required evidence of change) that were expected, and more specific reporting requirements were built into the POCs so that CCBs were regularly reporting to DDD on the progress that they were making. These more highly focused efforts resulted in verification of timely correction of noncompliance for these two CCBs.

DDD has revised the tracking procedures for correction of noncompliance for findings issued to CCBs. Notification is given to the CCB as soon as possible after noncompliance is identified. When a POC is developed, specific, state-required benchmarks are provided to the CCB. The benchmarks are entered into a tracking system and data is provided by the CCB at intervals determined by DDD and reviewed for progress toward the benchmarks. When 100% compliance is reached and verified, as soon as possible and no later than one year of the date of notification, and the ability to sustain the improvement is confirmed, DDD notifies the CCB in writing.

Revisions, with <u>Justification</u>, to Proposed Targets, Improvement Activities, Timelines, and Resources for FFY 2008, if applicable: Revisions are noted in the revised State Performance Plan (SPP) that is submitted with this APR. Changes have been made to include activities that are not directly related to improving compliance. New activities have been added to ensure more effective monitoring and general supervision based on recommendations that DDD has received from the Office of Special Education Programs (OSEP), the National Early Childhood Technical Assistance Center (NECTAC) and a private national consultant who has been assisting DDD to improve the focused monitoring procedures and timely correction of noncompliance.

Explanation of Progress or Slippage for FFY 2007: The target of 90.5% was met and exceeded. However, there was a slight slippage from 96.39% reported in FFY 2006 to 94.84% in FFY 2007.

Continued success in meeting the target for Indicator 2 is due to the extensive efforts made through monitoring, training and targeted technical assistance to improve performance throughout the state. Training and technical assistance to service coordinators and service providers emphasizes the delivery of services in natural environments and provides strategies for implementing appropriate services in the home and community settings.

Services are provided in a setting other than a natural environment only if the IFSP team provides justification in the child's IFSP. Any justification must document, at a minimum:

- a) The reason a child's outcome(s) cannot be met in a natural environment;
- b) Why the setting was chosen; and
- c) Strategies to move toward providing services in everyday routines, activities, and places (i.e., a natural environment).

In FFY 2007 as a result of an onsite data verification visit, DDD issued a finding of noncompliance to one CCB because it did not follow the related federal requirement (34 CFR 303.12(b) and 303.18) for providing services in natural environments, including the home and community settings in which children without disabilities participate. A POC was required and the program received ongoing technical assistance by DDD staff to identify the root cause for the noncompliance. While the CCB made progress, correction was not achieved within one year from the date of notification. As a result, technical assistance and reporting requirements have been intensified and correction is expected to occur within FFY 2008.

To address the slippage that occurred from FFY 2006 to FFY 2007, DDD has reviewed the improvement activities described above and revised them where appropriate, and the following improvement activities have been added which are described in the SPP submitted February 2, 2009:

- Materials will be developed and disseminated to families about the IFSP process, with an emphasis on service delivery in every day routines, activities and places; and
- Parents and service providers will be provided training at the statewide *Conference* on *Inclusive Education* on the IFSP process with an emphasis on services in natural environments (i.e., everyday routines, activities and places).

DDD publicly reports local program performance (including status determinations) on an annual basis by comparing each CCB with other CCBs of similar size and with state targets on compliance and performance measures. In late Spring 2008, reports for FFY 2006 were publicly released and are published on the website at www.eicolorado.org.

For those CCBs who are in year two of the status determination category of "Needs Assistance", DDD issued a menu of technical assistance activities which is posted on the website at www.eicolorado.org and will document which resources are utilized to help inform technical assistance efforts in the future.

Resolution of previously identified noncompliance in FFY 2006: Based on the results of a data verification visit in FFY 2006, DDD issued a finding of noncompliance to one CCB and a POC was required. This CCB was provided technical assistance by DDD staff to increase their understanding of the requirement to provide services to an infant or toddler in their natural environment. This focused technical assistance resulted in the CCB's timely correction of noncompliance.

Revisions, with Justification, to Proposed Targets, Improvement Activities, Timelines, and Resources for FFY 2008, if applicable: Revisions are noted in the revised SPP that is submitted with this APR. Changes have been made to replace activities that are not directly related to improving performance in this area. New activities have been added to ensure more effective monitoring and general supervision based on recommendations that DDD has received from OSEP, NECTAC and a private national consultant who has been assisting DDD to improve the focused monitoring procedures, timely correction of noncompliance and improved performance.

Overview of the Annual Performance Report Development: Information for Indicator 3 was provided by DDD staff, CDE, the Results Matter Work Group, the Early Childhood Outcomes (ECO) Center staff, contract staff through the University of Colorado Health Sciences Center/JFK Partners and local pilot communities.

Monitoring Priority: Early Intervention Services in Natural Environments

Indicator 3: Percent of infants and toddlers with IFSPs who demonstrate improved:

- A. Positive social-emotional skills (including social relationships);
- B. Acquisition and use of knowledge and skills (including early language/ communication); and,

Explanation of Progress or Slippage for FFY 2007:

- 4A: The target of 75% was not met, and there was slippage from 88% reported in FFY 2006 to 73% in FFY 2007.
- 4B: The target of 95.25% was not met, and there was slippage from 94% reported in FFY 2006 to 87% in FFY 2007.
- 4C: The target of 75% was met, however, there was slippage from 96% reported in FFY 2006 to 91% in FFY 2007.

The slippage seen for 4A may be attributed to the fact that 43% percent of families who returned surveys had been in the program for less than one year. Their limited time in the program may have impacted their confidence in their knowledge and understanding of rights and procedural safeguards. In Spring 2008, regional trainings were provided to service coordinators across the state on child and family rights and procedural safeguards. Because the FFY 2007 Family Outcomes Survey was sent to families shortly after the trainings, the knowledge that the service coordinators gained on how to explain rights and procedural safeguards to families did not influence the responses for this round of surveys. The results of these trainings are expected to impact the results of the FFY 2008 Family Outcomes Survey.

The baseline and targets set for 4B in the SPP submitted in February 2008 were based on a single year's data reported for FFY 2006 and may have been an unrealistic target. The overall return rate of surveys could not be determined because the surveys were completed partially using the online version and paper copies were distributed by local programs without careful documentation of the number sent to families. The returned surveys may not have been representative of the demographic characteristics of families receiving services. The minimal data available impeded the ability to accurately determine this baseline and targets. The baseline and targets for this outcome have been reviewed and revised by the Results Matter Workgroup based on more comprehensive data and stakeholder input and are included in the SPP submitted February 2, 2009.

In an effort to increase our return rate, a letter from a parent on the CICC and a paper copy of the survey were sent to families on April 1, 2008 announcing the availability of an on-line survey as well as an option to complete and return the paper survey. Each CCB was asked to have service coordinators and service providers inform families that they would be receiving the survey and to encourage the family to complete it. In addition, documents explaining the survey and requesting support were sent to community and EI partners statewide so that they would be informed of the process and could provide support to families.

The representativeness of the Family Outcomes Surveys returned was assessed by examining the demographic characteristics of the children of the parents who responded to the survey to the demographic characteristics of all children receiving early intervention services. This comparison indicates the results are representative by gender and age of the child. For example, 36% of the parents who returned a survey indicated that their child was female compared to 39% of children reported in the 618 Child Count (reported annually to OSEP) as female; 56% of parents who returned a survey indicated that their child was male and 61% of children were reported in the 618 Child Count data as being male.

The percentage of surveys received from minority populations was lower than the percentage of minority families served by the system as reflected in Colorado's 618 data.

DDD will continue to refine the data collection process to ensure the representativeness of the data reported.

To address the slippage that occurred in FFY 2007, DDD has reviewed the improvement activities described above and revised them where appropriate, and the following improvement activities have been added which are described in the SPP submitted February 2, 2009:

- Strategies and procedures used in other states to implement The Family Outcomes Survey will be reviewed to determine if they may be applicable in Colorado to improve return rates, demographic representation and overall outcomes;

Colorado remains below the national average and the average of other states that have what is considered a moderate eligibility definition (i.e., New York, Rhode Island, Indiana, Illinois, Delaware, South Dakota, Puerto Rico, New Jersey, Kentucky, Alaska, Minnesota, Missouri, Louisiana, Guam, and North Carolina).

DDD engaged in numerous activities to address the need to increase the identification rate of infants, birth to one year. The *Implementing Part C Provisions Required under CAPTA and IDEA* trainings were in Durango, Fort Collins, Pueblo and two trainings in the Denver Metro area. On June 17, 2008, Colorado participated in the McKinney Vento and IDEA Administration Collaboration, a one day web-based policy

forum co-hosted by the National Center for Homeless Education (NCHE) and Project Forum at the National Association of State Directors of Special Education (NASDSE).

The following family materials were developed in Spanish and English:

- A Family Overview: Colorado's Early Intervention System at a Glance;
- A Family Guide: Referral and Eligibility for Colorado's Early Intervention Services;
- A Family Guide: Funding Early Intervention Services; and
- Family panel cards (to be given to families by health care professionals as a referral tool when a child scores below the cutoff on a standardized developmental screening instrument).

A Referral Status Update Form was developed to reinforce the link between referral sources and the local early intervention programs within the 20 CCBs statewide. The form was developed based on research findings from the Tracking, Referral and Assessment Center for Excellence (TRACE). The form includes: 1) eligibility determination, including receipt of a referral, status of scheduling an evaluation, and an indication that the child was or was not eligible for services, 2) evaluation results, including assessment results and findings, assessment reports, and diagnostic results, 3) intervention, including information about available services, treatment options, and IFSP, 4) progress reports, including information on child progress, feedback on type and frequency of service provision, and changes in service provision, and 5) physician involvement, including coordination of child services, joint follow-up communication, and face-to face visits by the practitioner in the physician's office. DDD requires CCBs to use this form to notify the referral source of a child's status.

Ongoing work continues to increase the use of standardized developmental screening as a routine part of a well child visit within a pediatric health care practice to promote early identification and referral of infants and toddlers in Colorado.

The NICU Project collaboration with hospital staff, along with programs such as March of Dimes and Bright Beginnings is ongoing. These collaborative efforts address many issues such as family education in developmentally supportive care, family involvement within the NICU setting, and best practices for transition home upon discharge.

DDD has reviewed the improvement activities described above and revised them where appropriate, and the following improvement activities have been added which are described in the SPP submitted February 2, 2009:

- DDD will implement revised procedures for focused monitoring that effectively identify root causes of barriers for those CCBs that are low performing on this indicator;
- DDD will monitor all 20 CCBs for compliance on related requirements for Indicator 5, using a combination of data review, self-assessment and onsite data verification, issue written notifications of noncompliance, and require POCs when noncompliance is identified; and

Explanation of Progress or Slippage for FFY 2007: The target of 2.2% was not met and the identification rate remained the same as the 1.92% reported in FFY 2006.

DDD engaged in numerous activities to address the need to increase the identification rate of infants and toddlers birth to three. The *Implementing Part C Provisions Required under CAPTA and IDEA* trainings were held in Durango, Fort Collins, Pueblo and the Denver Metro area. On June 17, 2008, Colorado participated in the *McKinney Vento and IDEA Administration Collaboration*, a one day web-based policy forum co-hosted by NCHE and NASDSE.

The following family materials were developed in Spanish and English:

- A Family Overview: Colorado's Early Intervention System at a Glance;
- A Family Guide: Referral and Eligibility for Colorado's Early Intervention Services;
- A Family Guide: Funding Early Intervention Services; and
- Family panel cards (to be given to families by health care professionals as a referral tool when a child scores below the cutoff on a standardized developmental screening instrument).

A Referral Status Update Form was developed to reinforce the link between referral sources and the local early intervention programs within the 20 CCBs statewide. The form was developed based on research finding from TRACE Center. The form includes: 1) eligibility determination, including receipt of a referral, status of scheduling an evaluation, and an indication that the child was or was not eligible for services, 2) evaluation results, including assessment results and findings, assessment reports, and diagnostic results, 3) intervention, including information about available services, treatment options, and IFSP, 4) progress reports, including information on child progress, feedback on type and frequency of service provision, and changes in service provision, and 5) physician involvement, including coordination of child services, joint follow-up communication, and face-to face visits by the practitioner in the physician's office. DDD requires CCBs to use this form to notify the referral source of a child's status.

Ongoing work continues to increase the use of standardized developmental screening as a routine part of a well-child visit within a pediatric health care practice to promote early identification and referral of infants and toddlers in Colorado.

DDD has reviewed the improvement activities described above and revised them where appropriate, and the following improvement activities have been added which are described in the SPP submitted February 2, 2009:

- DDD will implement revised procedures for focused monitoring that effectively identify root causes of barriers to providing expected child identification;

Revisions, with Justification, to Proposed Targets, Improvement Activities, Timelines, and Resources for FFY 2008, if applicable: Revisions are noted in the revised SPP that is submitted with this APR. Changes have been made to eliminate activities that are not directly related to improving performance and compliance. New activities have been added to ensure more effective monitoring and general supervision based on recommendations that DDD has received from OSEP, NECTAC, TRACE and a private national consultant who has been assisting DDD to improve the identification rate, the focused monitoring procedures, timely correction of noncompliance and performance.

Explanation of Progress or Slippage for FFY 2007: The target of 100% was not met and the performance remained consistent, making slight progress, from 90% in FFY 2006 to 90.59% in FFY 2007.

After the passage of state legislation that defined responsibilities for birth to three Child Find, a joint memorandum was developed by DDD and CDE and distributed to the CCBs and AUs. A conference call was conducted in April 2008 by DDD and CDE staff to address federal and state requirements for CCB and AU staff. The call specifically addressed roles and responsibilities during the screening, evaluation, and initial IFSP process and the development of an interagency operating agreement to define local procedures. The call also provided guidelines for CAPTA requirements and referrals that come from a NICU setting. The call and related materials, including a joint directive, crosswalk and frequently asked questions documents, were distributed statewide and have been posted to the EI Colorado website as a resource for local programs.

DDD revised the written notification of noncompliance and POC procedures to ensure that CCBs understood the areas of noncompliance and to ensure they successfully completed their POCs. The changes included more direction from DDD on incremental targets (required evidence of change) that were expected and reporting requirements were built into the POC so that CCBs regularly provided data to DDD on the progress that they were making. A review of April 1, 2008 – June 30, 2008 data on Indicator 7 shows that the more highly focused efforts began to show their effectiveness on statewide performance in the last quarter of the fiscal year rising to 93.21%.

To address the 9.4% of noncompliance that occurred in FFY 2007 for Indicator 7, DDD has reviewed the improvement activities described above and revised them where appropriate, and the following improvement activities have been added which are described in the SPP submitted February 2, 2009:

- DDD will develop a process for funding CCBs to reimburse private providers for team consultation and attendance at IFSP meetings;

Based on the data from FFY 2007, DDD issued a finding of noncompliance to eight CCBs in December 2008, with scheduled correction as soon as possible, but no later than one year from date of notification. Three CCBs have already corrected and five are on target for timely correction no later than one year from the date of notification.

DDD has revised the tracking procedures for correction of noncompliance for findings issued to CCBs. Notification is given to the CCB as soon as possible after noncompliance is identified. When a POC is developed, specific, state-required benchmarks are provided to the CCB. The benchmarks are entered into a tracking system and data is provided by the CCB at intervals determined by DDD and reviewed for progress toward the benchmarks. When 100% compliance is reached and verified, as soon as possible and no later than one year of the date of notification, and the ability to sustain the improvement is confirmed, DDD notifies the CCB in writing.

Resolution of previously identified noncompliance in FFY 2006: Based on the data from FFY 2006, DDD issued a finding of noncompliance to nine CCBs for Indicator 7 and two CCBs for Indicator 7 related requirement at 34 CFR 303.23 (a) provision of service coordination activities. DDD issued POCs with scheduled correction as soon as possible, but no later than one year from date of notification. DDD also revised the written notification of noncompliance and POC procedures to make certain that CCBs understood the areas of noncompliance to ensure they successfully completed their POC. The changes included more direction from DDD on incremental targets (required evidence of change) that were expected, and more specific reporting requirements were built into the POC so that CCBs were regularly reporting to DDD on the progress that they were making. These more focused efforts resulted in eight of the CCBs' correction of noncompliance. Of these findings:

Indicator 7 - Six CCBs corrected within one year; one CCB corrected within 14 months; one CCB corrected within 15 months; and one CCB is making progress but has not yet corrected.

Related requirement – Both CCBs corrected within one year.

One CCB had one finding that was not corrected in a timely manner. As a result, DDD implemented multiple enforcement activities with the CCB that included the following:

- An onsite file review was conducted midway during the original one-year POC period.
 While progress was being made it was not substantial enough to confirm correction.
 The POC was amended with additional data reporting requirements.
- Multiple technical assistance visits were made to the CCB for staff training.
- The status determination for this CCB dropped from "Needs Assistance" to "Needs Intervention".
- Multiple technical assistance calls were conducted regarding data collection and issues related to the validity of the data being reported to DDD through the POC process.

- A focused monitoring onsite visit was conducted in October 2008 to identify the root causes that were preventing the CCB from correcting noncompliance.
- The POC was amended with specific requirements by DDD to construct policies and procedures around Indicator 7 and any related requirements.
- An additional requirement to address the policies and procedures around data collection and the use of data in the general supervision of the early intervention program was added to the POC.
- The CCB has been required to collaborate with a lead State staff person who has been assigned to the CCB for regular contact and technical assistance until correction of noncompliance is achieved.

Ongoing Activity. In FFY 2007, 18 CCBs completed their Interagency Agreements. Two remaining local programs are still working with their AUs for final approval.

8.13 2005-2010 A parent training module on IFSP process, including transition, will be developed and implemented statewide through regional training/ DDD staff, Training Cadre, and PEAK Parent Center mentors.

Ongoing Activity - Timeline revised in Improvement Activity 8.13, SPP submitted February 2, 2009. In FFY 2007, 11 parent trainings occurred in various service areas of the state using the *Inspiring Futures* curriculum with 155 participants in total. Five trainings occurred in the Denver Metro area and the other training locations included. Alamosa, Canon City, Colorado Springs, Edwards, Evans, and Mancos. Two parents conducted these trainings using a peer-to-peer model. While all of the trainings had translation, five trainings were conducted entirely in Spanish for bilingual and monolingual Spanish speaking families.

Explanation of Progress or Slippage for FFY 2007: The following progress was made:

- 8A: The target of 100% was not met, however, progress was made from 96.55% reported in FFY 2006 to 99.09% in FFY 2007.
- 8B: The target of 100% was not met, however, progress was made from 97.9% reported in FFY 2006 to 98.22% in FFY 2007.
- 8C: The target of 100% was not met, however, progress was made from 83.06% in FFY 2006 to 84.74% in FFY 2007.

Indicator 8C, the percentage of children exiting from early intervention services who have a transition conference at least 90 days prior to their third birthday, was a major focus of targeted technical assistance and statewide training during FFY 2007. Much confusion still remained at the local level regarding the LEA's role during the transition process; therefore, local programs were still delaying transition conferences until which time eligibility for Part B could be determined.

A statewide technical assistance call was held in May 2008 jointly by DDD and CDE for both early intervention staff and Child Find staff to further clarify the responsibilities of both parties during the transition process. Emphasis was made to local early intervention programs that the LEA must be involved in the transition process, and the transition conference must have occurred by the time the child turns 2 years, 9 months, regardless of Part B eligibility determination or the ability of the LEA to attend the conference in person. This joint effort between DDD and CDE is expected to have a positive impact on state performance in FFY 2008.

DDD revised the written notification of noncompliance and POC procedures to ensure that CCBs understood the areas in which they showed noncompliance and to ensure they successfully completed their POCs. The changes included more direction from DDD on incremental targets (required evidence of change) that were expected and reporting requirements were built into the POCs so that CCBs regularly provided data to DDD on the progress that they were making. A review of April 1-June 30, 2008 data on Indicator 8C showed that these more highly focused efforts began to show their effectiveness with statewide performance in the last quarter of the fiscal year rising to 87.14%.

To address the 15% of noncompliance that occurred in FFY 2007 for Indicator 8C, DDD has reviewed the improvement activities described above and revised them where appropriate, and the following improvement activities have been added which are described in the SPP submitted February 2, 2009:

- The transition module within the state IFSP training will be revised to provide more detail on required timelines for transition and the content of transition plans. This training will be provided to early intervention service coordinators, early interventionists and community partners throughout the state;
- A workshop on Part C to B transition for parents and early interventionists will be provided at the Conference on Inclusive Education;

- DDD will implement revised procedures for focused monitoring that effectively identify root causes of barriers for those CCBs that are low performing on this indicator:
- DDD will revise the state IFSP transition section to provide guidance to IFSP team members on required content for transition steps and services; and
- DDD will monitor all 20 CCBs for compliance on Indicators 8A, 8B and 8C, using a combination of data review, self-assessment and onsite data verification visits, issue written notifications of noncompliance, and require POCs when noncompliance is identified.

Based on the data from FFY 2007, DDD issued a finding of noncompliance to one CCB in December 2008 for Indicator 8B, with scheduled correction as soon as possible, but no later than one year from date of notification. This CCB is on target for timely correction.

Based on the data from FFY 2007, DDD issued a finding of noncompliance to seven CCBs in December 2008 for Indicator 8C, with scheduled correction as soon as possible, but no later than one year from date of notification. All are on target for timely correction.

DDD revised the tracking procedures for correction of noncompliance for findings issued to CCBs. Notification is given to the CCB as soon as possible after noncompliance is identified. When a POC is developed, specific, state-required benchmarks are provided to the CCB. The benchmarks are entered into a tracking system and data is provided by the CCB at intervals determined by DDD and reviewed for progress toward the benchmarks. When 100% compliance is reached and verified, as soon as possible and no later than one year of the date of notification, and the ability to sustain the improvement is confirmed, DDD notifies the CCB in writing.

DDD publicly reports local program performance (including status determinations) on an annual basis by comparing each CCB with other CCBs of similar size and with state targets on compliance and performance measures. In late Spring 2008, reports for FFY 2006 were publicly released and are published on the website at www.eicolorado.org.

For those CCBs who are in year two of the status determination category of "Needs Assistance", DDD issued a menu of technical assistance activities which is posted on the website at www.eicolorado.org and will document which resources are utilized to help inform technical assistance efforts in the future.

Resolution of previously identified noncompliance in FFY 2006: Based on the data from FFY 2006, DDD issued a finding of noncompliance to two CCBs for measure 8A, one CCB for measure 8B and eight CCBs for measure 8C. DDD issued POCs with scheduled correction as soon as possible, but no later than one year from date of notification. DDD also revised the written notification of noncompliance and POC procedures to make certain that CCBs understood the areas of noncompliance to ensure they successfully completed their corrective action plans. The changes included more direction from DDD on incremental targets (required evidence of change) that were expected, and more specific reporting requirements were built into the POCs so that CCBs were regularly reporting to DDD on the progress that they were making. These more focused efforts resulted in one CCB correcting measure 8A, both CCBs' correction of 8B and seven CCBs correction of measure 8C. Of these findings:

- 8A One CCB corrected within one year and one is making progress but has not yet corrected;
- 8B The CCB cited for this measure corrected within one year; and
- 8C Five CCBs corrected within one year; one CCB corrected within 14 months; one CCB corrected within 15 months; and one CCB is making progress but has not yet corrected.

One CCB had two findings, in 8A and 8C, which were not corrected in a timely manner. As a result, DDD implemented multiple enforcement activities with the CCB that included the following:

An onsite file review was conducted midway during the original one-year POC period.
 While progress was being made it was not substantial enough to confirm correction.
 The POC was amended with additional data reporting requirements.

- Multiple technical assistance visits were made to the CCB for staff training.
- The status determination for this CCB dropped from "Needs Assistance" to "Needs Intervention".
- Multiple technical assistance calls were conducted regarding data collection and issues related to the validity of the data being reported to DDD through the POC process.
- A focused monitoring onsite visit was conducted in October 2008 to identify the root causes that were preventing the CCB from correcting noncompliance.
- The POC was amended with specific requirements by DDD to construct policies and procedures around Indicator 8A, B and C and any related requirements.
- An additional requirement to address the policies and procedures around data collection and the use of data in the general supervision of the early intervention program was added to the POC.
- The CCB has been required to collaborate with a lead State staff person who has been assigned to the CCB for regular contact and technical assistance until correction of noncompliance is achieved.

Revisions, with Justification, to Proposed Targets, Improvement Activities, Timelines, and Resources for FFY 2008, if applicable: Revisions are noted in the revised SPP that is submitted with this APR. Changes have been made to eliminate activities that are not directly related to improving compliance. New activities have been added to address interagency collaboration and to ensure more effective monitoring and general supervision based on recommendations that DDD has received from OSEP, NECTAC, and a private national consultant who has been assisting DDD to improve the focused monitoring procedures and timely correction of noncompliance.

Explanation of Progress or Slippage for Timely Correction of Noncompliance Identified in FFY 2007: The target of 100% was not met and the 73.1% achieved in FFY 2007 shows slippage from the 100% reported in FFY 2006. There are a number of factors important to note.

Discussion of Correction of FFY 2006 Findings:

For the two CCBs who corrected, but not within one year, one corrected two findings within 14 months and one corrected two findings within 15 months. The three findings identified during FFY 2006 that were not corrected were attributed to one CCB. Additional enforcement activities implemented for that CCB are detailed under the Indicator 7, 8A and 8C sections. Additionally, the POC for this CCB has been amended, with the date the findings were issued maintained, and procedures as described below have been implemented immediately.

Discussion of Correction of FFY 2005 Findings:

The corrected findings that were reported in the APR submitted February 1, 2008 were based on noncompliance identified in FFY 2005 by the former lead agency, CDE. On July 1, 2006, DDD took over as the lead agency for Part C in Colorado. Prior to that time, there had been 32 individual Part C programs with responsibility for implementing federal Part C requirements. After the lead agency changed, only two of those programs remained. Those two programs timely corrected the noncompliance identified in FFY 2005 and the 100% that was reported in the FFY 2006 APR submitted February 1, 2008 was the result of the correction of those two programs.

On July 1, 2006, DDD took over lead agency for Part C and began numerous major activities related to the development, implementation and general supervision of the new early intervention programs within the already existing 20 CCBs. This resulted in programs implementing Part C requirements for the first time. DDD early intervention staff had the responsibility for training all programs on Part C requirements, data collection and the creation of local interagency coordinating councils. DDD immediately implemented general supervision activities and began onsite visits to monitor the implementation of requirements. Ten

of the 20 CCBs were visited within this first year (FFY 2006). Not surprisingly, many of these programs had noncompliance during the onsite visit and POCs were issued. When the FFY 2006 data was examined for reporting in the FFY 2006 APR, additional POCs were issued for the remaining programs whose data were not showing 100% compliance in August 2006. In FFY 2006 eight CCBs had POCs including 26 findings.

During FFY 2007, the remaining CCBs were visited to monitor the effectiveness of the implementation of Part C requirements and monitor the validity and reliability of data. Noncompliance that was not identified during prior data review was cited and POCs were amended to include any new findings. During FFY 2007 there were 18 POCs being implemented, including 43 findings.

In FFY 2006 and FFY 2007, DDD had six full time staff with the assignment of managing the early intervention program in Colorado, including state and federal requirements:

- A Program Coordinator responsible for managing the program (Part C Coordinator) including state and federal requirements, contract management and staff supervision;
- A Training Coordinator responsible for all required training across the state;
- A Community Coordinator responsible for providing technical assistance to all 20 CCBs across the state as well as supporting the LICCs, service providers. interagency partners and ensuring implementation of the outcomes data system. known as Results Matter:
- A Program Quality and Data Coordinator assigned the duties of program monitoring and data coordination and analysis;
- A Public Awareness Coordinator responsible for all public awareness and child find activities: and
- An Administrative Assistant responsible for supporting all of the other staff, as well as tracking the budget and coordinating events.

During FFY 2006 and FFY 2007, the following critical activities occurred which required valuable time and resources of the staff:

- Legislation was passed defining the responsibilities of DDD and CDE during the Child Find process and new state funding was secured to pay the costs for Child Find activities:
- The DDD early intervention website was created and launched;
- The statewide database previously managed through an Access database was migrated and converted to the DDD web-based database format (CCMSweb):
- Multiple trainings were conducted to train staff on data collection in the new system and one-on-one technical assistance was provided to any person who requested it;
- Numerous trainings were conducted across the state to ensure that all staff (service coordinators, early intervention directors) in the state completed the required Service Coordination Core Competencies and IFSP trainings;
- All materials available for distribution to families, service providers and interagency partners were changed to reflect the new lead agency information;
- A general supervision process was created and 20 onsite visits were conducted to monitor the implementation of federal requirements across the state;
- A Coordinated System of Payment legislation was enacted to require qualified insurance plans in Colorado to pay for early intervention services, training was provided across the state to instruct local programs on how to bill the insurance companies, the database was modified to allow for billing, and a person in the DDD

Part C SPP/APR 44 accounting office was recruited and trained to manage the payments to insurance companies.

Because of the enormous amount of activities and responsibilities taken on by a small staff implementing a new program, it became very clear that additional resources had to be utilized and reassignment of staff had to occur to ensure timely correction of noncompliance. After reviewing progress of programs towards timely correction, DDD staff realized that in order for CCBs to successfully correct noncompliance, additional guidance would need to be provided. The POC template was adjusted to include additional requirements for CCBs to submit data to DDD and a DDD staff person was assigned to be a lead to every CCB who had a determination of "Needs Intervention". Specific data was required based on the noncompliance identified and incremental benchmarks were prescribed. This led to the successful correction of noncompliance in a timely manner by many of the CCBs.

Three programs did not correct within one year, and DDD reviewed the process for identifying, tracking and providing additional technical assistance as needed for CCBs with open POCs. It was determined that in order to assure timely correction by local programs, two things needed to happen:

- Specific benchmarks needed to be outlined in POCs and a mechanism for tracking these benchmarks had to be put in place; and
- Technical assistance needed to be provided to any CCB with an open POC, in addition to those with a "Needs Intervention" status.

As a result, in FFY 2008 DDD has realigned staff responsibilities and revised the tracking procedures for POCs that are issued to CCBs. Notification is given to the CCBs as soon as possible after noncompliance is identified by the Program Quality Coordinator. A POC is developed and specific, individualized, state-required benchmarks are provided to the CCB. Notification of noncompliance and a draft of the POC is sent and the CCB adds the specific activities they will engage in that will ensure the program achieves compliance. The completed POC is reviewed by DDD to determine whether activities proposed by the CCB will have the impact desired for making progress toward achieving compliance before final approval is given.

DDD adjusted the responsibilities of the Public Awareness Coordinator to include the role of Plan of Correction Coordinator. The Plan of Correction Coordinator enters the benchmarks dictated by DDD into an online tracking system and data is provided by the CCB each month and reviewed for progress toward the benchmarks. Through the online tracking system, an automated reminder is sent to the Plan of Correction Coordinator if the data is not entered into the data tracking system. This system ensures that every CCB who has an open POC will be tracked throughout the process until correction is achieved. When 100% compliance is reached, as soon as possible and no later than one year of the date of notification, and the ability to sustain the improvement is confirmed, DDD notifies the CCB of their release from the POC and issues a letter of release shortly thereafter.

Additionally, DDD has ramped up the technical assistance activities provided to CCBs with open POCs. When a CCB is determined to be out of compliance in one or more areas, a notification and POC is issued to the CCB and a DDD staff person is assigned as the lead technical assistance contact to the CCB until correction is achieved. The technical assistance activities and staff person assigned are individualized to the needs of the CCB. The level of staff intervention for CCBs will be determined based on the scope of work that is necessary to ensure timely correction.

The Plan of Correction Coordinator collects the data required of the CCB through the POC process and notifies the lead DDD staff person on whether the CCB is making progress toward the benchmarks that are prescribed. If progress is not being made, additional technical assistance activities are implemented and contact is increased until the CCB reaches compliance. Benchmarks are set to achieve compliance within six months. If compliance has not been achieved within six months, technical assistance activities are accelerated so that correction can be confirmed prior to the timely correction timeline.

DDD has reviewed the improvement activities described above and revised them where appropriate, and the following improvement activities have been added which are described in the SPP submitted February 2, 2009:
