Report from the Chair



At its annual meeting in July, 2015, the Colorado Commission on Aging (CCOA) approved the Colorado Aging Framework, finalizing a project that we had been working on for many months in partnership with the Colorado Department

of Human Services. It also began CCOA's relationship with the Strategic Action Planning Group on Aging (SAPGA), which was formed by legislation in 2015 that called for a group to develop a strategic plan for aging for the State of Colorado. CCOA member Ben Moultrie represented the Commission on the SAPGA, and Mindy Kemp, CCOA Director, served on the committee as well; both kept Commission members informed regarding the progress of the Planning Group throughout the year. The Aging Framework was used by SAPGA as one of the many source documents it relied on for background information.

The CCOA set goals of its own for the year (see Strategic Planning report) that included reviewing behavioral health programs for older adults in Colorado, and consequently, many excellent presentations came before us throughout the year, informing us about the behavioral health needs of seniors as well as the services provided in our state. While it was clear that this is an issue of huge concern, the Commission did not to make recommendations for improvement at this time. We continued to develop our own written procedures and updated our bylaws during the year as well.

During the 2015-2016 year, the following members completed their terms: Alice Langley, CD-1, 2008-2016; Judy Hensley, CD-4, 2012-2016; and

Dar Vriesman, CD-7, 2012-2016. We are grateful to each of them for sharing their wisdom, energy and insights during their tenures. Joining us during this year were Debra Herrera, CD-3, Ignacio; Debra Bailey, CD-3, Grand Junction; Julie Cozad, CD-4, Milliken; Steve Grund, CD-6, Littleton; and Representative Jessie Danielson, Colorado House of Representatives. We have appreciated their new perspectives and ideas.

I would like to thank the Chairs of our committees during this past year: Joe Urban, Vice Chair of the Commission and Chair of the Strategic Planning Committee; Judy Hensley and Jody Barker, Cochairs of the Community Relations Committee; and Christina Johnson, Chair of the Public Policy Committee. The committees really do much of the work of the Commission, especially the Community Relations Committee which puts on the wonderful events of which we are so proud. The Executive Committee was made up of Ruth Long, Chair; Joe Urban, Vice-Chair; Christina Johnson, Public Policy Chair. Liaisons to other groups included: Ben Moultrie, SAPGA; Joe Urban, Aging Policy Advisory Committee (APAC); Paulette St. James, Assisted Living Residence Committee (ALRC); and Christina Johnson, Health Care Policy and Financing Advisory Group (HCPFAG).

Finally, we are very grateful for the staff support we receive from Mindy Kemp, Director of Aging and Adult Services and Tara Franck, Office Manager.

Strategic Action Planning Group on Aging (SAPGA) Report

House Bill 15-1033 created the Strategic Action Planning Group on Aging in Colorado. The Planning Group is charged with examining the impact of the aging demographic shift on the economy, workforce, businesses, market based products and services; state and local revenue budgets and fiscal policies; Medicaid and other safety-net programs and the collateral impact on other non-related state programs; family caregiving and public and private options for long-term care, services and support;

federal entitlement reforms; and transportation services and infrastructure. Ben Moultrie of the CCOA and Mindy Kemp, Director, Division of Aging and Adult Services, are both members of the 23 member Planning Group. The Planning Group met bi-monthly starting in August 2015. The Strategic Action Planning Group on Aging is required to provide a report to the General Assembly by November 30, 2016.

Public Policy Committee

For the 2016 Colorado Legislative session, the Public Policy Committee reviewed 28 House and 13 Senate bills at the Colorado State Legislature that had a reference to issues around aging. The committee members were Chair Christina Johnson, Ruth Long, Ben Moultrie, Debra Bailey and Steve Grund. The committee reviewed all of the bills and recommended that the full Commission support the following:

 HB1027—by Representative Danielson—a bill allowing victims of abuse to give their statements by remote means The CCOA ultimately decided not to pursue supporting these bills in a formal way:

- HB1097—Regarding permits on Medicaid Transportation Providers
- HB1277—extended the time frame for appeals on Medicaid benefits
- SB27—allowed for Medicaid options for prescription drugs by mail
- SB147—Creating Colorado suicide prevention plan.

Strategic Planning Committee

The Strategic Planning Committee in 2015/2016 concentrated their efforts primarily on short term goals that would support the work of the Commission and the State Unit on Aging. Most goals were accomplished during the fiscal year including: initiation of a process to develop a CCOA policy book, initiation of a communications liaison for the Commission and active participation by Commission members in the state strategic planning process.

The target areas identified for the Commission to focus their efforts in 2016/2017 include: affordable housing for seniors, support for the Colorado communities engaged in Age Friendly initiatives and caregiver respite programs. Much of the work for 2016/2017 anticipates supporting the completion of the report from the Strategic Action Planning Group on Aging, and how the Commission on Aging might support the goals that come out of that process.
