COLORADO STATS - Abandon Infants aka Safe Haven

Updated draft 3/2009

**CONCERNING CERTAIN ABANDONED CHILDREN- Senate Bill 00-171 & HB03-1095
BECAME LAW June 3, 2000 EFFECTIVE June 3, 2000 and March 23/2003
(AKA- Safe Haven Act)**

Pursuant to Senate Bill 00-171 (C.R.S § 19-3-304.5 (6)) Concerning Certain Abandoned Children, the State Department of Human Services is required to submit an annual report to the General Assembly compiling monthly reports by counties of the number of children abandoned under this statute.

PROVISION OF ACT

Added amendments to Colorado Revised Statutes (CRS) in following areas:

1. C.R.S § 18-6-401 (9) - Child abuse
2. C.R.S § 19-3-304.5 - Emergency possession of certain abandoned children

A child falls under the provisions of the Act if:

1. Child is 72 hours old or younger
2. Parent(s) did not express an intent to return for the child
3. Child is abandoned at:
 - a. A fire station, or
 - b. Hospital
