2011 CHILD SUPPORT HIGHLIGHTS

Mission

The Mission of the Child Support Enforcement Program is to assure that parents support their children. This is accomplished by locating each parent, establishing paternity, establishing support obligations, and enforcing those obligations.

Vision

Children can count on their parents for the financial, medical, and emotional support they need to be healthy and successful.



- The Colorado Child Support Enforcement Program (Program) received the 2011 Excellence Award , Outstanding Program, from the Western Interstate Child Support Enforcement Council.
- The current automated child support system is 25 years old. In 2011, work began on moving the system to a more modern platform in preparation for future enhancements.
- The Program continued with a federal grant to explore ways to help military families and another one to assist obligors with saving money in Individual Development Accounts that are matched at a four to one rate that can be used for education, business ownership or home ownership.
- An online application was made available for anyone wanting to apply for child support services.
- Custodial parents can now automatically receive an email message when a child support payment is disbursed to them from the Family Support Registry.
- Through out 2011, the Division worked with two vendors to provide medical support services on child support cases. The vendors were successful at identifying 22,049 children with private health insurance as a result of an ongoing data match, working with employers to enroll children in employer sponsored health insurance on 1,033 child support cases where a National Medical Support Notice had been sent to the employer of the obligors, and providing medical support facilitator services on 40,000 cases that resulted in 7% more families receiving medical insurance benefits.
- The Division of Child Support Enforcement, in collaboration with the Responsible Fatherhood Project, developed two videos that showcase fathers sharing, in their own words, their experiences with child support. Interspersed with information provided by child support workers, the videos have resonated with fathers in ways that more traditional "talking head" videos have not.
- The Division of Child Support Enforcement trained 90 parole officers and 227 probation officers on the use of the Child Support Website to enhance communication between agencies.

Over \$301 million dollars was paid to families in child support in 2011. This is an increase of over \$8 million dollars over 2010.

The caseload increased by almost 6,000, giving the Program the opportunity to serve more families in 2011.

For every dollar the Program spends, it collects \$4.49 in return. The Federal Office of Budget and Management considers Child Support Enforcement to be one of the best performing social services programs.


